

Coming next Tuesday, May 14th Author Dan Lawton and his Book, Above the Ground, A True Story of The Troubles in Northern Ireland including details of an IRA fugitive hiding in plain sight in San Diego for decades.



DAN LAWTON is a writer and practicing lawyer. He was born in Los Angeles and raised in Fullerton, California, along with his three younger brothers. He earned his undergraduate degree at the University of Notre Dame and his law degree at Georgetown University Law Center in 1986. After graduation, he served as a law clerk to Ninth Circuit Judge Thomas Tang in Phoenix, Arizona. Following his clerkship, He moved San Diego, and practiced law full-time, starting at a Luce Forward Hamilton Scripps before opening his own private practice in 1995. There he trained several young lawyers, all of whom had been my law students at Thomas Jefferson School of Law, where he has taught appellate advocacy on and off since 2001.

Throughout his career **Dan Lawton** has taken on pro bono¹ cases. One of those cases was a case concerning the extradition of a member of the IRA **Kevin Barry Hartt**, who was convicted of the 1978 murder of a British guard in Northern Ireland, had escaped from prison and found his way to San Diego.

A colleague told Dan of Kevin, who in 1992 had been arrested by the FBI and was in custody at MCC², facing extradition by the British Government. After listening to his story, Dan took on his representation for 8 years. By 1995, he came to believe his client was innocent.

Eventually Dan realized the complexities of the case and the massive battles with the British Government and the United States Attorney's Office, would require more than he could provide; a big-time trial attorney (Jim Brosnahan) and a large and well financed law firm, (Morrison Forrester), With the agreement of all the parties, Dan withdrew as counsel, remaining however, very close friends with Kevin throughout the litigation and his eventual exoneration in 2020.

Dan Lawton's book, *Above the Ground*, is about "the Troubles" and the struggle to prove Kevin Barry Harrt's innocence. It came out in 2023 to accolades from best-selling authors, historians, correspondents, and editors praising Dan's recounting of the trials and redemption of Kevin Barry Hartt. Today it is the # 1 in best-selling Irish historical nonfiction on Amazon.

We look forward to hearing more of this fascinating story from him.

¹ The term "pro bono," which is short for pro bono publico, is a Latin term that means "for the public good." In law it refers to legal services that are provided without expectation of compensation for the indigent.

² The Metropolitan Correctional Center, **San Diego** is a United States federal administrative detention facility designed to hold both male and female federal prisoners.

Our Speaker from Last Week

Diane Kane, PhD





Dr. Kane, a former senior planner from the city of San Diego, where she coordinated large scale historical surveys, gave us a thorough understanding of how historical preservation provisions do not slow down permitting time and reduce the availability of affordable housing.

She said San Diego's two-year permitting is a lengthy & expensive process.

resulting in an expensive and insufficient housing supply. Only a tiny part of the expense and time can be attributed to historical preservation review.

She described in some detail that the city is way behind in the development of housing and one thing they should consider is adaptive reuse of older buildings.

She mentioned and showed maps of some large neighborhoods in the city that have sought a federal historical designation, so they become exempt from the added density allowances of controversial SB 9. They're doing this so that their neighbors will not be able to add an ADU (Accessory Dwelling Unit) to their lot or developers tear down a single family home and replace it with a multi-unit building.

She also lamented the loss of NOAH (Naturally Occurring Affordable Housing. Bungalow developments and other older buildings torn down and replaced with market rate housing with only 20% affordable.
