


**Orin Gabsch** led us in the Pledge of Allegiance and offered the following words of inspiration.

On an analogous issue, she is looking for a van or possibly 2 that can hold 11 or 12 people to pick up the band and their



# **Our Speaker from Last Week**



Dan Lawton on his book, *Above the Ground,* a *true story of "the Troubles" in Northern Ireland.* 

On the face of it, this book concerns a young Belfast Irish Catholic taxicab driver, **Kevin Barry Artt**, who in 1982, was falsely accused and arrested for killing a British prison administrator, beaten over 5 days into confessing to the murder, convicted, imprisoned for life, and then almost miraculously escaped along with 38 members of the IRA from "the Maze" a massive Northern Ireland prison. With the help of others and using fraudulent documents, he would eventually find his way to California, only to be found by the FBI, arrested on a murder warrant from Belfast, and over a period of nearly 20 years eventually be exonerated and found innocent.

Underlying this story too, is the brutal story of "the Troubles" and the people caught in the web of hatred on both sides of this seemingly never-ending bloody political and nationalistic conflict. It would take Tony Blair, George Mitchell and representatives of the IRA to come up with the Good Friday Agreement in 1998 which removed direct rule by the British government, disbanded the IRA and set up a government made up of both sides to end the violence.

Finally, it is also the story of **Dan Lawton**, a San Diego Civil lawyer working for a white shoe law firm (Luce Forward Hamilton and Scripps) who one day in 1992, out of curiosity, met with Kevin Barry Artt at MCC where he was being held on an extradition hold to Northern Ireland. That meeting would change not only Kevin's life but also Dan's. He would devote 8 years to helping Kevin stay in the United States, eventually enlisting additional lawyers from **Morrison Forrester** as well as **Jim Brosnahan** to take on this monster of a case, and of course eventually writing this book.

During the time (20 years) it would take to unwind the case, **Dan Lawton** made numerous trips to Belfast, looking for evidence in the case. He would find exonerating evidence with the help of **Alan Miles**, the murder victim's son which eventually resulted in the Northern Ireland Appellate court quashing<sup>2</sup> the conviction.

<sup>&</sup>lt;sup>2</sup> Some may think the word should be "squashed". No it is "quashed" which means to reject as invalid, especially by legal procedure: 'his conviction was quashed on appeal." "to suppress or extinguish summarily and completely".

Kevin Barry Artt today leads a very normal life. He is 65, lives in San Francisco, married, and father to 3 children. For some time, he has been running a prosperous and successful construction business.

I have read the book, and found it engrossing, though I admit I wish there had been more about roles the attorneys played over the years as this case was an epic one from a legal perspective. I asked Dan about that before he spoke, and he said, "the editors thought it was too boring, and cut most of it out".

I should also mention, Dan Lawton told us, the book is in the process of being made into a movie. In the meantime, consider getting a copy, as I have only touched on the surface of this extraordinary story.
