At our upcoming meeting, Tuesday November 29, Phyllis Pfeiffer, Chair of the La Jolla Community Foundation On the La Jolla Streetscape



Phyllis, a graduate of Cornell University, and a La Jolla resident began her career in the Newspaper Industry in the early 70's at the La Jolla Light, became general manager of the LA Times San Diego Edition. After the Times closed, she headed North to the Bay area to run the Marin Independent Journal, later being named Senior Vice President of the San Francisco Chronicle.

In 2009 She returned to La Jolla, taking the position of publisher of the La Jolla Light which she has held for the last 14 years. She retired when the **San Diego Union** was bought out by a hedge Fund last July.

In 2009 she also helped form the privately funded **La Jolla Community Foundation** with the mission of supporting improvement projects to **Enhance La Jolla**. Most recently the Foundation launched a fund-raising campaign to raise 6.5 million for Phase one of the **Village Streetscape Project**. Tuesday, she will speak on the progress that is being made on the Streetscape projects today.



Who AM I? Don R Lincoln Esq.



Don Lincoln grew up on a rural farm in Upper New York State. The closest town had a population of about 130 people. For years his family had no electricity or running water. His education took place in a rural school district 40 miles away. During those years, early every morning a school bus would take him and other rural kids for that very long, 40-mile trip to school.

When he went to High School, among other things, the teachers insisted the students practice taking standardized tests. He estimated he took

over a hundred by the time he graduated. It seemed endless. Nonetheless that regular testing, taught him a lot about standardized testing. He credits that exercise for giving him a sizeable edge to successfully take college and law school entrance exams.

When he graduated, he became the first in his family to ever graduate from High School. In that same year he earned a full scholarship **to Cornell University**, based primarily on his high scores achieved on the New York Regents Scholarship Exam.

Upon graduation from Cornell, three things happened, 1. He was commissioned as a Naval Officer, 2. he married his wife Mary Jane, and 3. He received a scholarship to **Duke Law School.** Again, he credited that scholarship to his ability to take standardized exams.

While at Duke he went into the Reserves. After graduation he served in the Navy and was happy there. However, he was gone quite a bit and his wife

who was not happy with his absences, offered him a choice. As a result, he decided to resign from the service.

When he came to San Diego, at first, he worked for public agencies, such as the San Diego School District. Eventually he went into private practice, initially representing trailer owners who had grievances against their Trailer Park Owners. It was a niche market, but one that was surprisingly profitable.

Over the years he received an LLM in Tax from USD. Eventually his practice turned to Real Estate law. He is now semi-retired and has returned to doing some agency work.

Besides Rotary which he joined in 1978, he has done a lot of volunteer work with **the La Jolla Methodist Church**, and the **La Jolla Bar Association**, where he served as President in 2016. Today, he often thinks of the rural area he grew up in and the poverty that continues to exist there.



Our Speakers on November 14th: Joe Gilbreath Founder of Rise Up Industries and Mike Lucero



Joe Gilbreath found **Rise Up Industries** after a chance encounter with **Father Greg Boyle** at Donovan State Prison. Joe was there as a volunteer involved in a ministry that served those incarcerated. Father Boyle is a well-known figure, as he had started a very successful Reentry program in LA 35 years earlier called "Home Boys Industries", which since has been copied across the United States and the World.

Joe asked if San Diego had a "Home Boys" Program, Father Boyle said, "No, why don't you start one"? And so, he did.

It took 3 years to get adequate funding to set up the 18-month program which would teach gang parolees how to work a massive CNC Machine, qualifying them for much needed, well- paying jobs in private industry. During their training, among other things, they would be paid, helped to find housing, and drug tested. The initial class was 19 men. 18 have been successful, with only one reoffending.

Recently, RUI has qualified for Federal and State Assistance which will boost their ability to provide greater services within their reentry program and begin a program of Prevention for San Diego teens. It will be led by Mike Lucero, a graduate of RUI.

When Mike spoke, the room went silent. He candidly told us the story of his lost childhood. Both of his parents were drug addicts. By the time he was 10, the state had completely taken over his care. He bounced from foster home to foster home, then juvenile group homes. Along the way, he became initiated to gang life, leading to juvenile detention and eventually being incarcerated in state prison.

Two years ago, while in prison, he heard about RUI, and wanting to change his life, met with Joe Gilbreath, and asked if he could join the program.



Four months ago, he graduated from the 18-month program, and Joe hired him to be part of the RUI team to lead RUI's new Youth Prevention Program. It has now been two years since he was released from Prison. At 45, he is now married, raising a young son, has a good job and is part of a strong supportive community. The changes in his life have been epic.
