### C. Local Community Action (one-time/short-term) Projects:

- Continue support of these community action projects that are one-time, lower logistical planning effort/high volunteer desire projects:
  - a. Highway Cleanup
  - b. Feeding South Dakota
  - c. City Cleanup at Steven's High School
- 2. Support the emphasis on additional one-time or short-term projects by including a line item in annual budgets.

## D. Club lead District Grant Projects:

- 1. Past President and President-Elect shall serve on the Grants Committee. The Grants Committee will lead the development of a timeline and method of collecting District Grant application ideas from club members.
- 2. Potential Grant proposals are presented to the Grants Committee, then the Committee makes yah/nay recommendations to the Board for final decision to proceed.
- 3. Pending Board approval to proceed, Grants Committee will guide those interested in formally writing/submitting a grant to the District.
- 4. Document progress of potential grants throughout the year for club members to easily follow; recall District Grants have specific due dates per year, set by the district. Invite members to show their support during the development process.
- 5. With goal of at least one District Grant submission per year, invite club members to measure their ability to support for the duration of the project, pending/after District approval.
- 6. Research and create a list of other community grants that the club could be eligible to apply for in order to support our projects. For example, MIDCO, Monument Health, Vucurevich Foundation, South Dakota Community Foundation, and Black Hills Area Community Foundation.

### **E. International Projects:**

- 1. Continue support of these community action projects that are one-time, lower logistical planning effort/high volunteer desire projects.
- 2. Encourage the club, in partnership with Rotary International, to continue active support of the following:
  - a. Polio Plus
  - b. Tanzania School of St. Jude
  - c. Rotaract and Interact International Projects
  - d. Youth Exchange
  - e. Emergency Response Shelter Box for international disasters
  - f. Vocational Training Teams, Friendship Exchanges, other exchanges
- 2. Continue to evaluate and/or support Global Grants with which the District is involved. Current Global Grant that the club maintains an interest in supporting are as follows:
  - a. Hope Haven projects (providing wheelchairs in Philippines, Ukraine, and Romania)
  - b. Whiteclay Arts Makerspace
  - c. Self-help group in India
  - d. End Human Trafficking in District 5610
- 3. Continue/increase education on potential travel opportunities in support of the above projects.
