- 2. You complete and submit the online application form
- 3. Club members vote you in
- 4. You have an Induction Ceremony
- 5. Within the first 90 days you attend a New Member Orientation and serve as a co-greeter three times

Membership Application Form (Corporate)

Corporate Membership allows a business or corporation to designate one person as its primary member and up to four individuals from the same firm as alternate members.

Dues: \$250 per year for the Primary Member \$50 per year for each Alternate Member

All Corporate members, both the Primary and the Alternate(s), may:

- Attend weekly meetings
- Attend all club activities
- Attend other Rotary club meetings

All Corporate members, both Primary and Alternate(s), will:

- Receive the club's weekly newsletter, the *Punch*
- Be responsible for the cost of their meal (just as all members)
- Have the opportunity to become a Paul Harris Fellow

Only the Primary member will be able to:

- vote on club matters, such as electing a president
- have his or her name submitted to the Rotary District
- have his or her name submitted to Rotary International
- be able to hold office
