November is Rotary Foundation Month. The Rotary Foundation began as an idea by Arch Klumph in 1917 to start an endowment fund to do good in the world. This year's goal for the Annual Programs Fund is \$104 million. According to Rotary International, three things every Rotarian should know about the Foundation are: 1. The Foundation is working on our primary goal which is the eradication of polio. As of November 2, 502 cases of Polio were reported in 2011. 2. The Foundation changes lives—communities world wide benefit from the work of the foundation in the form of clean water. better health care, and the

Work of Rotary Peace Fellows. **3. You** make it possible—The Foundation is supported by voluntary contributions by Rotarians and others who share our vision. One of the ways our club continues to support the foundation is the water filter project in which every \$100 that we donate as individuals is matched by the club to maximize our dollars. We have also made the decision to contribute all proceeds from this years "Good News" to the Polio Plus Foundation and the club's share of the 50/50 drawings to the water filter project. The Rotary Foundation is for the Interact Club members at their regular after school meeting at 2:30. Moderator Judy Alexander is planning a ceremony and parents of the students will be invited to the event. We would also like to have some Rotarians present to support the students as well. DECLARATION OF ROTARIANS IN BUSINESSES AND PROFESSIONS

As a Rotarian engaged in a business or profession, I am expected to:

- 1) CONSIDER my vocation to be another opportunity to serve;
- BE FAITHFUL to the letter and to the spirit of the ethical codes of my vocation, to the laws of my country, and to the moral standards of my community;
- 3) DO ALL in my power to dignify my vocation and to promote the highest ethical standards in my chosen vocation;
- BE FAIR to my employer, employees, associates, competitors, customers, the public, and all those with whom I have a business or professional relationship;
- 5) RECOGNIZE the honor and respect due to all occupations which are useful to society;
- 6) OFFER my vocational talents: to provide opportunities for young people, to work for the relief of the special needs of others, and to improve the quality of life in my community;
- 7) ADHERE to honesty in my advertising and in all representations to the public concerning my business or profession.
- 8) NEITHER SEEK from nor grant to a fellow Rotarian a privilege or advantage not normally accorded others in a business or professional relationship.
