MESSAGE FROM CHAIR AND CHIEF EXECUTIVE

On behalf of the Board, staff, members, and volunteers, it is a great privilege to introduce New Zealand Land Search and Rescue's 2023/24 Annual Report. This past year has been remarkably busy and rewarding, reflecting our steadfast commitment to providing Search and Rescue services to the lost, missing, and injured throughout Aotearoa New Zealand.

New Zealand Land Search and Rescue Inc. continues to be the national volunteer organisation that provides land search and rescue support services to the Coordinating Authorities (New Zealand Police and Rescue Coordination Centre New Zealand). Our volunteers operate across suburban, urban, wilderness, and rural areas, including regional and forest parks, shorelines, and caves, to ensure that help is never far away.

Reflecting on the financial year 2023/24, Land Search and Rescue volunteers were involved in an impressive 495 Search and Rescue Operations, aiding 600 individuals whose lives were at risk. Our volunteers dedicated a combined total of 167,962 unpaid hours to Search and Rescue activities, underscoring their unwavering dedication and commitment.

We owe a tremendous debt of gratitude to our volunteers, whose selfless dedication makes our mission possible. We would also like to extend our heartfelt thanks to the families (whānau) and employers of our volunteers. Their unwavering support and understanding enable our volunteers to commit the time and effort required for their crucial roles in life-saving operations. The sacrifices made by these whanau and employers, often behind the scenes, are invaluable to the success of Land Search and Rescue.

We have seen substantial growth in our operational capabilities and volunteer support. This year, 343 new volunteers joined our ranks, contributing to a total of 3,300 volunteers. Our volunteers' extensive efforts were complemented by our continued emphasis on training and development. A total of 342 formal training events were delivered, involving 4,289 students and amounting to 72,668 hours of formal training.

Funding this year has allowed impressive results, with \$2,489,386 being spent on Land Search and Rescue group equipment, grants/scholarships and travel/accommodation. This funding has been instrumental in providing essential resources such as radio and communication equipment, GPS devices, Pisa jackets, first aid kits, locator beacons, specialist rescue equipment and WanderSearch pendants and tracking devices.

Although our National Support Staff has grown to include a small yet effective team of 41 staff, we remain firmly committed to enhancing the resources and support available to our volunteers.

Finally, we extend our heartfelt appreciation to all our volunteers, staff, donors, supporters, and collaborating organisations. Your collective efforts and contributions are deeply valued and have made a significant difference in our local communities and the ongoing mission of New Zealand Land Search and Rescue.

Introduction

We are New Zealand Land Search and Rescue, a national volunteer organisation dedicated to providing essential search and rescue (SAR) assistance across Aotearoa. Our mission is to support and carry out SAR operations in diverse environments, including suburban, urban, wilderness, and rural areas, as well as parks, shorelines, and caves.

With over 3,300 highly trained volunteers across 64 local groups, we respond to a wide range of emergencies nationwide. Our teams specialise in various disciplines, including Search and Rescue Dogs, CaveSAR, CanyonSAR, Alpine Cliff Rescue, and RiverSAR, ensuring we are equipped to handle even the most complex rescue situations. We are governed by the Board of Land Search and Rescue Inc and led by the Chief Executive, supported by a small team of salaried National Support Staff. Together, we provide strategic leadership and operational support, ensuring our volunteers can effectively carry out rescue missions and save lives across all terrains and environments.

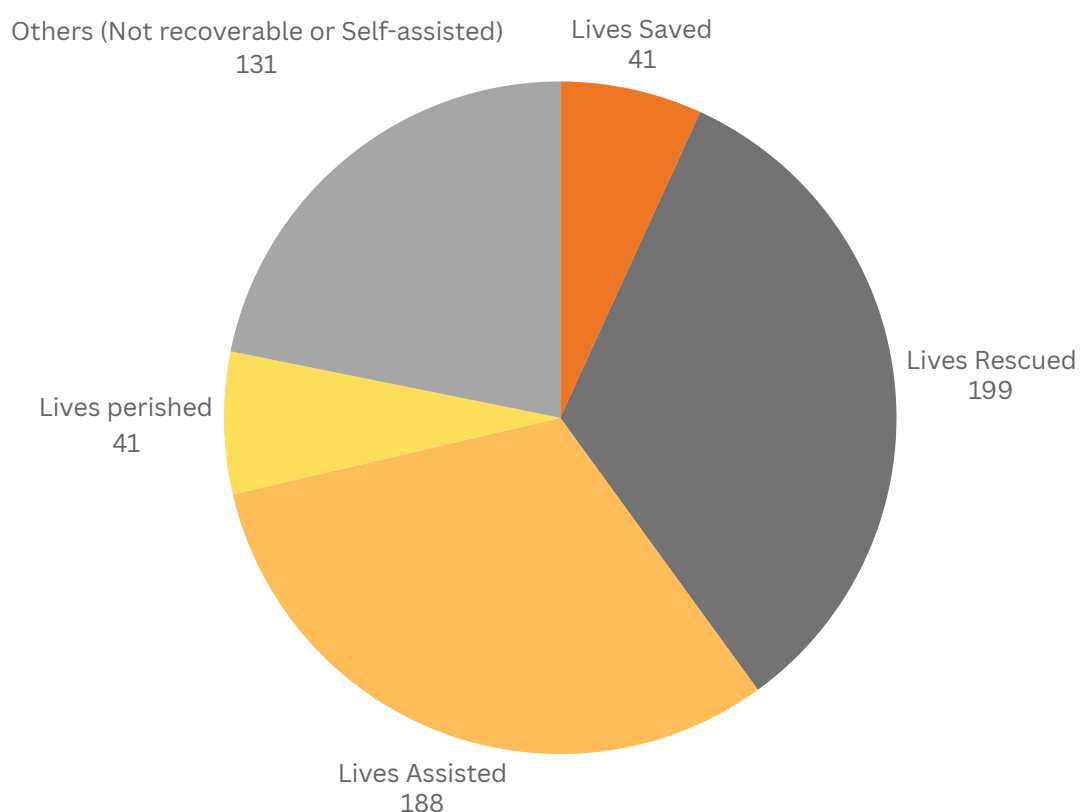

From July 2023 to June 2024, our dedicated volunteers donated an incredible **167,962 hours** to search and rescue operations, providing vital assistance to **600 people**.



We operate 24/7 in coordination with the New Zealand Police and the Rescue Coordination Centre, ensuring a rapid response to emergencies at any time. Our volunteers generously donate their time and bring highly specialised search and rescue skills to every operation.

Our coverage spans suburban, urban, wilderness, and rural areas, allowing us to respond to incidents in a variety of challenging environments. Specialist teams include Land Search and Rescue Dogs, CaveSAR, CanyonSAR, Alpine Cliff Rescue (ACR), and RiverSAR, ensuring that we are well-prepared for any scenario.

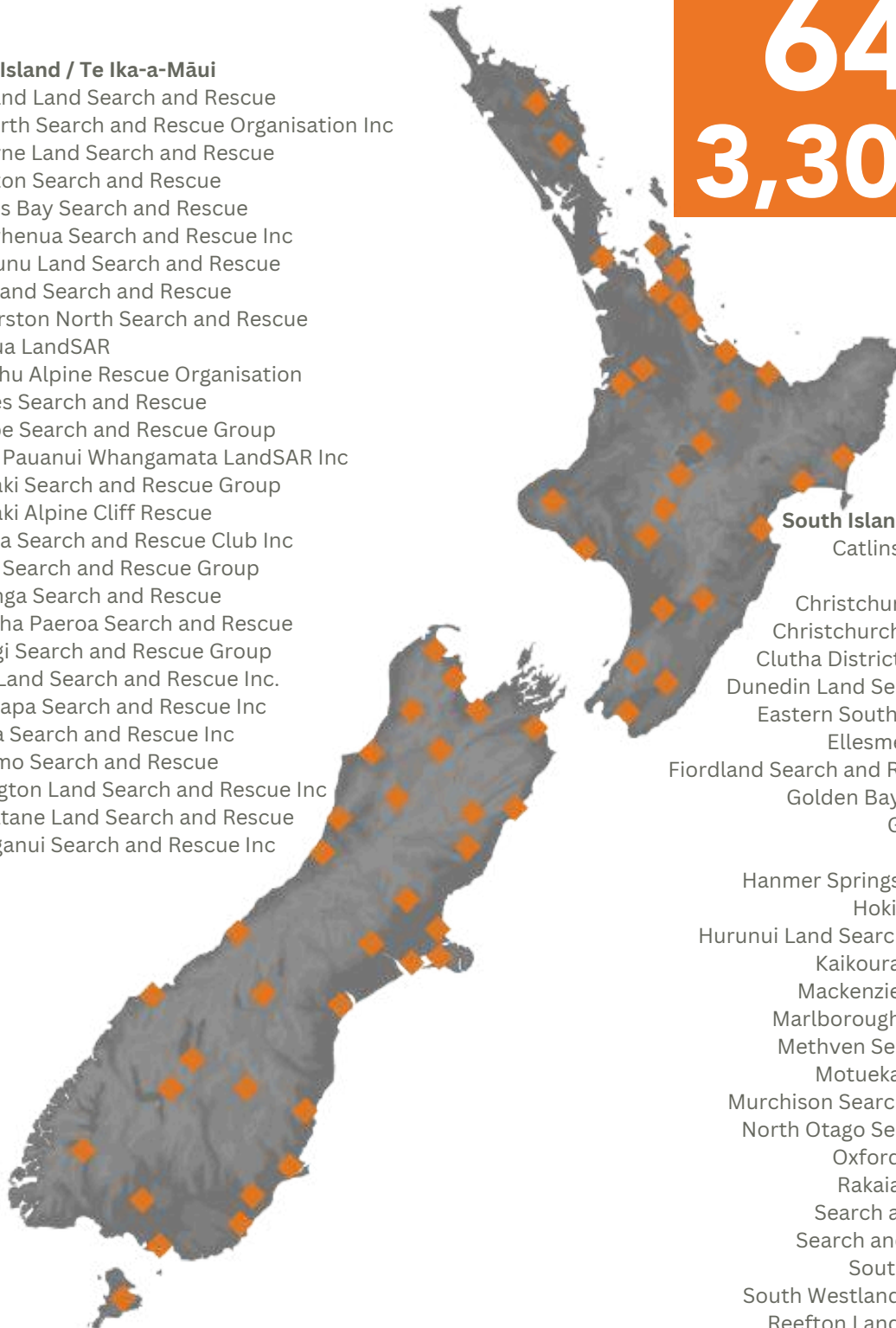

Land Search and Rescue's governance body is the Board of New Zealand Land Search and Rescue Incorporated.

The Board comprises of elected directors chosen by the Land Search and Rescue membership and appointed directors. The Board meets at least six times a year and appoints three of its members to the Audit Committee, which reviews all policies and financial commitments and undertakings.

OUR ACHIEVEMENTS IN 2023/24

Lives Saved, Training, and Specialist Teams at Work

In the 2023/24 period, we have made significant strides in saving lives and assisting those in need across New Zealand. With **495 operations** undertaken, we aided **600 individuals** in critical situations, including **41 lives saved, 199 lives rescued, and 188 lives assisted**. Our dedicated volunteers contributed over 167,962 hours, including operational, training, administrative, and prevention work. We continue to train and empower our teams, with **355 training events** completed and 2,354 volunteers attending training sessions. Our diverse volunteer base, made up of 3,300 individuals, played a pivotal role in every operation, ensuring that we are always ready to respond when needed. Together, we remain committed to providing search and rescue services across Aotearoa, ensuring everyone has a chance to come home safely.

(355 training events includes 342 formal and 13 informal training events, such as webinars and online workshops).

In addition to our operational achievements, we have placed a strong emphasis on training to ensure that our volunteers are prepared for any situation. This year, we delivered a total of 342 formal training courses across various disciplines. These included **181 Search and Rescue courses**, 49 Multi-Agency Search and Rescue courses, and 54 Emergency Management courses. We also offered 58 User Pays courses to extend our expertise and knowledge to other organisations. These training efforts are vital in maintaining the high standard of readiness and skill required for our volunteers to perform at their best in challenging environments.

Our specialist teams have once again demonstrated their crucial role in search and rescue operations across New Zealand. This year, our Specialist Land Teams dedicated over 1,913 hours to rescue efforts, resulting in 16 lives saved, 53 lives assisted, and 73 lives rescued. Teams such as CanyonSAR, CaveSAR, and Alpine Cliff Rescue (ACR) units from Christchurch, RARO, Taranaki, Wakatipu, and Wanaka contributed significantly to these outcomes. The Christchurch ACR alone saved 1 life and rescued 6 others, while the RARO ACR saved 2 lives, assisted 9, and rescued 9 individuals. Our Wilderness Dogs team, with 227.5 hours of dedicated work, played an essential role in assisting 5 individuals and saving 2 lives. These specialist teams bring a wide range of expertise and skill to complex and challenging operations, making an invaluable contribution to our overall mission of bringing people home safely.

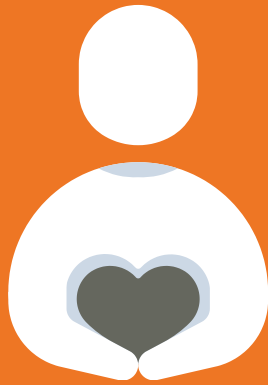

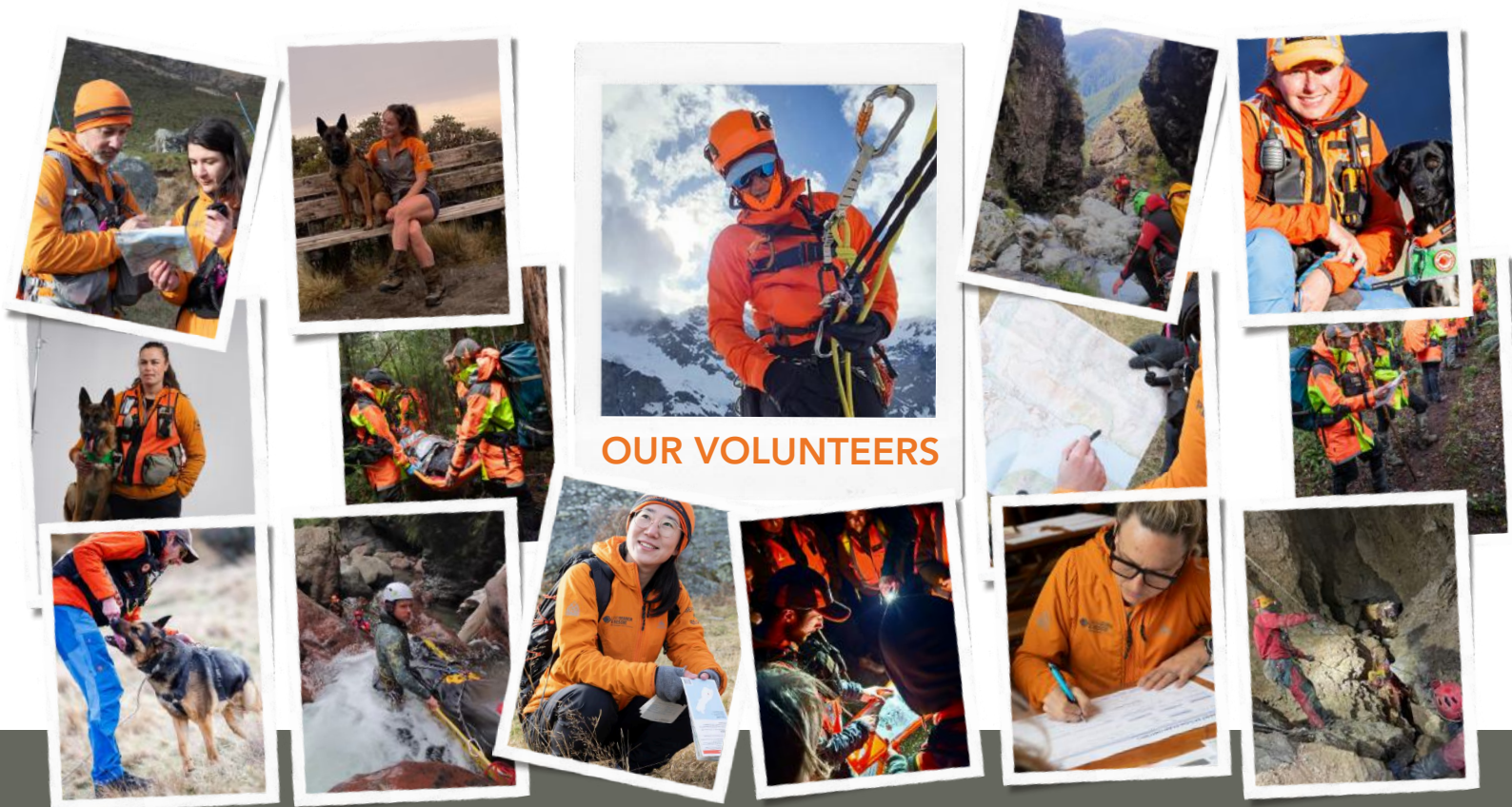

SPECIALIST TEAMS IN ACTION

This year, our Specialist Land Teams dedicated over 1,913 hours to critical search and rescue operations across New Zealand, resulting in 16 lives saved, 53 lives assisted, and 73 lives rescued. These highly trained teams, including CanyonSAR, CaveSAR, Alpine Cliff Rescue (ACR) teams from Christchurch, RARO, Taranaki, Tasman/West Coast, Wakatipu, and Wanaka, worked tirelessly in some of the most challenging environments.

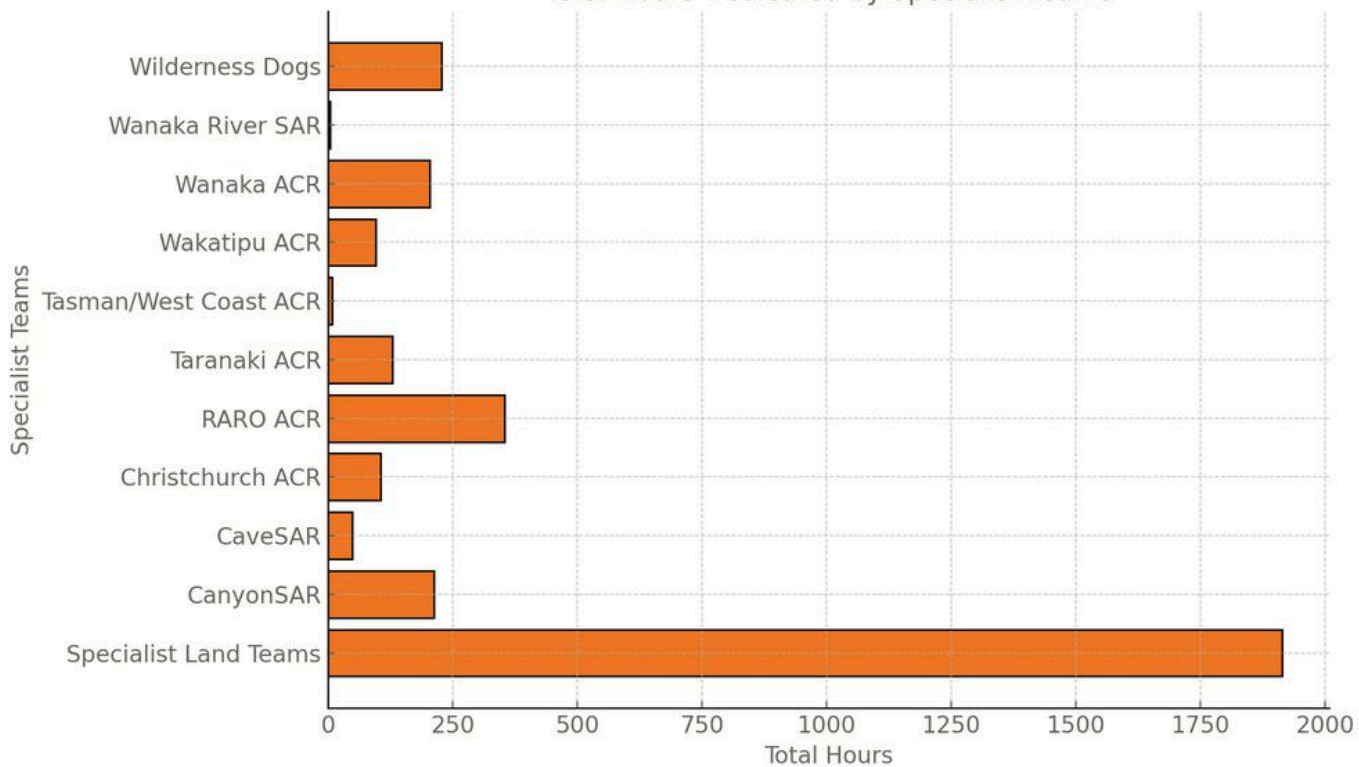
Among the standout contributions, CanyonSAR committed over 212 hours, resulting in 1 life saved and 2 lives assisted. The Wanaka ACR team played a vital role with over 203 hours dedicated to missions, saving 2 lives and assisting 15 others.

Our Wilderness Dogs also proved invaluable, dedicating 227.5 hours, assisting in the rescue of 5 people and saving 2 lives.

These operations highlight the dedication and expertise of our specialist teams, ensuring the safety and well-being of those in need across Aotearoa.



Total Hours Dedicated by Specialist Teams

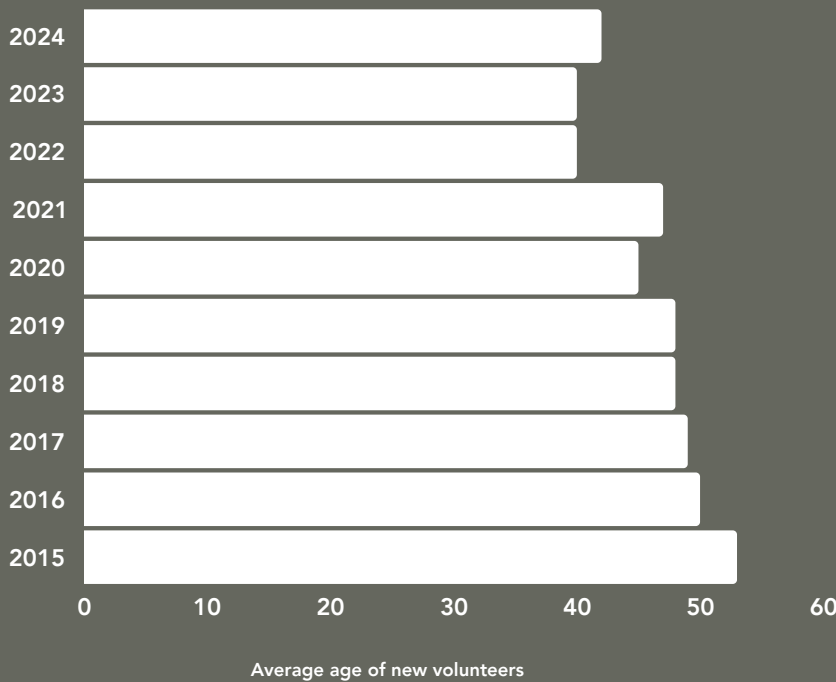


OUR VOLUNTEERS

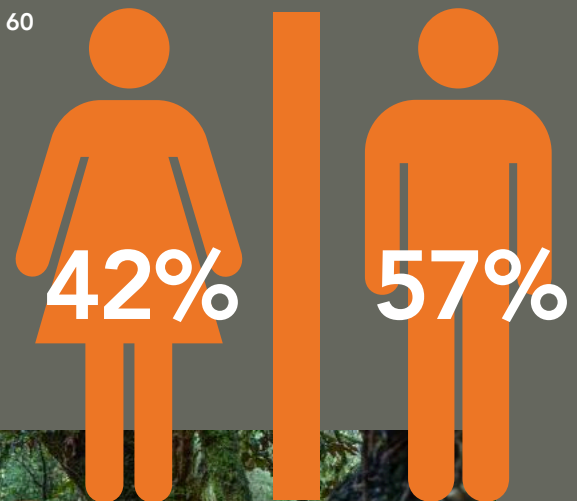
The average age of our volunteers is 48, and 30% of them are women.

NZSAR AWARDS

Gold Award:

- Senior Constable Conrad Smith, Ruapehu Alpine Rescue Organisation (RARO)
- Awarded for: 18 years of service and commitment to search and rescue, including managing high-profile operations such as the Mangetepopo canyoning tragedy and Te Maari eruption, and leading the establishment of the Central Plateau Emergency Management Facility.

Certificate of Achievement:

- Northland Land Search and Rescue, Northland Police SAR Squad, Fire and Emergency New Zealand Ti Hiku Specialist Water Rescue Team, Urban Search and Rescue Team, Whangārei Fire Station, and Northland Plumbing and Gas
- Awarded for: Operational activity during the search for a missing teenager in Abbey Caves on 9 May 2023. Despite difficult weather conditions, the teams conducted a technical rope recovery to return the student to his whānau.

THE WHY

The Searchlight Campaign was created to raise awareness of, and engagement with our mission, with a particular focus on increasing public recognition, expanding our audience, and building new partnerships. Our goal was to highlight the work of our volunteers and drive community involvement, and to start to establish a strong foundation for long-term engagement. This campaign was a critical step in amplifying our presence and setting the stage for ongoing support from volunteers, businesses, partners, and the wider public.

THE WHAT

The Searchlight Campaign successfully boosted engagement across multiple platforms, significantly increasing social media activity and expanding our audience. We experienced a noticeable increase in donations and new contacts, alongside stronger involvement from businesses and communities. The campaign's message reached far and wide through paid advertising, and our campaign film generated positive online engagement. Feedback was overwhelmingly encouraging, with increased awareness and a clear interest in continued involvement from participants. These outcomes highlight the campaign's success in raising awareness and building lasting connections with key stakeholders.

THE FUTURE:

Building on the success of our first campaign, we aim to make the Searchlight Campaign an annual event, running each May in celebration of our anniversary. By spreading the word across multiple mediums—such as programmatic advertising, newspapers, radio, and social media—we will continue to expand our reach and drive community engagement. This ongoing campaign will serve as a key platform for raising awareness of the critical work our volunteers do and ensuring we have the support needed to save lives in Aotearoa.

INTRODUCING OUR MASCOT

Earlier this year, we proudly introduced Seek as part of our Searchlight Campaign, a key initiative aimed at raising awareness of the vital work we do at Land Search and Rescue. Seek is more than just a mascot—Seek represents our ongoing commitment to assisting the lost, missing, and injured.

Throughout the year, Seek has traveled across the country, visiting school groups and joining our volunteers at community talks to promote awareness and share important prevention messaging. In May, Seek made appearances both online and in communities nationwide, engaging with people and helping to highlight the incredible efforts of our volunteers.

By introducing Seek, we aimed to connect with a broader audience and bring greater attention to the important work our volunteers do every day. With Seek by our side, we marked our 91st anniversary with renewed energy and purpose.



PREVENTION AND REDUCTION ACTIVITIES

In 2023/24, Land Search and Rescue significantly expanded its prevention efforts, particularly in wander prevention, resulting in an increase in volunteer hours. New resources were introduced to support groups conducting prevention activities, and funding was made available to enable public safety initiatives regionally.

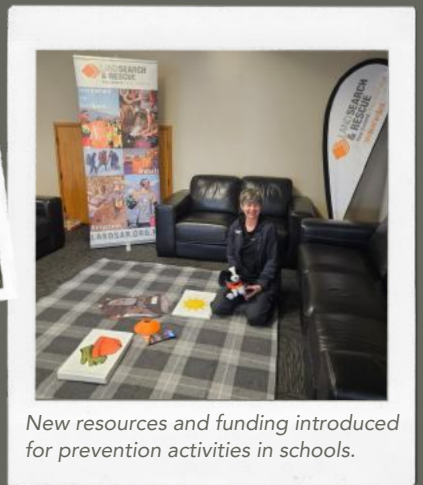
Land Search and Rescue strengthened collaboration by working closely with the Land Safety Forum and signing an agreement with the Mountain Safety Council to amplify safety messages. A new training course was also rolled out to boost volunteer confidence in responding to cognitively impaired individuals. Additionally, research from Victoria University of Wellington led to new wearable adaptations for WanderSearch users.



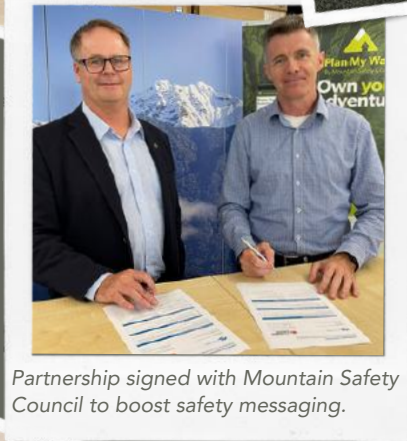

Do you have any cool stories or successes from supporting Land Search and Rescue that you can share?

We value the services that Land Search and Rescue groups throughout New Zealand provide, so when we can, we aim to ensure staff who volunteer can attend call outs. One of our Technical Horticultural Representatives, Aaron Thompson is a Land Search and Rescue volunteer in Marlborough, and has been involved for about 8 years.

He said "I'm really pleased that PGW is supporting Land Search and Rescue on a national level, as there are many synergies between the two organisations, especially the rural aspect. PGW has always been supportive towards my involvement with Land Search and Rescue. The timings of call outs can be a bit tricky since I'm in a sales role—it's just a case of keeping up good comms with my manager Nick and letting him know what's going on. Sometimes I just can't go on a call out due to work timings and other commitments, but that's fine as I know there are awesome people in our local group good to go."



MESSAGE FROM NEW ZEALAND SEARCH AND RESCUE (NZSAR)

It has been another busy year for our search and rescue sector, with 3,535 incidents across our search and rescue region. Around half of these incidents resulted in a search and rescue operation taking place, with 152 lives saved as a result. Many more lives have been impacted by your frontline safety and prevention work such as attending community events, visiting schools and issuing WanderSearch pendants.



For the year ending 30 June 2024, the Government invested \$5.630 million into Land Search and Rescue. Most of this funding supported the day-to-day running of the organisation, including national support staff. It's been great to see the new organisational structure in place, which has resulted in better support to frontline volunteers. I'm confident Land Search and Rescue will be a more resilient organisation in the future, because of the work being done today.

Your bright orange Land Search and Rescue jackets have been a familiar sight at various search and rescue training exercises around New Zealand this year. I would particularly like to acknowledge those people who were able to take part in Exercise Whakarauora Tangata, our Nationally Significant SAR Exercise series. While nationally significant SAR events are rare, it's important that our sector is prepared for when one does occur. As the Māori whakataukī says, 'Ki te kotahi te kākaho ka whati, ki te kāpuia e kore e whati' – when we stand alone, we are vulnerable, but together we are unbreakable.

The search and rescue sector has made significant progress in better understanding and applying Te Ao Māori over the last year. Ten years ago, it was rare to see or hear karakia outside of a marae, whereas now Land Search and Rescue have their own karakia that can be used before deploying in the field or to close off an operation. Around 88 percent of the people involved in search and rescue in New Zealand are volunteers – one of the highest rates of volunteer involvement in the world. Land Search and Rescue plays a vital role in search and rescue operations, especially when 'boots on the ground' is the only way to help. Our sector simply could not provide the world class services that we do without your commitment and dedication. Whether you are deployed in a field team, working out of the incident control point, organising a committee meeting or maintaining equipment, you are an important part of the high performing SAR sector that New Zealanders, and visitors to our shores, rely on in times of trouble.

RCCNZ relied on Land Search and Rescue support more than 80 times over this reporting period (which I understand is a record for one year) and this assistance played a crucial part in getting dozens of people safely back to their friends and family.

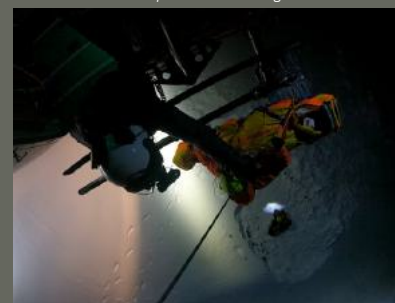
The last year has seen the further maturation of our SAR system and I have been pleased to see the willingness of Police, RCCNZ and Land Search and Rescue to work together to enhance SAR delivery. This journey does from time-to-time require robust conversations and a willingness to challenge each other. That we have been able to do this, and be better for having these conversations, is probably the thing I appreciate the most from the last year. I hope to be able to further build upon this as we work together to streamline our shared system and ensure that we are getting the most appropriate team to tackle the problem they are best suited to managing while ensuring they are effectively supported and coordinated.

A number of our operations last year highlighted the ongoing benefits of our partnership and the ability to bring together local knowledge, specialist expertise, national assets and sound planning and collaboration. An incident I recall from November of last year in the Tararua Ranges highlighted to me the strength of our system and its ability to bring together a wide range of skill sets and capabilities. This incident, involving a couple unable to complete their northern crossing due to the weather and terrain, brought together aeromedical teams, Police, Land Search and Rescue and the NZDF. Weather meant rescue aviation could not get to the distressed location and a Land Search and Rescue team was inserted into the region by an NZDF NH90. This team then walked in over some very challenging terrain while enduring extremely high winds to rescue the couple.

Land Search and Rescues' dedication to providing the necessary resources reflects the depth of our partnership, ensuring that we are equipped to handle even the most complex SAR scenarios. RCCNZ had to call upon Land Search and Rescue teams across the country 53 times in the last year, including calling upon specialised Alpine Cliff Rescue teams 28 times. These jobs typically happen at the worst time and in bad conditions and yet Land SAR volunteers unavailing make themselves available to save lives day in day out.

Land Search and Rescue has been a long-standing key partner providing search and rescue support for lost, missing and injured people across the country for over 90 years. We recognise and value the contribution of the committed and dedicated volunteers who sacrifice their time, often in challenging environments and less than ideal weather conditions, to help others.

In the year ending 30 June 2024, 3,919 volunteers were called upon and 24,653 hours were invested in 495 Search and Rescue operations to bring 428 people home to their family and friends. This is a tremendous effort and one that you can all be very proud of.

An additional 97,411 hours were spent on exercises and training for Land Search and Rescue volunteers to maintain and strengthen their skills and expertise. Using trained and capable people in SAR activities helps ensure that the right people are involved, the right tools are used and most importantly, the risks to the safety of all those involved in the undertaking of search and rescue operations are minimised.

The ongoing efforts and development of our District SAR Assistant Coordinators (DSARACs) has supported further engagement with Land Search and Rescue and other partner agencies. These Police roles have been in place in 10 Policing Districts around New Zealand since late 2021.

The role of the DSARAC team is to strengthen the Police SAR service by ensuring operations are reported and lessons learnt are shared, assisting with the delivery of training and equipping of our people, and seeking opportunities to contribute to and enhance the wider SAR sector.

We value our partnership with Land Search and Rescue and acknowledge their commitment operationally at the coal face and in the development and delivery of training. We know that if we want to continue to be successful, we all need to work together, and it takes each of us playing our part to contribute to shared SAR outcomes for Land Search and Rescue, Police and our communities.

Service Performance Report
For the Year ended 30 June 2024

The New Zealand Land Search and Rescue Group supports, develops, and maintains efficient and effective land search and rescue capability to consistently meet the operational requirements of Co-ordinating Authorities throughout Aotearoa New Zealand.

The Group has achieved this through providing member groups and volunteers with fit for purpose clothing and equipment to undertake their operational roles, grants to support member groups, and travel support to volunteers for the logistical requirements to attend national level events such training courses, group representative meetings, and the biennial Hui.

The Group has achieved this through delivering search and rescue training courses to support search and rescue trainees to achieve an appropriate level of training and to help ensure that good quality search and rescue services can be made available as required throughout Aotearoa New Zealand.

The categories of goods and services selected for reporting are the primary reporting categories in the Financial Statements.

The primary reporting categories of Equipment, Grants and Scholarships, and Volunteer Travel and Accommodation, exist to meet the information needs of Land Search and Rescue member groups on the direct benefits provided to member groups and volunteers.

The primary reporting category of Training Delivery - Volunteer and Other Students, exists to meet the information needs of Land Search and Rescue member groups on the direct benefits provided to volunteers and other students. The Other Students include students from SAR agencies, Emergency Management Agencies, Government Departments, and critical infrastructure organisations, with the goal of enhancing and integrating emergency response across Aotearoa New Zealand.

Up to four sub-categories have been selected to present with explanations of the main components within them. Quantities are obtained from purchase transactions and participant records.

Notes to and Forming Part of the Financial Statements
For the Year ended 30 June 2024

1. Reporting Entity

The Consolidated Financial Statements include New Zealand Land Search and Rescue Incorporated (the parent) and its controlled entity, Land Search and Rescue Training Ltd, which comprise the New Zealand Land Search and Rescue Group. Land Search and Rescue Training Ltd is a wholly owned subsidiary of New Zealand Land Search and Rescue Incorporated. It was purchased on 4 October 2019. All significant inter-company transactions between the entities are eliminated on consolidation.

New Zealand Land Search and Rescue Incorporated and Land Search and Rescue Training Ltd are both registered Charities. They are both members of the New Zealand Land Search and Rescue Charitable group.

There are independent Area and Group Land Search and Rescue organisations, whose financial results are not accounted for within these financial statements because New Zealand Land Search and Rescue Group has no control over these organisations.

2. Basis of Preparation

Statement of Compliance

The Consolidated Financial Statements have been prepared in accordance with New Zealand Generally Accepted Accounting Practice ("NZ GAAP"). They comply with Public Benefit Entity Standards Reduced Disclosure Regime ("PBE Standards RDR"), as appropriate for Tier 2 not-for-profit public benefit entities, for which all reduced disclosure regime exemptions have been adopted.

The New Zealand Land Search and Rescue Group is a Tier 2 Reporting entity as for the two most recent reporting periods it is not publicly accountable and has had between \$5 million and \$33 million operating expenditure.

These financial statements were authorised for issue by the board on the

Measurement Basis

The Consolidated Financial Statements have been prepared on the historical cost basis.

Functional and Presentation Currency

The Consolidated Financial Statements are presented in New Zealand dollars (\$). There has been no change in the functional currency of the entity during the year.

Basis of Consolidation

Controlled entities are those entities over which the Group has the power to govern the financial and operating policies so as to obtain benefits from that entity's activities. The financial statements of the Group's controlled entities are included in the Consolidated Financial Statements from the date that control commences until the date that control ceases. Subsequent changes in a controlled entity that do not result in a loss of control are accounted for as transactions with owners of the controlling entity in their capacity as owners, within net assets/equity. The financial statements of the controlled entities are prepared for the same reporting period as the controlling entity, using consistent accounting policies.

On the loss of control, the Group derecognises the assets and liabilities of the controlled entity, and the other components of net assets/equity related to the controlled entity. Any surplus or deficit arising on the loss of control is recognised in surplus or deficit.

Intra-group balances and transactions, and any unrealised income and expenses arising from intra-group transactions, are eliminated in preparing the Consolidated Financial Statements.

Goods and Services Tax (GST)

New Zealand Land Search and Rescue Incorporated and Land Search and Rescue Training Ltd are both registered for GST. All amounts are recorded exclusive of GST, except for Accounts Receivable and Accounts Payable which are stated inclusive of GST.

3. Use of Judgements and Estimation Uncertainties

The preparation of the financial statements requires management to make judgements, estimates and assumptions that affect the application of accounting policies and the reported amounts of assets, liabilities, revenue and expenses. Actual results may differ from those estimates.

Judgements

Judgements made in applying accounting policies that have had the most significant effects on the amounts recognised in the financial statements include the following:

- New Zealand Land Search and Rescue purchase various items of equipment for distribution to regional entities and volunteers. Given that New Zealand Land Search and Rescue does not retain control over the use of these assets the expenditure is not considered to be capital in nature and the equipment is not recorded as Property, Plant and Equipment of the entity.
- Expenditure on minor assets under \$500 in value is not deemed to be significant enough to warrant recognition as Property, Plant and Equipment of the entity.
- While New Zealand Land Search and Rescue has service agreements with various entities for the delivery of search and rescue services, these arrangements do not constitute 'exchange transactions' for the purposes of revenue recognition as New Zealand Land Search and Rescue does not provide specific services of approximately equal value in direct exchange for the funds received (refer note 4(a) below).

Going Concern

The Consolidated Financial Statements have been prepared on the basis that the entity is a going concern.

Assumptions and Estimation Uncertainties

There are no assumptions or estimation uncertainties that would have a significant risk of resulting in a material adjustment during the financial year.

Changes in Accounting Estimates

There have been no changes in accounting estimates that have an effect on the financial statements.

4. Significant Accounting Policies

The accounting policies set out below have been applied consistently to all periods presented in these financial statements. The significant accounting policies are detailed below:

(a) Revenue

Revenue is recognised when the amount of revenue can be measured reliably and it is probable that economic benefits will flow to the entity, and is measured at the fair value of consideration received or receivable.

The following specific recognition criteria in relation to the entities revenue streams must also be met before revenue is recognised.

Finance Income

Interest on bank deposits is recognised as it accrues.

Revenue from Exchange Transactions

Exchange transactions are those in which the entity receives assets or services, or has liabilities extinguished, and in exchange directly provides approximately equal value, in the form of cash, goods, services, or use of assets.

Revenue from the provision of goods and services is measured at fair value of the consideration received or receivable.

Revenue is recognised on completion of Training services.

Revenue from Non-Exchange Transactions

Non-exchange transactions are those where the Group receives an inflow of resources but provides no or nominal direct consideration in return.

With the exception of services-in-kind, inflows of resources from non-exchange transactions are only recognised as assets where both:

- It is probable that the associated future economic benefit or service potential will flow to the entity, and
- Fair value is reliably measurable.

Inflows of resources from non-exchange transactions that are recognised as assets are recognised as non-exchange revenue, to the extent that a liability is not recognised in respect to the same inflow.

Revenue from Non-Exchange Transactions (continued)

Liabilities are recognised in relation to inflows of resources from non-exchange transactions when there is a resulting present obligation as a result of the non-exchange transactions, where both:

- It is probable that an outflow of resources embodying future economic benefit or service potential will be required to settle the obligation, and
- The amount of the obligation can be reliably estimated.

New Zealand Land Search and Rescue receives various grants and donations which are classified as non-exchange revenue due to their nature.

Grants and donations received that have no requirement to return any unutilised funds are recognised as revenue immediately upon receipt.

Grants received that contractually require the return of any unutilised funds are only recognised as revenue to the extent that performance obligations are met and funds have been spent for the required purpose. Amounts received but unutilised at reporting date are therefore recognised as non-exchange liabilities. These liabilities are subsequently recognised as non-exchange revenue as and when the conditions are satisfied.

The Group sometimes receives donated goods in-kind and services in-kind. Taking into consideration materiality and measurement reliability the Group has elected not to recognise the goods and services within the Consolidated Statement of Comprehensive Revenue and Expense or the Consolidated Statement of Financial Position. The major classes of goods and services in-kind received are disclosed in the Donations, Fundraising and Other Similar Revenue note.

(b) Employee Benefits

Short-term employee benefit liabilities are recognised when the Group has a legal or constructive obligation to remunerate employees for services provided up to reporting date for which settlement will occur within 12 months of reporting date, and are measured on an undiscounted basis and expensed in the period in which employment services are provided.

(c) Financial Instruments

New Zealand Land Search and Rescue recognises financial instruments when it becomes a party to the instruments. Material financial instruments include cash and cash equivalents, accounts receivable and accounts payable. All financial instruments are recognised initially at fair value and subsequently at amortised cost.

The Group derecognises a financial asset when the contractual rights to the cash flows from the asset expire, or it transfers the rights to receive the contractual cash flows in a transaction in which substantially all the risks and rewards of ownership of the financial asset are transferred. Any interest in transferred financial assets that is created or retained by the Group is recognised as a separate asset or liability.

The Group derecognises a financial liability when its contractual obligations are discharged, cancelled, or expire. The Group also derecognises financial assets and financial liabilities when there has been significant changes to the terms and/or the amount of contractual payments to be received/paid.

Financial assets and liabilities are offset and the net amount presented in the statement of financial position when, and only when, the Group has a legal right to offset the amounts and intends either to settle on a net basis or to realise the asset and settle the liability simultaneously.

Financial Assets

Loans and Receivables

Loans and Receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market. After initial recognition these are measured at amortised costs using the effective interest method, less any allowance for impairment. The Group's cash and cash equivalents and receivables from exchange transactions are classified as loans and receivables.

Financial Liabilities

The Group's financial liabilities include payables. These are classified as amortised cost and are initially recognised at fair value and are subsequently measured at amortised cost using the effective interest method.

(d) Leases

Classification and Treatment

Leases in which the entity assumes substantially all the risks and rewards of asset ownership are classified as finance leases. Leases that are not finance leases are classified as operating leases. New Zealand Land Search and Rescue is not party to any finance leases. Operating leases are not recognised in the entity's Statement of Financial Position. Payments made under operating leases are recognised in the Statement of Comprehensive Revenue and Expense on a straight line basis over the term of the lease. Lease incentives are recognised as an integral part of the total lease expense, over the term of the lease.

(e) Property, Plant and Equipment

Items of property plant and equipment are initially measured at cost, except those acquired through non-exchange transactions which are instead measured at fair value as their deemed cost at initial recognition.

Items of property, plant and equipment are subsequently measured at cost less accumulated depreciation and impairment.

When parts of an item of property, plant and equipment have different useful lives, they are accounted for as separate items (major components) of property, plant and equipment.

Any gain or loss on disposal of an item of property, plant and equipment (calculated as the difference between the net proceeds from disposal and the carrying amount of the item) is recognised in surplus or deficit.

Subsequent expenditure is capitalised only when it is probable that the future economic benefits associated with the expenditure will flow to the Group. Ongoing repairs and maintenance is expensed as incurred.

For plant and equipment, depreciation is based on the cost of an asset less its residual value. Significant components of individual assets that have a useful life that is different from the remainder of those assets, those components are depreciated separately.

Depreciation is recognised in surplus or deficit on a straight-line or diminishing value basis over the estimated useful lives of each component of an item of property, plant and equipment.

Depreciation rates used are as follows:

Computer Equipment and Software	50 - 67% DV
Office Equipment and Furniture	19 - 67% DV
Training Delivery Equipment	20 - 67% DV

(f) Business Combinations

Business combinations are accounted for using the acquisition method as at the acquisition date, which is the date on which control is transferred to the Group. The Group controls an entity when it has the power to govern the financial and operating policies of an entity so as to obtain benefits from its activities. In assessing control, the Group takes into consideration potential voting rights that are currently exercisable.

The Group measures goodwill at the acquisition date as the aggregate of the fair value of consideration transferred, the recognised amount of any minority interests in the acquiree, and the fair value of any pre-existing equity interest in the acquiree, less the fair value of the net identifiable assets acquired and liabilities assumed.

Any gain on bargain purchase gain is recognised immediately in surplus or deficit.

The consideration transferred does not include amounts related to the settlement of pre-existing relationships. Such amounts are generally recognised in surplus or deficit.

Transaction costs related to a business combination incurred by the Group, other than those associated with the issue of debt or equity securities, are expensed in surplus or deficit as incurred.

Any contingent consideration payable is measured at fair value at the acquisition date. If the contingent consideration is classified as equity, then it is not subsequently remeasured and settlement is accounted for within net assets/equity. Otherwise, subsequent changes in the fair value of the contingent consideration are recognised in surplus or deficit.

If the business combination is achieved in stages, any previously held equity interest is remeasured at its acquisition date fair value and any resulting gain or loss is recognised in surplus or deficit. It is then considered in the determination of goodwill.

(g) Intangible Assets

Intangible assets are initially measured at cost.

All of the Group's intangible assets are subsequently measured in accordance with the cost model, being cost (or fair value for items acquired through non-exchange transactions) less accumulated amortisation and impairment.

The Group has no intangible assets with indefinite useful lives.

Subsequent expenditure is capitalised only when it increases the future economic benefits embodied in the specific asset to which it relates. All other expenditure, including expenditure on internally generated goodwill and brands, is recognised in surplus or deficit as incurred.

Amortisation is recognised in the surplus or deficit on a straight-line basis over the estimated useful life of the amortisable intangible asset.

The Private Training Establishment's intangible assets acquired are amortised on a straight-line basis with an estimated useful life of eight years.

Amortisation methods, useful lives, and residual values are reviewed at each reporting date and adjusted if appropriate.

5. Changes in Accounting Policy

There have been no changes in accounting policy, all policies have been applied on a basis consistent with the prior year.

New Zealand Land Search and Rescue Incorporated has control over its wholly owned subsidiary Land Search and Rescue Training Ltd. There are no significant restrictions regarding the transfer of dividends, loan repayments, and other funds from the controlled entity.

An advance has been made from Land Search and Rescue Training Ltd to New Zealand Land Search and Rescue Incorporated (no interest payable and no defined payment term). Note that the intercompany advance is eliminated on consolidation.

New Zealand Land Search and Rescue Incorporated holds a contract with New Zealand Search and Rescue for the delivery of core search and rescue courses and therefore they invoice New Zealand Search and Rescue for training delivered by Land Search and Rescue Training Ltd. Land Search and Rescue Training Ltd use intercompany invoicing and the intercompany advance account to transact with New Zealand Land Search and Rescue Incorporated, which can result in a significant balance within the advance account. The intercompany advance is eliminated on consolidation.

New Zealand Search and Rescue Incorporated holds a Service Level Agreement with New Zealand Land Search and Rescue and they received \$5.6m of funding during the period to support the implementation of that agreement.

Of the \$5.6m received in the period the following amounts were provided to Land Search and Rescue Training Ltd to directly support:

- Training and Competency .5 of an equivalent full-time employee
- The Learning Management Framework .5 of an equivalent full-time employee
- Academic Compliance requirements .5 of an equivalent full-time employee

The transfer of this funding was made via the intercompany advance account.
