SIKKIM (EAST & NORTH) – DARJEELING - 2022

09 DAYS/08 NIGHTS (08 – 16 Mar 2022)

In March 2022, ten Rotarians & family members from four District 3310 clubs travelled to Sikkim (India) on a Vocational Training Team and Fellowship trip. The trip was led by PP Jimmy Ooi (RC Singapore) and included DG Dolly Yeap (D3310), DRFC PP Dr Shahul Hameed and Michelle (RC Singapore), PDG Michael Yee (D3310) and Helen, Dir Louisa and her husband Weng Cheu & son Sean (RC Singapore), PP Brian Tan (RC Raffles City) and last, but not least, Dir Peter Brock & Tanya (RC Singapore).

The trip was to experience first-hand the impact which our Clubs and our District, through Global Grants, are having, in and around Kolkata. In addition, we also visited Sikkim and some of the more remote villages north of Gangtok, to see the potential for further assistance.



We spent our first full day visiting hospitals in and around Kolkata that have been the beneficiaries of Rotary Club of Singapore sponsored Global Grants. The impact of these grants, and the support given by the RC of Belur (RCS Sister Club) [Global Grant - Eye Projects at Susrut Hospital], RC Calcutta Metropolitan (RCS Sister Club) (Global Grant – Oxygen Plant at Ispat Hospital], RC Calcutta Mahanagar [Global Grant - Dialysis Centre], RC Calcutta Mega City (Global Grant - Ventilators at Ramakrishna Mission Hospital] is amazing and I'm proud, and a little humbled, that I belong to a Club that has transformed so many lives. From the purchase of dialysis machines, ventilators for Covid-19 treatment, medical oxygen plants, funding eye clinics and general hospital medical services, our Club is supporting the amazing effort of many medical professionals whom every day, 'serve to change lives.'

It wasn't all work though as we also visited Mother's House, the final resting place of Mother Teresa, and were spoilt by having lunch with several new Rotarian friends. We ended the night by attending a joint meeting of the Rotary Club of Calcutta and the Rotary Club of Calcutta Mega City where we were honoured to meet Rotary International Director Nominee, RIDN Anirudh Roy Chowdhury. During the meeting, we were also given a presentation on their proposed Global Grant project to protect the local mangroves whilst also improving local flood mitigation measures.

After a welcome sleep, we met our other travellers who arrived overnight. Once breakfast was over, we headed for the airport to catch our flight to Bogdogra, the northernmost airport of West Bengal. Upon arrival, we meet our guide and our drivers, then drove, after lunch hosted by the RC Siliguri, the 115Km to Gangtok. This sounds like a pleasant drive, however due to the mountainous climb, the journey takes five hours. In addition to the windy roads, to enter Sikkim, you need specific approval, called an In Line Permit, which needs to be approved at the border checkpoint between West Bengal and Sikkim. As this isn't a quick process, we stopped at Ricki's Bar & Restaurant for a beverage and snacks while waiting for the permit to be approved. During the next seven days, we had many checkpoints to pass which resulted in numerous stops to enjoy the mountain scenery.

During the next few days, we managed to experience local hospitality, as well as meeting up with members of the RC Gangtok South and well as RC Gangtok Smart City. We were fortunate to have a representee from RC Gangtok Smart City, Rtn Choden joining our tour for the next stage of our trip, which was to visit the village of Lachung, located North Sikkim, close to the Tibetan border.

During the Gangtok rest day prior to travelling to Lachung, we were very blessed to be granted an audience with His Excellency Zurmang Gharwang Rinpoche. Due to covid19 restrictions, this was his first public greeting in more than two years, and he was more than generous with his time.

After spending time wandering around the monastery, we travelled to Tsomgo Lake, which is at an elevation of 12,310 feet (3,753m). A highlight of the visit to the lake is a Yak Safari. Yaks are known as the Himalayan wagon and are often used to carry loads in the high passes of the Himalaya.



Upon our return to Gangtok, we had an interaction dinner meeting with Rotary Club of Gangtok South at our hotel, the Mayfair Resort & Spa.



During the next three days, we drove to Lachung and spent time with the local Dzumza (village committee) to discuss their needs and how Rotary could assist. It was quite clear to us that improving the Lachung Primary Health Care Centre and the local schools would offer significant benefits to the community of which, the RC Gangtok Smart City will take the lead in preparing a Global Grant submission.

### OPENING REMARKS

President Louis Lim warmly welcomed members and guests to the Club's hybrid meeting held at the Churchill Room at Tanglin Club.

He is Singaporean but is of Japanese descent, his mother is Singaporean and father is Japanese. In terms of community services, he focused on educating digital adoption such as NFTs, generative art etc to art students/adult practitioner through schools like NAFA and communities such as "Join the flow - a freelance engagement community".

### GUEST SPEAKER: MS. RANGANAYAKI THANGAVELU

#### TOPIC: SOCIAL INCLUSION AS AN ANTIDOTE TO POVERTY

the Club's 13<sup>th</sup> Fireside Chat was moderated by VP/PN Dr Chan Siew Luen who introduced the Speaker, Ms. Ranganayaki Thangavelu as his co-conspirator in University. Ms Ranga is Deputy Executive Director of Beyond Social Services.

Ms Ranga gave a brief overview of the services provided by Beyond Social Services which as the organisation's name denotes – their approach to services goes beyond welfare towards stability. She highlighted some statistics of poverty in Singapore with about 14% (about 140,000 households) of families living on less than \$1,500 per month. With 57,000 families among the poorest living in HDB rental flats with an average income of \$750 a month. Ms Ranga shared Beyond's vision to create neighbourhoods where individuals support themselves and contribute to stable families, and in turn build resilient communities that support the wider society. She further spoke on approaches to tackling social issues; bridging volunteers and partners to vulnerable communities and shared success stories such as the "Sew Can We" initiative that empowered women from low-income backgrounds to generate income through sewing projects. Following her talk, Ms Ranga answered the many questions posed to her such as the demographics of the various groups which the organisation works with, as well as the various challenges faced.

To conclude, VP/PN Siew Luen warmly thanked Ms Ranga for sharing her informative insights and views.

### GUEST SPEAKER: ROTARIAN SUHAIMI ZAINUL-ABIDIN

#### TOPIC: EID AL-FITRI – ITS MEANING AND CELEBRATION

President Louis called on PP Perlita Tiro to introduce the Speaker, none other than our member, Rtn Suhaimi Zainul-Abidin. PP Perlita noted that next week would be the celebration of Hari Raya also known as Eid Al Fitr. Rtn Suhaimi is a lawyer by training, like our President. He joined his current company, Quantedge Capital in 2013 and in 2018 became its CEO. Rtn Suhaimi joined the Club less than two years ago and leads the Vocational project for the Artisan of the Year Award. He also serves in many other charitable organisations and statutory boards.

Rtn Suhaimi shared the significance of Hari Raya or Eid al-Fitr which are somewhat interchangeable. He started talk on the Islam as a faith with about 1 billion Muslims in the world and one of the 3 monotheistic faiths – Judaism, Christianity and Islam and gave historic similarities. He spoke briefly about Prophet Muhammad and the 5 Pillars of Islam. Rtn Suhaimi focussed his talk on Ramadan and fasting; Ramadan which is the 9<sup>th</sup> month of the Muslim calendar is known as the fasting month. He explained that it was a month of spiritual reflection, self-improvement and heightened devotion and worship and abstain from sinful speech and behaviour. He added that it teaches self-discipline, self-control, sacrifice and empathy for those who are less fortunate. He further explained the fasting rituals and prayers and the paying of “zakat” (obligatory alms). Rtn Suhaimi advised that Ramadan culminates in Eid al-Fitr (Hari Raya) which is a day of renewal and forgiveness. It is also a gathering of family and feasting and giving. He noted the cultural customs of celebrations such as dressings of Islamic religion and Malay custom. Rtn Suhaimi graciously answered questions posed to him from members and members also gave their comments and how the celebrations were conducted in other countries.

President Louis called on PP Dr Shahul Hameed who warmly extended the vote of thanks to Rtn Suhaimi for his talk and presentation. President Louis warmly all wished all Muslim members a “Selamat Hari Raya Aidilfitri”!

### GUEST SPEAKER: MR SAZZAD HOSSAIN

#### TOPIC: UNCONVENTIONAL WISDOM: ACCELERATING SOCIAL IMPACT

Director Rtn Louisa Lee was honoured to introduce the Speaker, Mr Sazzad Hossain, whom she added was logging in San Francisco, having to wake up at 4.00am in order to attend the meeting. She advised that she was introduced to Sazzad through previous speaker Mr Bjorn Low of Edible Garden as they were both Ashoka Fellows and when conceptualising the moringa trees project and wanted to have a community angle and that was how they were connected with Sazzad who does a great deal of work with the local migrant community and the Seeds of Friendship was created.

Sazzad is CEO of SDI Academy and SDI Global, he is also the CEO of DoorMart. Mr Hossain founded the Singapore-based social enterprise in 2013 to help the country's migrant workers overcome daily challenges by improving their English. He has since expanded its services to include computer skills, financial literacy and entrepreneurship.

Sazzad shared his inspiring story and experience in helping migrant workers during the pandemic, through food, essential distribution and the launch of an app to help them connect with each other, and the wider community. He also partnered with remittance groups to help migrants send \$1.2 million home during lockdown. He spoke of the problems faced by migrant workers in Singapore, having to pay exorbitant agency fees ranging from \$12,000 to \$15,000. He highlighted the social outreach programme for the migrant workers.

Sazzad shared how we could think in an unconventional way, using three examples of the Nigerian Prince scam; Van Halen and the brown M&Ms and Coca-Cola.

President Louis invited Rtn Suresh Hathiramani who warmly thanked Sazzad for his talk, adding that he had not for many years of Rotary seen a President not intervening and asking a speaker to cut short the presentation which speaks of Sazzad's compassion and work. Rtn Suresh noted the pinpoint silence from members which he added was in respect for what Sazzad was doing for the migrant workers.
