Foreword

Honorary Member Rtn Uttam Kripalani has been with Rotary for 43 years. He is a great achiever inside and outside Rotary. He is celebrating his 80th birthday on May 18, and HM Rtn Joseph Chia took this opportunity to interview him to share his interesting experiences with all of us. Below is a condensed version of the interview.

Dear HM Uttam, Congratulations on your 80th birthday, could you tell me what motivated you to come to Singapore in 1976 when at that time Singapore was a relatively unknown newly independent country in the Far East?

At an interview with the Chairman of National Insurance Co Ltd in India, I was offered an Assistant Manager posting in a small branch in Hong Kong. I politely declined, especially after being the youngest Senior Divisional Manager in India based in Tamil Nadu with 10 branches and about 100 employees. They then offered me an opportunity to revamp the company's operations in Singapore which I accepted as an exciting challenge after having been sent to survey the opportunities available in what I felt was a dynamic atmosphere created by PM Lee Kuan Yew and his team. My company was able to grow with Singapore.

You joined Rotary in Cochin India in 1971 and later in Singapore in 1983 and was a hundred- percenter all these years. We seldom hear of the term hundred-percenter these days, please explain what is a hundred-percenter and why did you do so?

When I joined Rotary, attendance was one of the important requirements of being a member. 60% was the minimum attendance requirement. In fact, membership could automatically be cancelled if three meetings in a row were missed. I always took the opportunity of attending the meetings or making them up at another club, The fellowship and the opportunity to work with other Rotarians became irresistible and I have great pleasure in maintaining my 100 Percent record even -----though it is not compulsory.

What was your most satisfying experience in Rotary?

The most satisfying experience has to be the airplane flight my committee organised for about 167 underprivileged children, who were brought from various homes. We took them on a one-hour flight in an aircraft sponsored by Qantas, with fuel paid for by one of the oil companies and landing rights and passport requirements waived by the airport authorities. I had the pleasure of working on this programme with PP Dr EE Peng Liang, who was the founder President of the Singapore Council of Social Service [now National Council of Social Service] and PP Raymon Huang.

Other than Rotary what were your other social work experiences in Singapore?

Other than Rotary I was involved in the setting up of the Crohn's and Colitis Society and continue to be one of the Advisors. As a Vice President of the Action Group for Mental Illness [AGMI] I helped in the inclusion of mental illness cover in the MediShield Insurance Policies. Though limited, it is one small step closer to the ideal coverage. As one of the earliest members of the Indian Activities Executive Committee [Siglap South CC], I have helped pioneer some cultural and social activities including the introduction of Music and Poetry. In the early period of my being in Singapore I was involved with acting in a few plays organised by the Stage Club.

One of the most recent activities I have undertaken is working with the MSF-Commlinks Befrienders' programme, along with PN Sonali and a group of Rotarians who will work to befriend some challenged families living in rented flats provided by the government. Niharika [spouse of Rtn Varun Gulati] and I will work with a family of four who are deaf and dumb. Both of us have decided to try and learn sign language to help us communicate with this challenged family.

Any other memorable Rotary events?

Amongst the many moments of pleasure I have derived from Rotary include getting the Rotarian of the Year Award [Rotary Year (RY) 2015/16], Arthur Thevathasan Award for introducing many new members [RY 2014/15], winning the best presenter award at one of the Four-Way test debates, being an emcee at several Presidents' Installations, and the honour of being an emcee at the dinner organised in honour of Rotary International President Shekhar Mehta.

But the biggest pleasure must be the many friendships I have forged with Rotarians, their families and friends.

You have been an avid golfer and I remember you achieved two Holes-in-one, which are relatively rare, please tell us more about them?

Yes, I have had the pleasure of getting two holes- in- one including one at the Delhi Golf Club where I got a holein-one on a par four [a rare Albatross]. Flukes do happen. I continue to play golf with a handicap of around 17-18, along with my interest in other sports such as Cricket, Soccer, Tennis and Squash. I have won nearly 50 trophies mainly for golf.

Your late wife Laxmi, your two children Gaurav and Mallika, I had the great pleasure of meeting all of them, could you share something about them?

My wife Laxmi passed away a few months back. She was an active supporter of our club and the Inner Wheel Club of Singapore. My son, Gaurav is the Artistic Director of the Singapore Repertory Theatre and my daughter, Mallika is a leadership facilitator and Executive Coach working with Potential Projects and Executive Coaching Consultancy both of which are headquartered in London. I have two grandchildren, Tara who recently completed her degree in Biochemistry from the University of Bristol and is working at an old folks' home and Akash, who is a student at the NUS School of Maths and Science and has represented Singapore in several International Maths Olympiads.


Toastmaster PP Stan Low called on members to join him in a toast to the Italian Republic coupled with the toast to Rotary International.

Distinguished Guest Speaker Series

Speaker: His Excellency (H E) Dante Brandi, Ambassador of Italy to Singapore

Topic: A soft response to hard times. The case for public diplomacy.

H E Ambassador Dante Brandi was introduced by fellow Italian, Rtn Francesco De Liva. The speech delivered by Ambassador Brandi, discussed the issue of polarization in the current global climate. Polarization is a major issue, with a battle of narratives and reduced capacity of influence for balanced players. However, there are remedies for polarization, including societal resilience, co-regulation of the digital space, support for independent journalism, and public diplomacy.

Public diplomacy is based on the principle of dialogue and aims to mobilize, influence, change, and attract. Emotion and storytelling are important aspects of public diplomacy, with a focus on values and contribution to the global public good. The presentation argues that the more people know about reliable players, the better their perception is. There is an unprecedented level of communication coordination among like-minded countries and an unprecedented level of acknowledgment and capacity to contrast hostile disinformation.


Public diplomacy is not propaganda, and truth is not enough. Storytelling and listening are important, and the best narrative is one that tells the world how you contribute to the global public good. Diplomats are seen as architects of choices. The future of diplomacy may involve the use of A.I. and neurosciences.

In the speech Ambassador Brandi also highlighted the importance of societal resilience in combating polarization. Co-regulation of the digital space is another remedy, as it can help to ensure that information is accurate and reliable. Support for independent journalism is also crucial, as it can provide a balanced perspective on events.

In conclusion, Ambassador Brandi offered a comprehensive overview of the issue of polarization and the remedies that can be used to combat it. Public diplomacy, with its focus on dialogue, emotion, and storytelling, is a key tool in this effort. By mobilizing, influencing, changing, and attracting, public diplomacy can help to build a more resilient and cohesive global community.
