In Focus

Rotary - Singapore Institute of Technology Mangrove Conservatory

Mankind's damage to the environment has been ongoing since the start of the industrial revolution. The environmental crisis gained widespread prominence in the late 1960s due to a convergence of factors such as revelatory books and publications like "Silent Spring", environmental disasters like the Santa Barbara oil spill and a growing movement with emergence of environmental protection advocacy groups.

"Supporting the Environment" became Rotary's seventh area of focus in June 2020. The Rotary Club of Singapore elected its first Director of Environment and Sustainability in Rotary Year 2021/22. Since then, environmental projects became a regular staple in our range of projects.

The Singapore Rotary International Convention 2024 provided a perfect platform to launch an impactful environmental project in Singapore. Through the Foundation of Rotary Clubs (Singapore) Ltd. (FRCS), an innovative project was curated with the Singapore Institute of Technology (SIT) to build a mangrove conservatory in the new SIT campus in Punggol. A signing ceremony was conducted on 23 May 2024 in the SIT Campus in Dover, witnessed by Ms Low Yen Ling, Senior Minister of State, Ministry of Community, Culture and Youth and Ministry of Trade and Industry.













Mangrove are important for coastal defence, storm and erosion protection, biodiversity refuge, and as a carbon sink with ten times the capacity of a rainforest of equal size. However, between 1820 and 2023, Singapore mangrove coverage has gone from 13% to 0.5% due mainly to reclamation and urban development. Several species have gone extinct in Singapore making mangrove less diverse and more vulnerable.

More importantly, with the rising sea level, mangrove is needed to protect our shorelines. We need to grow resilient mangroves to improve Singapore's climate adaptation.

The Rotary-SIT Mangrove Conservatory will have an outreach and education component providing public access to the mangrove with supporting educational material. The Conservatory will also conduct research to develop sea-level ready mangrove to protect Singapore's shores.



Tanks with controlled environment will test selected mangroves in future climate and evaluate which species is going to be better suited to protect Singapore's shoreline, sequester carbon and host a vibrant biodiverse environment. Current species as well as extinct and foreign species will be evaluated in these tanks.

The outcome of this research can be scaled and exported to other parts of the world where the coastal erosion is imminent. This will also reduce the construction of sea walls, providing a natural and sustainable resolution.

Rotary Club of Singapore is honoured to be appointed as the Project Lead by Rotary International Director Chew Ghim Bok. Over the next few years, we will work closely with all 23 Rotary Clubs in Singapore to raise \$680000 to bring this exciting project to fruition.



Distinguished Guest Speaker Series

Speaker: His Excellency (H E) Mr Jean-Dominique Ieraci, High Commissioner for Canada in Singapore

Topic: Pitch My Country

The honour of introducing HE Mr Ieraci fell to fellow Canadian, Rtn Hayden Hughes. HE Mr Ieraci has an illustrious diplomatic career, serving appointments in various countries such as Mexico, France, Syria (covering Cyprus and Jordan) and Korea. This is also H E Mr Ieraci's second tour in Singapore.

HE Mr leraci gave an insightful talk "pitching" the salient points of his country and its excellent relationship with Singapore. He shared several anecdotes including challenges such as visibility of his country, as citizens were quite humble in their presentations. His talk focused on business and technology, describing Canada as a nation of engineers. He advised that Canada is the 7th largest investor in Singapore and collaborates on ocean piracy, military-training and assist with cyber-attacks. He noted that Canada has the 3rd largest reserves of oil and gas, and understandably the 1st industry in Canada is energy. However, the 2nd industry was surprisingly automotive, followed basically by technology. H E Mr Ieraci also spoke on Canada's emerging economies such as artificial intelligence, nitrogen industry, robotics and small nuclear reactors. He also gave an investment prospective of the country, citing some of the investments received. H E Mr Ieraci highlighted the creative technology credited to Canada including its tourism and education sectors. He graciously took on questions posed to him by members.

President Siew Luen invited PP Stan Low to extend the Club's vote of thanks to HE Mr Ieraci. In doing so, PP Stan was also pleased to advised that H E Mr Ieraci had agreed to be an Honorary Member of the Club.


