Catalytic & Collaborative Philanthropy: Unlocking Innovation & Impact in Asia

What is the transformative role of catalytic philanthropy, underpinned by multi-sector partnerships? How does it unlock bold innovations to accelerate and scale positive environmental and social impact? Mr. Desmond Kuek will showcase Temasek Trust's approach and pathways to shaping a vibrant philanthropic landscape in Asia.

PP Stan Low:

On 21st August, our guest speaker, Mr Desmond Kuek, Executive Director and CEO of Temasek Trust, spoke eloquently to demystify where the Trust gets its funding, how the Trust is structured, and what it does with its funds. He also elaborated on its objectives, how these objectives are measured, and the Trust's mission to encourage Collaborative Philanthropy.

Mr Kuek laid out the complex external macrotrends that will exacerbate human challenges such as climate change, biodiversity losses, ageing demographics and the potential pitfalls of new technologies like generative AI. He also touched on the next pandemic, macroeconomic environment, geopolitics especially the increase of uncertainties in Asia and polarisation of the political landscape.

The landscape of philanthropy in Asia is shifting because of an ageing population from 8% in 2016 and forecasted to reach 18% by 2050. He noted a massive transfer of wealth in Asia from the old to the young, of which an estimated US\$2.5 trillion will go to the Millennials. Other shifts noted were the strategic philanthropic focus on impact, the blurring of the lines



growing desire for collaboration among donors.

Our speaker went on to tell us of his 4-Ps, the Planet, People, Peace, and Progress. He told us how Temasek Trust tries to balance their mission through its ecosystem pillars.

Looking ahead, Temasek Trust is forging it's Pathway to Philanthropy by focusing on investments with impact, developing platforms and convening partnerships for impact, and advocate evidence-based and outcomebased approaches. Other pathways will focus on capacity building to mobilise philanthropic resources, enabling innovations and solutions at scale, and to grow sustainable socio-economic enterprises.

CATALYTIC & COLLABORATIVE PHILANTHROPY: UNLOCKING INNOVATION & IMPACT IN ASIA

On 21st Aug 2024 at the weekly meeting of Rotary Club of Singapore, we were joined by Mr Desmond Kuek, CEO of Temasek Trust as the speaker for the evening. Mr Kuek captivated the audience with his stellar delivery and content sharing with us the philanthropic initiatives of Temasek Holdings driven through Temasek Trust. He took us through the compelling themes the Trust is focussing on in a fast changing and dynamic world that has a particular relevance to Singapore and Asia.

Based on the thesis and thinking of Temasek, the pressing issues that Singapore and wider Asia is faced with originates from five broad areas which in turn are the focal themes for Temasek Trust to work towards philanthropy and impact. They are (i) Climate Change (ii) Biodiversity Loss (iii) Aging Demographics (iv) Disease X (Next unknown virus to attack our world) and (v) Geopolitics and Global bifurcation. In addition to these, other pressing areas involve effects of new technologies, macroeconomic environment, and polarization of political landscape.

Mr Kuek also spoke about the shifting landscape of philanthropy in Asia. In Asia we are witnessing a renewed focus on Social and Environmental impact. Extreme weather events are almost double in Asia compared to rest of the world and also the effects of a fast-aging population. Asia is to witness a massive transfer of wealth and millennials are placing even more emphasis on gauging the impact driven by data. Asia is also witnessing ingenuity in sustainable and philanthropic finance with new creative models emerging. We are also witnessing enhanced collaboration of donors across sectors who wish to 'touch and feel' the end-results. investment firm incorporated in 1974. Temasek is a generational investor, seeking to make a difference always with tomorrow in mind. The investment horizon is long term and the firm invest off their balance sheet and is not constrained by 'fund life' and the investments are predominantly in equities. They do not hold targets for investing by asset class, country, sector, or single name and investment activities are guided by their view of long-term structural trends. The firm aspire to help every Singaporean generation thrive by empowering the well-being of the firm's people, portfolio companies, partners, communities, and the planet they share as a common home. The firm see the responsibility to fulfill their role not just for today's, but also for future generations.

The speech was followed by Q&As which further covered focal areas of Philanthropy on how the firm measured impact which Mr Kuek articulated as a complex process. This section also covered points on demanding reputation from partners and emphasized on the quality of the giving process. PP Stan gave the vote of thanks, stressing again on the 4 Ps that were highlighted by Mr Kuek in the new world of Philanthropy and Giving — Planet, People, Peace, and Progress. This meeting was chaired by DGE Shahul as President Tom was traveling and Dr Shahul too expressed his sincere gratitude towards the speaker on behalf of the Club. . It was a well received speech and Mr Desmond Kuek spent quality time interacting with members and guests after the meeting. From his conversation with HM Mr Mohan Vaswani, Mr Kuek was delighted to listen about the philanthropic works done by Ishk-Tolaram foundation and projects carried out along with Rotary.

Mr Kuek also spoke about their innovative philosophy around 'pay-for-success' and supporting commerce and entrepreneurship to serve humanity.

It serves well to be aware of the background of Temasek Holdings. 
