## CONSTITUTION

## Standard Rotary Club Constitution

- Articles 1-21 reflect the Standard Rotary Club Constitution (SRCC)
- With the omission by Rotary District 9600 (D9600) of SRCC article 17 Rotary Magazines, and substituting 75\% in lieu of two thirds in Article 21 Section 2
- Articles 22-24 added by D9600
- Articles 25-26 added by our drafting (RCC)


## Standard Rotary Club Constitution (Cont'd)

- The club is given real options via Articles 7 \& 9 affecting:
- Article 8 s. 1 : Meeting timing and format
- (min twice a month)
- Article 12 : Attendance
- Article 15 S. 4 : Termination for non-attendance
- Article 10 s.2, 4-8 : Kinds of membership
- Options previously considered and advised January 2018


## Standard Rotary Club Constitution (Cont'd)

- Correction to Article 2
- Article 2 Name
- The name of this organization shall be Rotary Club of Caloundra Inc. (Member of Rotary International)
- (a) The name of a satellite of this club (when applicable) shall be Rotary Satellite Club of Caloundra (A satellite of Rotary Club of Caloundra Inc.)


## REGULATIONS

- Regulations essentially drafted by D9600
- A number of modifications included in our drafting

## Attendance

- Expectation (Art.5(2))
- Attend 2 meetings of this club or Satellite Club (SC)
- Participate in Board \& Committees
- 1 service project a quarter
- Termination (Art.9)
- Must attend 10 meetings of club or SC (or make-up) each half-year
- Must participate in 1 service project each half-year
- If not, a member may be asked to show cause why membership should not be terminated


## Attendance (Cont'd)

- Termination (Art.9) (Cont'd)
- Unless leave approved or excused by Board, a member must attend 6 consecutive meetings
- If not, shall be deemed a request to terminate membership
- Subject to 10 days' notice and an opportunity to respond
- Right of Appeal - Const. 15 s(6)


## Excused Absences

## Excused Absences

- Apply for Leave
- Leave may be granted for good \& sufficient reasons Art.6(2) \& Const. 12(3a):
- for up to 12 months
- Renewable if for medical reasons, or for childbirth, adoption or foster care
- Given the ability to meet attendance obligations in a flexible manner (including the ability to apply for leave), the drafting by D9600 \& this club repeals the Rule of 85 .


## Board composition

- 6 officers :
- President, Immediate Past-president, Presidentelect, Vice-president, Secretary, Treasurer
- 10 other Directors + Satellite Club Chair
- Roles determined by Committee Structure


## Satellite Club

## - Essentially:

- Members of SC are members of this club
- Members of this club or SC may attend meetings/projects of either
- Bank account as stipulated by this club
- SC Chair a director of this club and reports to the Board
- Establishment
- Needs
- clear need and viability established
- approval by members of this club
- a minimum of 8 members, and probably more


## Other changes

## Regulations

- Reflect our previous advice except for:
- The percentages - Article 2 Kinds of Membership
- Increase in Corporate Members per Corporate Article 3 Membership Rights \& Privileges
- Eligibility for Corporate Membership now covers entities with a local place of business
- Budgets for this club and a Satellite Club now a planning tool and control mechanism - not the limit of expenditures
- Proposed new members advise to members


## Proposed Special Resolution

The Constitution and Bylaws of ROTARY CLUB OF CALOUNDRA INC. be amended by sulbstituting the constitution and regulations at Attachment $A$ for the existing constitution and Bylaws.
