PNW Passport Club Board Meeting August 10, 2020

P-Roy: Welcomed everyone to the Board Meeting.

P-Roy: Asked if there were any questions regarding old business.

Seeing none he'd like a motion to accept the August 6, 2020 minutes as

presented.

P-E Deb: motioned to accept the minutes of August 6, 2020 as present.

P-Roy: 2nd PASSED

P-Roy: asked Treasurer Terry for his report.

T-Terry: We have 42 members on the books plus 2 honourary members.

T-Terry: asked to have the American PO Box for Rotary explained.

P-E Deb: explained that the Club needed one to work with SCRIPs but we no longer

We were informed that there would be a cost to the Club for any member who orders hard cards instead of e-cards. There would be a shipping cost of \$8.00 for each envelope sent to us. It was hoped that most members would choose the e-cards.

Discussion: It was thought that once a month those who wish to have hard cards give their request to P-E Deb. She would send in the order, receive the order, distribute the order.

Member Yvonne Gallardo-Van Ornam may be willing to help with the program.

Member Lornell Ridley might be willing to help get a similar Canadian programme up and running.

T-Terry: stated the Club needs to make a commitment to the no golf fundraiser this

year due to COVID.

Discussion: Board members thought we need to stress to our membership that this was a RI Foundation fundraiser and please send in their money. It was decided this would be done at our meetings in September, and in the

Roundup.

P-Roy: said that we almost have the grant for the Green Bag Project we need a

separate US bank account and a mailing address for the funds to be sent to.

P-E Deb: stated that was being done.

T-Terry: also stated he was working on the bank account.

P-Roy: brought up the subject of Club insurance. Canadian insurance does not cover

our American members. Our American members are not insured by Rotary International for liability. Yet, they were being charged by RI for insurance.

P-E Deb: motioned that we appoint Treasurer Terry Greer to ask District 5050 to refund

the liability insurance that has been paid by 17 US members.

P-E Deb: motioned to accept the Financial Report as presented.

P-Roy - 2nd PASSED

New Business:

P-Roy: asked Club secretary Joy about more policy & procedures to be put into

place.

Sec Joy: Now that our Club is putting into place a manual for the Club to be passed along to future executive members we need to set into place how we sign off on emails, letters, thank yous, etc. We are sending letters, etc on behalf of the Club not ourselves. We should all be putting our name & title at the end of the letter, email or thank you, etc. If the conversation continues with a person then it would be okay to use only our name & no title. On a card we can always add a more personal note on the side or back of the card.
