Special Meeting: Notice of Special Motion

Background:

In January 2020, District 5050 was notified that the Canadian insurance policy would not cover US PNVV Passport Rotary Club Members. After several months discovery, discussion, and deliberation by the club board, it has been determined that the best option for the club is to request a club charter domicile reassignment within the Rotary International database. From Rotary International staff: If the Club's domicile is a US Club – then all the members of the Club would be covered by the RI US insurance policy regardless of where the members reside. This means that all members in Canada would be covered under the RI policy.

To make this request to RI the club is required to hold a special meeting to vote on the motion. A 2/3rds majority of the members <u>present</u> at the meeting is required to carry the motion.

The Special Motion:

Move to change the club domicile name in Rotary International Records from <u>Pacific Northwest</u> <u>Passport D5050(British Columbia, Canada)</u> to <u>Pacific Northwest Passport D5050(Washington</u> <u>State, USA)</u> to ensure that all club members have liability insurance coverage.

Additional Information:

President Roy will be requesting a new club charter document. Of interest our research indicates that all other cross-border Passport Rotary Clubs are charter domiciled in the US. There is an expectation that the club will remain incorporated as a British Columbia Society at this time. It is possible the club will also incorporate in Washington State depending on further direction from counsel and/or Rotary International.

This change will not affect the Canadian members access to the Canadian Rotary magazine.

There is a time sensitivity to this issue due to the Rotary International annual dues notices going out to the clubs on July I, 2021 that will need to include the insurance premiums for all the club members.

The dues structure for the club will remain the same this year as we are not having to pay the Canadian premium which was about \$650/yr. 2021-22 dues for the club are expected by 6/29/2021 and an invoice will be coming out within the next day or two.

In addition, the board will be available to provide additional background information about the proposed motion at the club meeting 6/12/21 @ 4pm. (Zoom link is on Clubrunner)
