# Leo's Membership Page

#### A ROTARY RECRUITING MODEL

#### Aim

Outline a 5 Step Recruiting Model that doubles membership and fosters perpetual membership growth.

#### **Assumptions**

- Recruiting new members is a priority
- At best, 10% of club members will recruit new members
- We each know 2000 people, some will make great Rotarians
- We have the ability to reach all ideal candidates in our community

#### **Step 1 - Cap Membership**

- Ask each club member to write down the ideal size for the Rotary Club
- The Secretary determines the average number and reports the results
- The number is the cap for the next couple of years
- This exercise results in a clear goal

#### Step 2 - Assemble a SWAT TEAM

Assemble a crack recruiting team to recruit one new member each within 45 days

#### Step 3 - Develop a Master Prospect List

- Team members write down their 20 best prospects
- Team members meet to collate a master prospect list
- Duplicate names and classification issues are sorted out
- The prospect list is presented to all Club members and approved

#### Step 4 - Sift for Rotary Interest

- Each team member calls their prospects and sifts for interest
- Prospects are mailed a brochure and referred to the Club or Rotary web site
- Those who show an interest are invited to a free Rotary meeting
- This Rotary meeting is a special event with a good speaker and a great program
- Follow up with a knowledgeable Rotarian to speak to the prospect about Rotary membership
- Induct new members with fanfare

On February 23, 2005, Rotary International, will celebrate its 100th anniversary. The Royal City Rotary Club and the New Westminster Rotary Club are joining forces in a community project to celebrate this impressive landmark by contributing \$100,000 to the enhancement of the Crosstown Greenway which runs through New Westminster and connects Coquitlam, Burnaby and Vancouver.



Greenways are multi-use paths and designated walking and cycling routes that are enhanced by landscaping features, traffic calming devices, and pedestrian and cycling priority measures. The Crosstown Bikeway/Greenway, which provides opportunities for recreation and facilitates bicycle and pedestrian travel across the City, connects parks, schools, shopping areas and SkyTrain stations. 

# 5040 ROTARY SPIRIT

Pursuant to the District 5040 Policy the following Resolutions to amend the District Policy are sent to you for comment and consideration at the District Conference in Williams Lake on May 15th, 2004.

#### Resolution #1

Proposed by PDG Leo Nimsick to insure that an appropriate PDG pin and gift are available for presentation at the District Conference.

Proposed Resolution #1

To amend the District Policy by adding a new section G: Recognition *Whereas* it has been a tradition in District 5040 that an appropriate Past District Governor pin and an appropriate gift (example - plaque) be presented to the District Governor at the District Conference.

Whereas there has never been a set procedure to accomplish this tradition. It is resolved that the District provide an appropriate Past District Governor pin and a suitable gift recognizing the District Governor for leadership and dedication to the District and to Rotary International. The District Governor Elect in consultation with the District Secretary will have the pin and gift available for presentation at the District Conference.

#### Resolution #2

Proposed by DG Mary Watson to allow the DGE to select which International Convention the District will give financial assistance for attendance and to insure that financial assistance is available for the Zone 22 Institute and such other multi District meetings as may be called.

Proposed Resolution 2

To amend the District Policy section 6 (c) & (d)

Whereas the District provides financial assistance to ensure that the District Governor attends an International Convention:

And whereas the District provides financial assistance to ensure the District Governor, District Governor Elect and District Governor Nominee attends multi-district meetings:

It is resolved that (c) the District provides financial assistance not to exceed \$7000.00 to ensure the District Governor's attendance at an International Convention either in his/her year as Governor or in the year that he/she is District Governor Elect as an option.

It is resolved that (d) the District provide financial assistance to ensure the attendance of the District Governor, District Governor Elect and District Governor Nominee at the Zone 22 Institute and at such multi district meetings as may be called from time to time.

#### Resolution #4

Proposed by PDG Del Paterson to bring the District Policy up date with the RI Leadership Plan.

Proposed Resolution #4

Whereas the Nominating Committee has been made of the three immediate Past District Governors and whereas Rotary International has recommended that the Committee be expanded to include other Rotarians. It is resolved that Section C (1) be amended as follows:

"C (1) The Nominating Committee shall be made up of the last 3 District Governors and two Assistant Governors who are members of clubs in District 5040. The Assistant Governor members will be appointed by the District Governor Elect on or before the 1st of July and will be members of the committee for one year only unless reappointed by the following District Governor Elect."

# District Policy Amendments

#### Resolution #3

Proposed by PDG Chris Offer to bring the District Policy in line with RI Policy regarding abuse and privacy issues.

Proposed Resolution #3

#### A - Recommended New District Abuse Policy

1. Whereas in November 2002, the RI Board adopted the following policy statement:

"Rotary International is committed to creating and maintaining the safest possible environment for all participants in Rotary activities. It is the duty of all Rotarians, Rotarians' spouses, partners, and other volunteers to safeguard to the best of their ability the welfare of and to prevent the physical, sexual, or emotional abuse of children and young people with whom they come into contact."

- 2. Whereas it is incumbent on Rotary District 5040 to protect all children and adults involved in all programs affiliated with Rotary District 5040,
- 3. Whereas the number of civil cases involving various types of abuse are on the increase.
- 4. Whereas it is incumbent on Rotary District 5040 to demonstrate due diligence in the protection of all children and adults involved in district activities,

Be it resolved that Rotary District 5040 amend the district policy by adding a new section "G" that states:

"G. Rotary International District 5040 is committed to creating and maintaining the safest possible environment for all participants in Rotary activities. It is the duty of all Rotarians, Rotarians' spouses, partners, and other volunteers to safeguard to the best of their ability the welfare of and to prevent the physical, sexual, or emotional abuse of children, young people and adults with whom they come into contact."

# B - Recommended New District Protection of Privacy Policy

- 1. Whereas on January 1, 2004, new federal privacy laws came into effect.
- 2. Whereas this new law does apply to Rotary District 5040 if personal information collected by the district is sold or bartered,
- 3. Whereas it is incumbent on Rotary District 5040 to protect private information collected by the district,

Be it resolved that Section F(1) of the district police be amended by adding a new section (c) and (d) that state: "(c) Rotary International District 5040 respects the privacy of personal information collected from Rotarians and other individuals. No personal information will be released to any person or organization other than for the use of the administration of Rotary International and District 5040 without the written consent of the individual. Personal information shall be retained only as long as necessary.

(d) The District Secretary, under the direction of the District Governor is designated as responsible for compliance with this policy. Requests for release of information shall be directed to the District Secretary."

# District Governor's Notes...

# DISTRICT GOVERNOR'S AWARD Deadline: APRIL 15th

Recognizing that the strength of the Rotary movement is founded on the service carried out by club members, the purpose of this award will be to provide a means for Rotary Clubs in District 5040 to personally recognize a member of the club for his/her outstanding efforts in service to the club and/or community (local and world).

**Eligible Nominees**: Candidate for nomination should be Rotarians in good standing in their clubs who have consistently demonstrated their support of the Object of Rotary through participation in a variety of service activities.

**Selection Process:** The nomination of a candidate to receive this award will be made by the club. The method of selection will be determined by the club. The club president must endorse the nomination and submit it to the District Governor.

**Requirements:** A fee of \$300 Canadian is to accompany the nomination. This fee will be accumulated in a special fund to be used for a project or projects at the discretion of the District Governor. The Current Plan for the monies in the Special Fund is a Centennial Project.

A special pin and certificate will be available for presentation to the recipient. This award is to allow clubs to honour members for exemplary service and is separate and apart from the Paul Harris Fellowship which is a recognition for a US\$1,000 contribution to the Rotary Foundation.
