



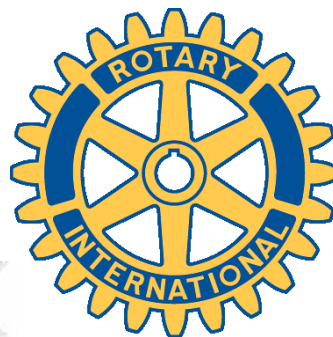

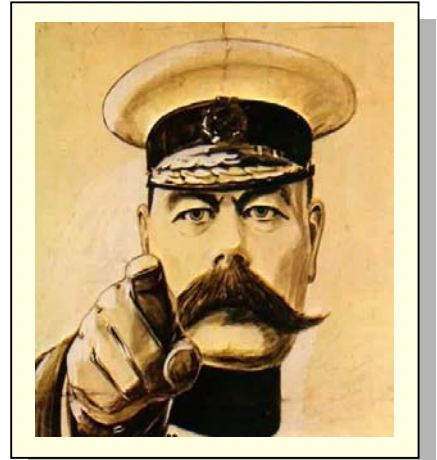
Since July 1st 2003 we have brought in 68 new members. Retention is a bigger problem as we have lost 72. Please don't write these people off since they may come back at a later date.

## Vancouver's "Rotary International Plaza"

**On December 1, 2003, Governor Mary Watson and Dr. Martha Piper, President of the University of BC dedicated "Rotary International Plaza" at the university by unveiling a commemorative stone. RI President Bhichai Rattakul and Past District Governor Del Paterson officially opened the plaza on May 1, 2003.**

Dr. Piper stated that in recognition of Rotary International's contribution to international education worldwide and to honour the long-standing connection between local Rotarians and the University, the University Board of Governors agreed to name the area in front of the International House, "Rotary International Plaza." She praised Rotary's support for international education and thanked local Rotarians.

International House was opened in 1955 as a Rotary Jubilee project to celebrate Rotary's 50th year. Eleanor Roosevelt opened International House. The house was funded by the Rotary clubs of Vancouver and Vancouver South (formerly RC of Marpole). International House demonstrates the longevity of a Rotary project and the importance of Rotary Centennial projects. How many Rotary Centennial projects will have the impact of International House and still influence in the community in 2055 when Rotary celebrates 150 years?

Rotary International Plaza is the focal point of the University's new International precinct. A variety of international schools and programs offer courses in this area of the campus. The Plaza has five flagpoles, one with the Rotary flag, terraces and landscaped open space. The plaza will be the official space for receiving foreign dignitaries who visit UBC, as well as a visual statement of the University's commitment to international education.

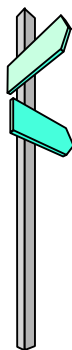
Throughout the years Rotarians have participated actively in the programs and activities organized by International House which is a home away from home for thousands of International students and scholars. Rotarians serve on the Board of Directors of International House. International House involved as a unique social and cultural centre for international cultural learning.



The University of BC has up to fifteen **Rotary Foundation Ambassadorial Scholars** as students each year. For almost 50 years, students from International House have participated in a unique program with Rotarians from the RC of Vancouver South and Rotary clubs in Penticton.

Each year 25 students are driven 300 km from Vancouver to Penticton by Rotarians through some of the most spectacular scenery in the world. The students then are home hosted by Penticton Rotarians. The students take a variety of tours, wineries being very popular and experience Canadian culture and Rotary fellowship.

The complete qualifications for being District Governor are published on page 23 of the RI Manual of Procedure (2001) and are listed in Article 15.070 of the RI Bylaws on page 234. Also available at:

[www.rotary.org](http://www.rotary.org)

- Regular membership in good standing in a Rotary Club in District 5040;
- Nominated by a resolution of a Rotary Club in District 5040;
- Club must be in good standing;
- Past president of a club for a full term;
- Willingness and ability, both physically and otherwise, to fulfill the duties;
- Must have completed seven or more years in Rotary;
- Attend the International Assembly upon taking office;
- Have business or professional work organized in such a manner that the time needed to carry out the duties is available;
- Have a thorough knowledge and be able to discuss any phase of Rotary in a convincing and articulate manner.

#### **Additional desirable qualifications:**

- Good computer skills with knowledge of e-mail systems, internet, spreadsheets and word processing;
- Demonstrated management and leadership skills;
- Good public speaking skills;
- Financial management skills.

## Frequently Asked Questions about becoming a District Governor

### Q: What is the time commitment?

**A:** District 5040 has appointed Assistant Governors as part of RI district leadership plan. The result has been a lightening of time demands on the Governor. However, because of the number of clubs and the geographic size of District 5040, a considerable amount of time still is required. Depending on personal management styles, these requirements will vary greatly.

### Q: What are the financial obligations?

**A:** RI and District 5040 compensate the Governor for expenses associated with the position. While there will be some out-of-pocket expenses, they are not excessive.

### Q: What is the role of my spouse or partner?

**A:** The partner of a Governor has had varied roles in past years and this is dictated solely by the individual's preference. Some partners have preferred to adopt a strictly social aspect while others have been full, active participants in carrying out the duties of the position. Training programs include partners, whether that person is a Rotarian or not, and partners are expected to attend and participate in all training programs.

### Q: What training is available?

**A:** Training starts with the DGN who attends the Blue Denim Seminar and PETS. The DGE attends PETS, Blue Denim, the International Assembly and Governor Elects Training at the Zone Institute. There are also manuals, work books and other training materials supplied by RI.

### Q: Does a Governor have to be retired?

**A:** No, the Governor does not have to be retired. However, a flexible work schedule is essential with significant blocks of time off to visit clubs and attend training seminars. The commitment is for two full years (DGE and DG year).

Candidates who would consider maintaining their current vocational activities during their term as Governor should realize that they will likely require a significant reorganization of their vocational activities.

## Additional Information:

Rotarians considering submitting their application may wish to discuss the role of the District Governor with members of the Nominating Committee or other recent Past District Governors. Considerable information is also available on the RI web site [www.rotary.org](http://www.rotary.org). Rotarians who may wish to consider submitting their application for future years are encouraged to contact the committee members and discuss how they can prepare themselves in the meantime.
