What are "Foundation Recognition Points." How do I

earn these points and what are they good for? After you have contributed \$1,000 to the Annual Programs Fund, Polio Plus or a TRF approved Global Grant, you will receive your first Paul Harris Fellow, and you will then begin earning one Foundation Recognition Point (FRP) for each additional dollar you contribute to those same three programs. You can use



your points to assist someone else in becoming a Paul Harris Fellow and you receive multiple PHF recognition. <u>read more</u>

How to transfer membership to a new club. Relocating Rotarians are encouraged to seek out clubs in their new location. Because each Rotary club is self-governing, however, membership isn't really transferable. Once you've been accepted for membership in a new club, you should resign your membership in your former club as of



the admittance date to your new club. Be sure to use your former membership number so your membership history is retained. If you're moving more than 20 miles away and will no longer be a member of your current Rotary club, you can either complete the <u>Rotarian Relocation Form</u> or ask your club secretary to submit the <u>Membership Referral Form</u> on your behalf. Read about membership provisions for special leaves of absence in Article 12, Section 2(a)(1) of the <u>Standard Rotary Club Constitution</u>.

End of Year Foundation Donations - The Rotary Foundation receives nearly 50% of all donations in the last 2 months of the Rotary year. If your club is holding donations from a special Foundation event, club happy bucks or individual Rotarians and plans to make a donation this Rotary year - don't wait for the end of the month. Donations must be received by June 30, 2011 to be credited to the club's goal for this Rotary year. The simple way for personal donations is to donate online at <u>www.TRFCanada.org</u>. Clubs and Rotarians can also use the global donation form and mail a cheque to the Toronto PO box <u>download the form</u>.
