4. Consists of Major Gifts & Bequests of US\$10,000 or more and PHS x 10 year commitments
5. Consists of new donations

# 3 Types of Gifts to support a Million Dollar Dinner

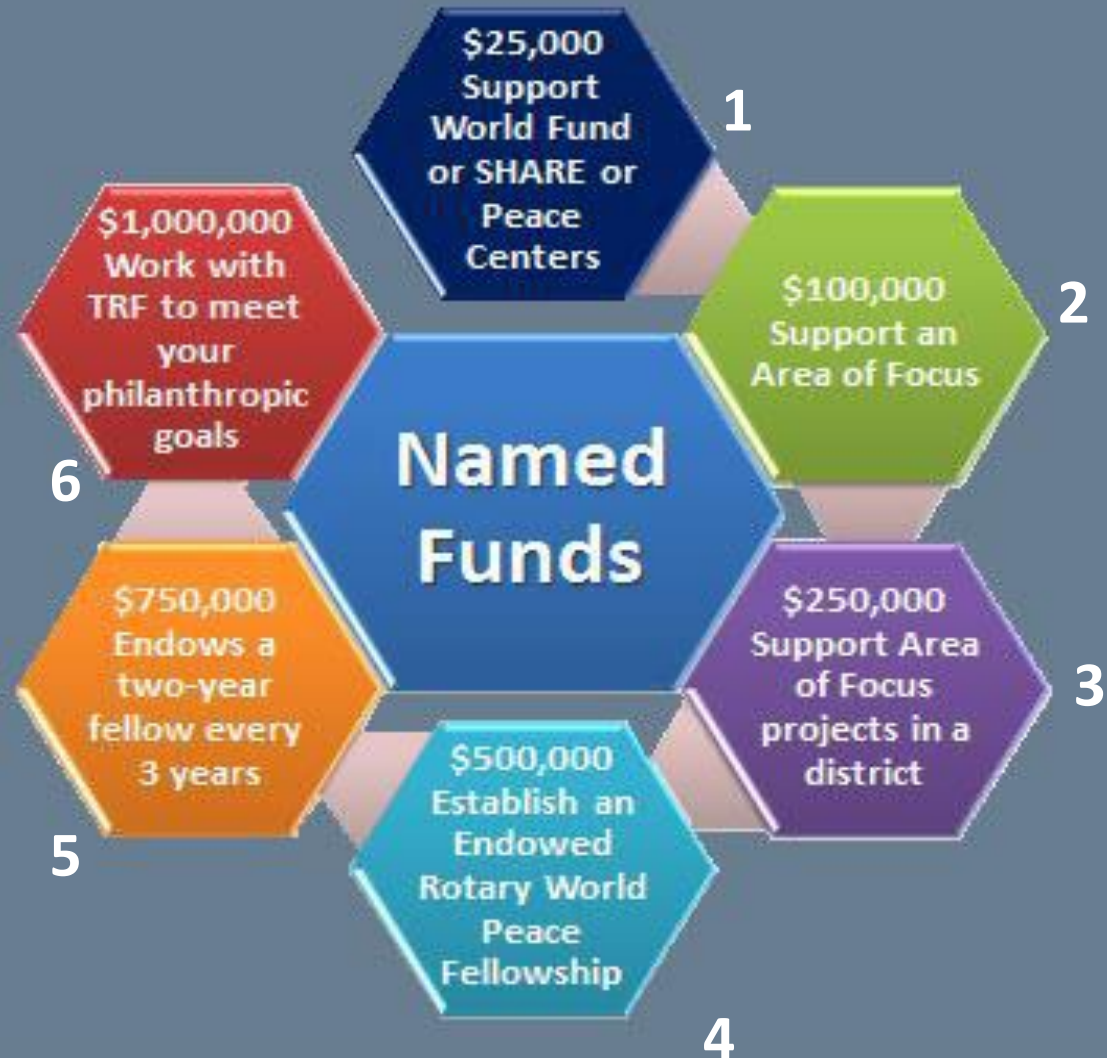
1. Cash\*/stock gifts of US\$10,000 or more\*\*
