1. What is the purpose of this project? Provide a brief description.

The purpose of the grant is to provide funds to purchase a used 18 foot long sail training boat. The boat is needed for sail instruction and sail experience for youth, youth groups and at risk youth. The Duluth Superior Sailing Association currently provide week long sailing classes to nearly 150 persons each summer, of which about 2/3 are youth and youth at risk. Sailing experience outreach serves 500 to 700 youth each summer.

2. How will it meet the needs of the community

Having this additional boat will allow DSSA to further their outreach into the community and teach a sustainable life sport at low or no cost depending on ability to pay. This program helps develop self esteem, self reliance and teaches teamwork skills. Youth regularly describe this program as the highlight of their summer. Most of those attending these classes have no other access to the water. This program is done in a safe and structured manner.

A final inspection of the boat will be made after the purchase and the Rotary Emblem will be a fixed to the boat.

Res Letter of participation

Dear members of Rotary 25,

The Duluth Superior Sailing Association (DSSA) is a SO1 (c) 3 non-profit incorporated in 1995. Our organization was originally formed in 1979 as the Twin Ports Youth Sailing Association to teach kids the art and joys of sailing. We are an affiliated organization of the Duluth Boat Club, which was incorporated as a similar non-profit in 2002 to support and create a home for the various non -motorized boating organizations in the Twin Ports of Duluth and Superior.

We operate our on-the-water program during the summer months from a dock in the Duluth Park Point Recreation area. Our fleet numbers about 30 sailboats and two motorized chase boats ranging from 8' to 31' in length. We taught more than 100 persons how to sail in week-long classes in 2011. About 2/3 of these were youth from 8 to 18. The balance of our students and members were college age to adult. All lead instructors are U. 5. Sailing Certified.

Our program includes sailing experiences for physically disabled persons in conjunction with Courage Duluth. This program has suffered in the past four seasons due to the shallow water at our dock that prevents most of our larger boats, which are used in the disabled program, from getting into the dock in order to lift the participants on board.

Our program also provided single day sailing experiences to about 150 other youth from various organizations, including the YMCA and Northland Children's' Home. Youth are able to join for only \$10 per season, which provides them with unlimited supervised open sailing opportunities seven days per week throughout the summer.

Sailing classes are provided for a fee to those who can afford to pay. However, we provide scholarships for any youth or youth groups who are unable to pay the class fees. Our boats are either received as donations or are purchased through gifts, grants and fund raisers. The balance of the operating cost of our program is supported by generous personal gifts and grants from organizations in the recent past such as the Canadian National Railroad, the Duluth Yacht Club, the Young Athlete's Fund, The Duluth Adjusters Club, Boy Scout Eagle projects, the Duluth Boat Club and West Marine.

Youth learn a fully sustainable life sport. They learn boating safety and how to safely navigate a pleasure craft in one of the busiest commercial harbors in the nation. They acquire teamwork skills and develop a sense of personal responsibility. They grow with the self confidence that can only come from learning how to master control over the wind and elements. Sailing is a wonderful cooperative past time for groups and families. Many families participate in our programs, and come out for Wednesday family nights, open sailing and Thursday night races in our 13' Laser class boats.

The interlake class sailboat that will be purchased with the generous support of a grant from Rotary 25 will be used by groups, disabled participants and families. It will be able to come freely into our sheltered dock due it's shallow draft.

Members of our program generously assist in the running of the Superior Dragon Boat Festival each year, a project of the Superior and Harbor Town Rotaries. They assist the Duluth Boat Club in running the races, manning the safety/emergency boats and the starting line operations. Two members of Rotary 25 have been instrumental in our success. Jack Soetebier has been a tireless supporter for several years and has helped raise over \$4000 for boat repairs and equipment, through a DSSA fund started by participants in the Trans-Superior yacht race that we named the Soetebier- Pierpont fund. Also, Rebecca Butler is currently our Treasurer.
