**Project Description**

1. Briefly describe the project. What was done, when and where did project activities take place, and who were the beneficiaries? We were part of a \$317,000+ project to modernize Fergus Falls' public school facilities for training our high school students in manufacturing processes. Specifically, the industrial art facilities at Kennedy Secondary School in Fergus Falls were upgraded and Rotary's funds helped to purchase a much needed second vertical mill. Beneficiaries of the project are the students of Fergus Falls Independent School District 544 and prospective employers of those students when they graduate.

2. How many Rotarians participated in the project? 8+

3. What did they do? Please give at least two examples. Eight Rotarians from the two clubs in Fergus Falls served on the 19-member Task Force that raised over \$317,000 for the overall project. Rotarians also assisted in moving items out of the metal shop so its lighting and electrical supply could be updated and the room painted before new machines arrived.

4. How many non-Rotarians benefited from this project? Approximately 30 students a year are expected to be trained on the device.

5. What are the expected long-term community impacts of the project? The Modern Manufacturing Learning Lab is now teaching the work skills of computer numeric controlled (CNC) machines, creativity, innovation and accuracy – skills that are in demand by many employers in our area. The goal is to help our students by the next generation of eager, passionate, successful workers and business owners.

6. If a cooperating organization was involved, what was its role? Not applicable.


