**Explanation**: Matching grants support the humanitarian service projects of Rotary Clubs and Districts. The proposed project is a hand-dug well in Dembia District, Amahara Region, Ethiopia. The well will be created at the Abowerum Health Center, one of the 9 health centers within the district. This particular health center has no reliable water source at this time. The well will be available for both the health center and surrounding communities, so it is expected to improve both sanitation at the health center as well as improve the lives of many people who live in the area.

The project will be implemented through the help of the Dembia District Water Department and with the oversight of the Health Department in the District. A local NGO in Gondar, 'WOGEN', will facilitated the well-digging process and the training and monitoring of the well after it is complete. Wogen has experience digging wells in other locations. The director of WOGEN is Hibste Mekonnen, a Rotarian of the Gondar Fasiledes Rotary Club, who is leading this project. Already, other Rotarians have been involved in the project, for example, the head of the Public Health Institute at the University of Gondar, Dr. Sisay, facilitated the welcome letter process by working with the Health Office of Dembia District.

Rotarians from the Gondar Fasiledes Rotary Club will visit the site during well-creation and will help WOGEN to train the community committee that will take over responsibility for the well. Rotarians will follow-up in the months after the well has been created to ensure that the well committee is working properly, that the Water Department is monitoring the chlorine levels of the well, etc.

Rotarians in District 5580 will be involved in the project by keeping in contact with Gondar Fasiledes Rotary Club, particularly during the community training phase. Sharing experiences could be particularly valuable for Gondar Fasiledes Rotary Club and WOGEN in creating training plans for the community committee.

The Abowerum Health Center is government-owned. It is overseen by the Dembia District Administrative Office, under the leadership of the North Gondar Zone administration, and under the law and requirements of the Amhara Regional State Health Bureau. Ultimately, the Federal Ministry of Health (FMOH) governs all health activities in Ethiopia and the land is owned by the Ethiopian national government. Please see the welcome letters from both the Water, Irrigation, and Energy Development Office (hereafter 'Water Department') and Health Office of Dembia Woreda \*'woreda' means 'district'.

Construction of the well will take approximately three weeks. Construction will begin immediately after receiving funds, to try to complete the well prior to the heavy rainy season of June-August. Training of the community committee will occur as soon as the project is completed.

Describe how the benefiting community will maintain this structure or project (financing of maintenance, etc.) after grant funding has been fully expended and who will be responsible for sustainability of the structure.

The Water Department and Abowerum Health Center will both be responsible for caring for the well. The Water Department will monitor the well regularly, measuring levels of chlorination and observing that the well does not have structural problems. However, a community committee will be identified by Rotarians, Wogen, the Kebele, and the Head of Health center to take community responsibility for the well. The committee is trained during a one-day training session, in which they learn about well care and make a plan for monitoring and following up on any issues that could arise with the well.

Describe specific activities of the Host and International Partners in implementing the project.

Host Rotarians will facilitate the entire project. As mentioned above, the project primary contact is Rotarian Hibste Mekonnen who will work directly with the Water Department and Health Center at all points of the project. Host Rotarians will be in contact with the Water Department, Health Office, and Health Center to facilitate the process. Host Rotarians will visit the site, work with the Kebele and Head of the Health Center to select community committee members to work on the project, train the community committee to oversee the well, and will continue close follow-up with the Water Department, Health Center/Health Office, and community committee in the year after the well construction. After one year, Rotarians will intermittently follow-up in the coming few years.

What will the Rotarians who are members of the partner clubs do during the project? Please note that financial support is not considered active involvement. (Refer to *Matching Grant Application Instructions* for suggestions.)

As mentioned above, Rotarians will provide oversight of all aspects of the project. So far, this has already included spending one day to meet with the Health Office and the Water Department in Kolladiba town, as well as spending time working with Global Grant Scholar Alicia Helion to translate Amharic materials, develop a complete budget, and multiple calls to the Health Center and Water Department to ensure smooth submission of this application. After this, Rotarians will oversee the well construction, including purchasing supplies and bringing them to the Abowerum Health Center, directly viewing the site during construction, and training community members after the well is constructed. Further, the Rotary Club will be responsible for checking on the well in the coming months and years. The Rotary Club will be responsible for collecting receipts for all items and writing reports on well progress.




Dembia Woreda Map



ABOWERUM HEALTH CENTER is located in Kebele 19 in the above map. You can see the red dot on the map where Abowerum Health Center is located.



We will contribute financially and through sweat equity in this project. We have used and will continue to use our Wogen organization car for supervising the site and facilitating the processes.




