The Latin America Rotary Aid (LARA) project of Rotary Clubs in District 5580 has collaborated with the Rotary Club of Santa Barbara, Honduras for twenty years on a wide range of projects addressing the health, social, and educational needs of communities in the Department of Santa Barbara, a 5,000 km<sup>2</sup> area in the rural northwestern mountains of Honduras. The City of Santa Barbara, with a population of only 15,000, is the largest municipality in the department and is the primary service center for the department of 400,000 people, most of whom live in small mountain villages. The Rotary Club of Santa Barbara is a full partner with LARA, and the club members provide a key role in identifying critical needs, working side-by-side in LARA projects, and assuring the success of each project. The Rotary Clubs of Ashland, Wisconsin and Santa Barbara, Honduras have much in common, in spite of differences in climate and social wellbeing, because both clubs consist of professionals committed to the quality of life in a largely rural region. While the Ashland Rotary Club has provided support for the Honduras program for several years, the club has never before requested Rotary District funds for this program. The club has not received any district grants.

To address the massive unemployment of 24% of its working age population, Honduras has promoted the establishment of maquiladoras, mostly foreign-owned garment factories, as a path out of poverty. The factories are attracting unemployed workers from villages to areas surrounding the maquilas. This has been the case with a T-shirt factory on the outskirts of the City of Santa Barbara. Families with young children are moving into the Colonia Brisas del Pinal, a neighborhood near the factory. The local elementary school has become overwhelmed with the influx of children. A key to the long-term success of the young families in this neighborhood is a positive, healthy introduction to primary school for children and a reliable, stimulating, and safe environment for children of parents who are eager to hold a steady job in the local factory.

The national education system in Honduras does not provide adequate support for its schools. Rather, since 2008, the City of Santa Barbara has rented two small rooms in a private home where two teachers attempt to educate sixty children in kindergarten and pre-kindergarten. The school provides lunches for the children but lacks a kitchen for food preparation. Bathroom space in the rented house is so limited that children have to go home when they need to use the bathroom.

Neighborhood parents requested assistance from the City of Santa Barbara and the Santa Barbara Rotary Club to construct a two-room kindergarten adjacent to the existing elementary school. City staff prepared detailed construction drawings and cost estimates for the materials. The proposed kindergarten is not extravagant. Each room is 6 x 8 meters, with a masonry foundation, concrete block walls, brick floors, and a metal roof. Each room has built-in bookshelves and a blackboard. Included in the project is a kitchen to assure that children receive safe, nutritious meals and bathrooms connected to the city's sanitation system.

# Describe the project and the need it will address, including the intended beneficiaries and how the project will benefit the community in need.

Honduras is one of the poorest countries in the Western Hemisphere. A common sight along the roadsides throughout the country are families in thatch huts with no sanitation and young children working to raise a meager living rather than attending school. The influx of families to Colonia Brisas del Pinal near the T-shirt factory in Santa Barbara has the potential to become either another slum or a stable neighborhood. Support for working parents, especially young mothers, by serving the educational and care needs of their young children during the work week, is a key need that local residents identified for developing a stable neighborhood. The provision of a kindergarten is a small -- but critical -- step toward assuring improved family development and a path for children into education, rather than a life on the streets. The city's current rental of kindergarten space is a stop-gap measure that can neither assure consistent supervision and education nor appropriate sanitation and nutrition. The outcomes of providing a decent kindergarten in this neighborhood will be:

- 1. An improved start in school attendance for children;
- 2. A more stable family environment for working mothers who will experience fewer conflicts between child care and employment; and
- Families with steadier incomes in the neighborhood as a result of improved educational and social services to children of working parents faced with fewer stresses outside of work.

#### Provide the estimated length of time needed to complete the project.

Construction is planned for January - April 2013 during the dry season. The City and the Santa Barbara Rotary Club will oversee site preparation and excavation in January. Ashland and other District 5580 Rotarians will participate with the local community in major construction activities during February. The City and Santa Barbara Rotary will complete electrical and sanitary connections in March and April.

# Describe how the benefiting community will maintain this structure or project (financing of maintenance, etc.) after grant funding has been fully expended and who will be responsible for sustainability of the structure.

The director of the school, neighborhood residents, and the neighborhood development trust are committed to sound maintenance of the kindergarten, just as they currently provide for the elementary school building and grounds.

#### Describe specific activities of the Host and International Partners in implementing the project.

The Santa Barbara and District 5580 Rotarians in LARA include several professional builders who have managed construction projects similar to this in previous years. They contribute tools and provide the supervision necessary to engage U.S. and Honduran Rotarians alongside neighborhood parents and teachers in the construction project. The City of Santa Barbara's engineering and public works staff also will assist the team of Rotarians and local residents in the project.
