### Rotary Celebrates 105th Anniversary

During the first Rotary club meeting on 23 February 1905 in Chicago, Paul Harris, Gustavus Loehr, Hiram Shorey, and Silvester Schiele met to talk about their personal experiences. Harris then unfolded his general plan for their club meetings. This was the simple beginning of the world's first service club, the Rotary Club of Chicago. It was created because of Harris' wish to capture in a professional club the same friendly spirit he had felt in the small towns of his youth. The Rotary name derived from the early practice of rotating meetings among members' offices.

The Rotary Club of Chicago has big plans for celebrating Rotary's anniversary on 23 February 2010 this year. As the first club established by Rotary founder Paul Harris, the Chicago club will be marking its 105th anniversary at the same time Rotary marks 25 years of work to eradicate polio. The Chicago Club, Rotary International and Districts 6440 and 6450 have joined forces to light up the Wrigley Building in downtown Chicago with the End Polio Now logo on 23 February to celebrate Rotary's polio eradication efforts. Plans are in the works to project End Polio Now onto the sides of several other well-known landmarks on the anniversary day. Last year, the image illuminated a section of the House of Commons in London, the Colosseum in Rome, the Sydney Opera House in Australia, and a number of landmarks in Scotland.

Every club and district is encouraged to use the anniversary of the first Rotary club meeting, designated as World Understanding and *Peace Day, to share the story of Rotary's local and global contributions.* 

### Kansas City, Missouri Rotary Club Celebrates 100th Anniversary



The Kansas City, Missouri Club ("Club 13") will celebrate its 100th Anniversary May 20, 2010 at Union Station in Kansas City. And all Rotary clubs in our District are invited to join in the Celebration. The Celebration will begin at noon and will feature a Parade of Clubs, with a representative from each Club attending taking part. Rotary President John Kenny, from Scotland, pictured to the right, will be the keynote speaker, and immediately after lunch there will be a commemorative group photo taken, with President Kenny, in front of the historic Union Station.



Of special interest to Rotarians in our District is that many of our clubs grew out of Club 13. That Club was chartered in 1910 and it chartered the Topeka (Downtown) Club in 1914. The Topeka Club then sponsored seven clubs and those seven clubs sponsored fourteen more clubs, as listed on the left side of the District Tree (*see page 3 of this newsletter*). In 1916 Club 13 sponsored the Kansas City, Kansas Cub. The Kansas City, Kansas Club sponsored three clubs and those three clubs sponsored fourteen more clubs in **our District as listed on the right side of the "District Tree**. *So 38 clubs in District 5710 descended directly from Club 13, as shown in "date chartered" order on the District Tree on page 3.* To see how the clubs of the Kansas portion of Club 13 descended, <u>CLICK HERE</u>. ### Membership Development-Lighting the Fire

Last month we discussed the first two steps in the membership development process. The first was to get a good handle on your club's membership situation going back a few years. The second was to improve your club such that business or professional persons will want to join immediately. While you are probably still tackling those steps, let's investigate step three – Lighting the Fire.

As you were doing steps one and two, presumably the club's leadership team came on board in wholehearted support of improving membership development. Now the club's leaders need to ignite that sense of urgency with the membership at large. Remember, when it comes to recruiting, informing, and retaining new Rotarians, your club will be much more successful if the effort is supported by everyone and not just the current officers. How does the club leadership light the fire?

Perhaps the first move is to review the membership situation with the members, perhaps at a club assembly. Go over membership numbers for the past several years, new members as well as terminations. Did your



investigation discern any trends in why good people departed the club? Address average age and diversity in the club – be frank. Discuss the possibility that the goodness of Rotary may be lessened [or disappear] in the community if trends aren't reversed. Then review with your members the findings from the "Healthy Club Checklist" and "Look in the Mirror." Tie these in to your efforts to improve the club. Let me suggest that these two reviews be presented by club officers other than the president. Club members need to see two things: that the club needs to address membership and that the club leaders are all behind this effort. At this point, a few members not among the club's leadership team may be offering suggestions. This is healthy. However, you are not quite at the point where best to implement new ideas. These people who stepped forward may be exactly the folks to populate your Membership Committee.

Membership Committee? Yup! If you don't have one, put one together now. Some of the club leadership team may be on this committee but it will be best to ensure that the rank and file members who want to work membership issues are put to work here. You need buy-in from the membership in order to succeed. The immediate goal of the membership committee is to review how the club currently does business. Specifically:

- How does the club identify potential members?
- How does the club approach them?
- How does the club help them make a good decision to join or not?
- What is the paperwork flow to get them signed up?
- Finally, how does the club get the new member involved immediately?

Do these suggestions fly in the face of how you currently work membership development? Let me just say: "If you always do what you always did, you will pretty much get what you always got." Time to change how you think about membership development!

### Rotary World Peace Fellowships

All Rotary Clubs in District 5710 are encouraged to recruit and nominate candidates for Rotary World Peace Fellowships. Unlike Rotary Ambassadorial Scholarships, which are normally awarded to college-age students, a Rotary Peace Fellow applicant must already have a college and substantial experience with peace and/or conflict resolution. Members in every club in our district know individuals involved in international charitable endeavors, law enforcement, social work, or other careers related to conflict resolution who might be potential Rotary Peace Fellows.

The fellowships are for study at one of the six Rotary Centers for International Studies in peace and conflict resolution to obtain a master's degree in international relations, peace studies, conflict resolution, and related areas, or a professional development certificate in peace in conflict studies. The Rotary Centers have been established by The Rotary Foundation in partnership with prestigious universities throughout the world.

During their studies, Rotary World Peace Fellows work to advance knowledge of issues related to peace, causes of conflict, and world understanding. The fellows participate in Rotary Center seminars and commit to careers related to international relations, peace, and conflict resolution. Rotary World Peace Fellowships are for up to two academic years and provide funding for round-trip transportation, tuition and fees, room, board, and other limited expenses. The certificate program is for three months.

Rotary District 5701 has had two winners of these highly-competitive fellowships in the last three years. David Kozar is completing his master's degree at Queensland University in Australia. Summer Lewis is scheduled to begin her fellowship at Queensland University later this year. Both Kozar and Lewis are from Manhattan and are alumni of Kansas State University.

The six Rotary Centers for International Studies involve the following seven university partners:

- Chulalongkorn University, Bangkok, Thailand (certificate program)
- Duke University and the University of North Carolina, USA (joint center)
- International Christian University, Tokyo, Japan
- Universidad del Salvador, Buenos Aires, Argentina
- University of Bradford. West Yorkshire, England
- University of Queensland, Brisbane, Queensland, Australia






### News from the Leavenworth Rotary Club
