

Raffle Rules and Disclosure Statements

1. The raffle for Rotary 5810 ("Rotary 5810") begins on July 1, 2014 and ends on December 31, 2014 ("Raffle Period"). The Raffle is conducted by Rotary International District 5810, 3736 Interlaken Dr., Plano, TX 75075. The Official Rules of the Raffle are set forth herein. By entering the Raffle, Participants agree to be fully and unconditionally bound by these Official Rules, waive any right to claim ambiguity in the Raffle or these Official Rules, and further agree to be bound by Rotary 5810's decisions and interpretation of these Official Rules.
2. Void where prohibited by law.
3. Eligibility. The Raffle is open to all persons age 18 and older.
4. Each ticket will cost \$100.00 for one entry. More than one person may share in the raffle ticket purchase. Prizes will not be issued to anyone other than the Entrant(s) whose name is on the ticket stub.
5. A person or entity may purchase a maximum of 10 tickets. 1,500 tickets will be sold.
6. Each numbered Raffle ticket stub will be placed in the Raffle ticket container.
7. Online: Tickets may be purchased via our secure electronic commerce server at www.rotary5810.org.
8. By Mail: Download the Official Raffle entry form ("Ticket Stub") and complete legibly at www.rotary5810.org all information requested on the Entry Form, including the number of Tickets you would like to purchase, and enclose payment for one hundred (\$100.00) for each entry. During the Raffle Period, mail the completed form and payment to: Rotary International District 5810, 3736 Interlaken Dr., Plano, TX 75075 or call 214-552-1509 and receive your requested purchased Ticket Stub via email and/or U.S. regular mail.
9. By Telephone: 214-552-1509 and provide the information requested by the operator to order Tickets.
10. Phone and on-line entries with payment must be received no later than December 31, 2014.
11. Mailed - in Entry Form(s) and payment(s) must be postmarked no later than December 24, 2014 and must be received by Rotary 5810 no later than 7 days later. All mailed entries received after December 31, 2014 will be returned to the person mailing the entry and not entered in the drawing.
12. All entries must include payment by check, cashier's check, money order, or credit card. For credit card purchases, the Entrants must provide the full name, billing address and telephone number of the cardholder and the credit card number, expiration date, and three - digit personal security code. All credit card purchases will be charged a processing fee of \$3.00 per transaction.
13. Once an Entrant's order is processed, Rotary 5810 will email or mail via U.S. postal carrier a receipt (ticket stub) which will include a Ticket number(s) to the name and

address provided on the Entry Form or to the operator. All final transactions will be processed in the United States.

14. Rotary 5810 will be responsible for maintaining control and security of all of the Raffle ticket stubs. An individual not connected to Rotary will draw the winning tickets at the place and time designated. Such individual shall, by public certification under oath at the time of the drawing, certify that all Raffle tickets purchased have their stub in the container of stubs where the winning Raffle ticket will be drawn.
15. The public drawing will be on December 31, 2015 and will be official after the committee has determined that all eligibility requirements have been met.
16. Drawing Location. Will be held in a public place determined by the District Governor of Rotary 5810.
17. Drawing Times: Will be at 3:00 p.m. You may attend the drawing. Please plan to arrive at approximately one hour prior to the drawing time.
18. You need not be present to win.
19. The winner will be notified by phone on January 2, 2015.

21. Notification. Prize Winner will be notified by Phone, U.S. Mail and Email. If the Prize Winner cannot be located within fifteen (15) calendar days after the drawing, the winner will be deemed to have forfeited his/her prize and another winner will be selected for the Grand Prize. The Winner will be posted approximately 48 hours after the final drawing and may be obtained by visiting www.rotary5810.org.

Winner grants permission for the use of their names, photographs/likenesses for advertising and promotion for this and similar promotions without compensation, unless prohibited by law.

 25. The Raffle is subject to all applicable federal, state, and local laws and regulations, and is void wherever prohibited or restricted by law.
 26. In the event that the raffle is cancelled because of insufficient ticket sales, Rotary 5810 reserves all rights to refund all monies.

27. If the Raffle is cancelled because of insufficient ticket sales, refund to the purchaser of a ticket will be made as stated below.
28. Purchaser(s) will be refunded the price of the chance automatically upon cancellation of the raffle. Refunds will be by check for tickets purchased by check or cash to the address of the purchaser listed on the ticket stub. For purchases made by credit card, the refund will be a credit back to the credit card of the cardholder purchasing the tickets.
29. Proceeds from the Raffle will benefit The Rotary Foundation and its ongoing charitable purposes. Contributions to The Rotary Foundation will be in the name of Rotarians purchasing tickets. The amount credited to each Rotarians account will be determined by dividing the total contributed by the number of tickets purchased by Rotarians. The maximum credit to a Rotarians account shall be the total amount paid for tickets purchased.

These Official Rules shall not be changed by any oral statement made by any employee or other person acting on behalf of Rotary 5810 By participating, Entrants agree: (i) to be bound by these complete Official Rules and the decisions of Rotary 5810 which shall be final and binding; and (ii) to waive any right to claim ambiguity in the Raffle or these Official Rules, except where prohibited by law. By accepting a Prize, Winner agrees to release Rotary 5810, its officers, directors, employees, representatives and agents, and any person or entity associated with the production, judging, or administration of the Raffle (collectively, the " Releases ") from and against any claims, damages, disability, attorneys' fees, and costs of litigation and settlement, as well as any liability due to any injuries, damages or losses to any person (including death) or property of any kind

resulting in whole or in part, directly or indirectly, from redemption, acceptance, possession, ownership, misuse or use of any prize or participation in any Raffle - related activity or participation in this Raffle.
