Grant Criteria:

- Applicant Rotary Club must be:
 - located within District 5890;
 - current on its District and Rotary International dues;
 - current in its Rotary Foundation reporting requirements.
- The project must be:
 - held within the jurisdictional confines of Rotary District 5890;
 - actual project specifically addressing Hurricane Beryl relief.
- Grant application must be signed by the Rotary Club President.
- A Rotarian (may be the President) must be listed who will provide oversight and management of the project funds for the entire duration of the project receiving the funding.
- The Rotary Club must provide some sort of funding for the project.
- Partnering with other Rotary Clubs within or outside our District is encouraged, but not required.
- Cannot be used for overhead or operational costs of another non-profit organization.
- Must be used in their entirety solely on the project for which the application was approved.
- Maximum grant amount is \$2,000.00 per Club. Clubs may do a joint project and each Club may receive \$2,000.00
