There was some discussion as to the necessity of locating a licensed vendor who would have access to the current branding colors and images. It was determined that any vendor can enter Rotary Brand Center and acquire logos and PMP colors to produce a banner for us.

2018 - 2019 Budget

Tom reported that he was working on his budget. There are several unknowns that Tom needs input from the district and the board to help clarify numbers.

The positions that the District shall reimburse for the 2017 Zone are: District Governor, District Governor Elect, District Governor Nominee, Foundation Chair, Membership Chair, Public Image Chair, District Trainer, and two (2) Future Leaders.
