The award is named for Boone Rotarian and Past District Governor (1954-55), Judge Paul E. Hellwege, who passed away in 2010, and is established to promote the ideals of ethics and integrity, which were Paul’s fervent passions.

The awards will be presented annually to Rotarians who have been a member of a club in District 6000 for a minimum of three years and who exemplify the attributes and passion for ethics and integrity in their vocational, business and personal lives that Paul exemplified.

This awards recognize individuals who have made outstanding contributions that foster the development of integrity. The awards single out persons who have made contributions in business, media, academia or government and who have, by their actions, writing, policies and public pronouncements, strengthened and fostered development of integrity and ethical practices. Special consideration should be given to members who have made sacrifices and/or undertaken risks to uphold Rotary’s Core Value of Integrity. There may be only one nomination per club per year. Those who are nominated will be recognized at the annual District Conference.
