# 2017 District 6440 District Awards Criteria



## Club Service Award

A Club Service Award will be given in each tier for the best overall demonstrated achievement. Club Service/Club Administration focuses on internal club administration. A club should submit the following:

- A club officer succession plan showing officers as well as Board Executives, how the club conducts the election of the slate of officers and timeliness of election.
- Up to date club By-Laws and a plan or schedule to regularly revise when necessary.
- Up to date club strategic plan and plan or schedule to regularly revise when necessary.
- Basic knowledge of Rotary History. Samples could include: A Rotary History moment at club meetings, a review of an article in the Rotarian Magazine; knowledge of Rotary impact in the world – such as where we stand on polio eradication, etc.
- A sample of club calendar of speakers.
- Name of Club member(s) - who attend to matters for the “Family of Rotary”, i.e. Condolence cards, get well cards, birthday cards, etc.; calls to member who haven’t been attending.
- Sample of New Member Induction and Orientation programs.
- Name of Chair who assists with the planning and execution of New Member Orientation sessions and examples of same.
- Secretary fulfills duties of attendance, ClubRunner/MyRotary updates such as adding new members, terminating members and updating club officers, taking and submitting Board minutes.
- Sample calendar of club socials/holiday celebrations/charter night celebrations, etc. arranged by the Club Service Chair.
- Good track record of the Club paying District and RI dues on time.
- Up to date reporting of goals, achievements and reports on Club Central

Review committee will also consider ease of review, completeness of documentation and professional presentation.

## Vocational Service Award

A Vocational Service award will be given in each tier for the best overall demonstrated achievement(s). The awards will be based on the following:

- Discussion vocations and taking time to learn about other vocations in the community
- Using the club's professional skills to serve a community need
- Members practicing their profession with integrity and inspiring others to behave ethically through their actions
- Helping young people achieve career aspirations
- Guiding others in their professional development

An award will be made for the best overall demonstration of Vocational Service in each tier. This award will be based on the following:

- Host classification talks
- Tour member's workplaces
- Establish a service project using your member's vocational expertise
- Display/promote 4-way test and rotary code of conduct in regular meeting
- Offer vocational talents of club to provide opportunities for young people to learn and explore different vocations– i.e. mock interviews, career day activities, etc.
- Advance ethics – offer an essay for interact clubs or other groups “What 4-way test means to me”
- Commit to community responsibility
  - Target club philanthropy to issues related to club goals per project
  - Volunteer service through club sponsored projects per project
- Other vocational activities per additional activity

The vocational service award will be presented to the club that best demonstrates vocational service through a written narrative outlining each project documented by photographs, news releases, club bulletins, Facebook or other available media outlets.

Review committee will also consider ease of review, completeness of documentation and professional presentation.

## Community Service Award

A Community Service Award will be given in each tier for the best overall demonstrated achievement(s). The awards will be based on the following:

### Club Projects:

A club may include more than one community project in their application

- Submit a one page summary for EACH club project.
- Describe the planning process and the significant impact on the community.
  - The project was well planned and had a significant impact on the community for the nature and impact of the project.
  - The project was new to the club or a continuation from a prior year.
- How many of your club members were involved with the project?
- Did the Club perform a needs assessment? If so, describe the process that was used.
- What picture(s) of the project were submitted and was a press release sent to the local paper or a District Rotary publication? Included copies of what was submitted and what was published.
- Is the project entered completely and marked as “Achieved” in Club Central?

### Other Community Service:

- Did the club make cash contributions that exceed \$100 per member of the submitting club, to local community projects or organizations that are involve one of Rotary’s six areas of focus? List the projects or organizations and the relevant area of focus. for every \$100 per member contributed
- Did the club organize or participate in an awareness event or a fundraising initiative, in the community, to support polio eradication?
- Did the club participate in a District event, including the District Conference, in which the Club prepared an Exhibit or display that described one of its community projects?
- Did your club submit a qualified application for a local community District Grant?

- Public affairs to include news releases, D6440 and club articles. photographs

- Useful (working) links and home page up to date
- Link to District site

**To be eligible, the club must submit its web address to the committee.**

- Describe a club project that includes a summary, the planning process (if any) the impact it had on the community and how many of your club members were involved with the project. What pictures of the project were submitted and was a press release sent to the local paper, sponsoring club or District. Include copies of what was submitted and what was published.
- Did the club organize or participate in an awareness event or a fundraising initiative, in the community, to raise awareness/ educate or support polio eradication?
- Did the club participate in a Rotary Club or District event, including the District Conference, in which Interact members prepared an Exhibit or display that described one of its community projects?
- Club activities not in scope of the above, but to be considered:  
Description of youth activities initiated by/with a Rotary club focused on youth such as a literacy reading program; holiday or special charitable or "fun" activity; a club funded scholarship(s); etc.

Description of Interact club participation such as student attendance at Rotary meetings; reciprocal attendance at Interact club by Rotarians, Interact and Rotarian involvement in joint activities; student and club faculty sponsor recognition; news articles and photos; providing Rotary information.

Review committee will also consider ease of review, completeness of documentation and professional presentation.

## ROTARIAN SPOUSE/PARTNER SERVICE AWARD

### PURPOSE

An individual may receive the award only once. It's not possible to nominate one's own spouse or partner for the award. Nominations must be typed and are limited to one nomination per club per year
