WHAT IS THE DIFFERENCE BETWEEN A PAUL HARRIS FELLOW AND PAUL HARRIS SOCIETY MEMBER?

Anyone who cumulatively contributes US\$1,000 during any time period becomes a Paul Harris Fellow. A person can also be named a fellow if someone else uses 1,000 Foundation recognition points to honor them as such. A member of the Paul Harris Society contributes at least US\$1,000 each year to the Annual Fund, PolioPlus Fund, or approved Foundation grants.

AM I REQUIRED TO GIVE US\$1,000 BEFORE JOINING THE PAUL HARRIS SOCIETY?

No, an immediate US\$1,000 contribution is not required at the time of enrollment. How you fulfill your Paul Harris Society giving intention each year is up to you. You can donate US\$1,000 at one time or in several smaller amounts that reach that total. One easy way is to donate automatically through the Rotary Direct recurring giving program. HOW DID THE ROTARY FOUNDATION GET STARTED?

The Foundation began after Rotary's sixth president, Arch Klumph, suggested in 1917 that Rotary should have an endowment fund "for the purpose of doing good in the world."

Starting from an initial contribution of US\$26.50 from the Rotary Club of Kansas City, Missouri, USA, the Foundation has received more than \$6.1 billion in total contributions.

The Foundation made a grant of \$500 to an organization supporting children with special needs in 1930 and continues to do good around the world in Rotary's name.

WHAT DID ARCH KLUMPH SAY ABOUT THE FOUNDATION'S IMPACT?

"The Rotary Foundation is not to build monuments of brick and stone. If we work upon marble, it will perish; if we work on brass, time will efface it; if we rear temples, they will crumble into dust; but if we work upon immortal minds, if we imbue them with the full meaning of the spirit of Rotary ... we are engraving on those tablets something that will brighten all eternity."

WHAT IS THE ROTARY FOUNDATION CADRE OF TECHNICAL ADVISERS?

The Cadre of Technical Advisers is a group of Rotary members who offer their expertise and advice to clubs and districts that are planning and carrying out grant projects around the world. They also strengthen the impact of Rotary's grants by safeguarding Foundation funds.

Cadre members provide guidance about conducting community assessments, incorporating sustainability, setting up monitoring or evaluation plans, and properly managing the financial aspects of a project.

More than 550 Cadre members who speak more than 80 languages come from 75 countries. You can connect with Cadre members who have expertise in a specific area of focus or in a particular language, country, or district.

CLUB GRANTS

How to qualify today in order to receive funds for projects in 2025 2026:

Receive up to \$2,000USD of matching funds for small scale, short term projects, either locally or globally by: Club Dues must be in good standing

Enter Goals for Foundation and Polio, and Foundation Chair in myRotary

A minimum of 2 ACTIVE members completes any online Foundation module, which can be found on the RI website>log into "myrotary">knowledge and resources>learning center>Foundation.

Module must not be one that has already been completed and must have a certification date later than July 1,

GLOBAL GRANTS

To be eligible to sign the Club MOU for Global Grants, and participate in global grants, including cluster funding, VTT (vocational training team), as a host, or as an international partner, and for a club to receive financial matching funds from the district (host club or international partner only), a club is required to qualify by:

Club dues must be in good standing

Enter Rotary Foundation and Polio goals, and active Foundation Chair assigned into My Rotary Have a minimum of 2 ACTIVE members complete the online module, with at least an 80% score. Completion certificates must be submitted to: lezliemurch@gmail.com

The Rotary Foundation helps Rotary members to advance world understanding, goodwill, and peace by improving health, providing quality education, improving the environment, and alleviating poverty.

Any Club in district 7090 can contribute to a global grant and receive matching funds from District 7090 up to a total of \$10,000, if the project is outside of D7090. If the project is within D7090 a club can receive up to \$15,000 of matching funds. Then the World Fund provides an 80% match to any district funds. For example, if your club provides \$1,000, D7090 provides \$1,000 and the World Fund provides \$800, for a total of \$2,800.

Endowment Ideas for Canadians

Your donation options... Here are the most common methods to make a substantial charitable gift.

Cash donations. Tax receipts for donations that total over \$200 provide a combined federal and provincial tax credit of at least 40% of the donation amount (varies by province).

Investments. When donating securities, including stocks, bonds and mutual funds, the donor receives a tax receipt for the investment's fair market value. Neither the donor nor the charity pays tax on capital gains.

- **Donor-advised funds.** Designed as a long-term program, donations are invested and grow on a tax- deferred basis. The donor periodically gives grants to charities of their choice.
- **Bequests in a will.** It's possible to state the donation as a specified amount, a percentage of the estate or the remaining assets after providing for other beneficiaries.

Registered plans. When a charity is the beneficiary of an RRSP or RRIF, the donation tax credit can offset the tax payable by the estate on the RRSP's or RRIF's assets. If a charity is named as the beneficiary of a Tax-Free Savings Account (TFSA), the tax credit can help offset taxes payable by the estate.

Life insurance. Donating the proceeds of a new or existing life insurance policy can provide tax relief either to the donor during their lifetime or to their estate.

Charitable gift annuities. One portion of the donor's amount is a donation for which the donor receives a tax receipt, while another portion provides the donor with a tax-advantaged income stream for life.

ENDOWMENT FUND

- Contributions are professionally invested in perpetuity
- Only the earnings are spent to supplement Foundation activities

There have been many themes over the years in Rotary, the first one that comes to mind is Building Communities, Bridging Continents with many great themes to follow like Make a Difference, Be an Insiration, Serve to Change Lives, Imagine, Create Hope in the Word and of course our newest theme The Magic of Rotary. What do all these themes have in common? They describe attributes that Rotarians process and then make happen by creating positive change in the World.

The Magic of Rotary is not The Rotary Foundation it is Rotarians that make the Magic happen!

The Rotary Foundation only supplies the toolbox that provide the tools that allow Rotarians to apply the Magic to create meaningful change in Communities that will be successful and sustainable.

The Rotary Foundation toolbox consists of programs and grants which are fully funded by donations from Rotarians and Friends of Rotary and allows Rotarians to spin their magic. Donors understand that each gift or bequest makes you part of the eradication of Polio, a partner in creating Peace, a person who supports clean water and sanitation where water's worth is measured in lives. It makes you someone who believes that all babies, children and mom's should have good medical resources, micro-credit and equal rights. You are a person that is fighting AIDS, Polio, Malaria and other diseases.

Help and make sure that this Magic continues in perpetuity by making a bequest or a gift to the Endowment Fund.

One of the tools available is our D7090 Best of Friends Heritage Endowment Fund (E20602) which was established to pay tribute to Rotarians who have made a meaningful impact in our District and Clubs. Contributions are invested in perpetuity and investment earnings are used to provide a permanent source of funding that support our District's programs.

You can create a legacy for yourself or significant others through the Heritage Fund or think about creating your own through a bequest or gift.

Creating your own Named Fund establishes your Rotary legacy. Our Endowment Committee can walk you through the process and explain all options available to you

Can a business or organization become a Paul Harris Fellow?

No. Only individuals can become Paul Harris Fellows. However, businesses and organizations can receive a **Certificate of Appreciation** for contributions of \$1,000 or more, or transfers of 1,000 points or more.

Can a deceased person become a Paul Harris Fellow?

Yes. A donor can recognize a deceased individual by requesting a Memorial Paul Harris Fellow designation
