

District 7090 Annual General Business Meeting Minutes Monday, December 4, 2023

Number of Attendees: 47

Call to Order: 7:03 PM EDT by District Governor Scott Macin welcoming all members.

Assistant Governor Tommy Gerbasi raised a point of order seeking to confirm who and what constitutes a quorum? Club presidents or their designee comprise the voting members of each club. The total number of votes as tabulated by the count of the membership is 104. A quorum is defined as two thirds of the total number of votes. Therefore, 69 votes constitute a quorum.

Presentation of the Audited Financial Statements 20202-2023: John Teibert, Treasurer, Financial Report Overview. John explained the purpose and scope of the audit performed by Lumsden & McCormick CPAs LLP. He also gave an overview of the Financial Statements and the Management Letter.

District Governor Scott Marcin discussed the State of the District with respect to membership and the status of clubs. The total number of members is 1892 an increase of 31 for the year. The total number of Rotaractors is 69. The district membership goal is 2000. Currently, there are 67 clubs in District 7090. Scott acknowledged the time and tenure of Pene Hutton who retired earlier this year. In his remarks, District Governor Scott Marcin also recognized the creation of the Rotary District 7090 *Endowment Fund with Rotary International* and extended his appreciation for the leadership team and their support.
