Full DG Report attached. The key lesson learned from club visits: EVERY Rotary Club in District 7090 shares two things in common:

- Absolute irreverence toward each other. None of us takes ourselves too seriously and I didn't meet ONE "holier-than-thou" individual in all of the visits. They/we ALL have a lot of fun in Rotary. As PDG Rob Leek said in his Club Visit speeches years ago, "Rotary is far too important to take it (and ourselves) too seriously". To a woman and man, District 7090 people agree.
- While the individual projects may vary, EVERY club is dedicated to serving their community. A need is identified, and Rotarians do something about it. I am amazed by the number of local and international projects individual clubs engage.

Training:

- Advancing selection process for DGN with aim of announcing DGNN for 2017-18 by Jan 2015
- Plans are underway to combine AG training, PETs and Club Director, Committee and Rotarian at large training next April and May. Two days of training will be offered –one on each side of border. (April 11 in St. Catharines and May 2 in Niagara Falls)
- PETS schedule changes this year. PETS 1 will be after PETS 2. We are again participating in the multi-District PETS2 in Toronto. It is scheduled for March 6-7, 2015.

Rotary International District 7090 Minutes of Annual General Business Meeting Buffalo Convention Center, Buffalo, New York Friday, October 24, 2014/4:00 PM

Attendance: 15

I. <u>Call to Order</u>: Jack Amico, District Governor 2014 – 2015

Welcome: DG Jack called the meeting to order at 4:00 P.M. welcoming everyone.

Invocation: Kevin Crouse, IPDG

Rotary Moment: Rick Sterne, PDG

High Five (with his red nose on)! Rotarian for 40 years....dad was a Rotarian so it goes back to childhood. So many Rotary moments.....how blessed he feels to be a Rotarian. Reflecting about his club......snowmobile around Canada.....reflecting about involvement in the District and involvement with youth. Probably most rewarding years were serving as Assistant Governor, then District Governor. He believes the Rotary is making a difference in the lives of other; but Rotary has certainly made a difference in his life.

II. **<u>RI President's Representative</u>**: David H. Buck, PDG District 5970

PDG Karen introduced RI Representative Dave. Citing among other things his 43 years as a Rotarian, District Governor.

Representative Buck indicated that he and his partner were Aides to Gary Huang last year in Pittsburgh. He said that Gary when asked him if he had ever been a President's Rep, he responded "no", and Gary said he could change that and he did!

He mentioned all the good things he had heard about our District, especially the work of The Foundation.

He spoke about when he and wife Ruth participated in an NID in India where 125,000,000 children were immunized in one day. He noted that the most amazing thing about our polio efforts....is that India is now polio free....something that the government said would never happen. He went on to explain that there are 3 strands of polio, 1, 2, and 3; strands 2 and 3 have been eradicated. He also noted that the vaccine has been reformulated to address strand 1. He shared the statistic that there were 243 cases this year....exactly 50 less that this time last year and that Pakistan.....is a concern because of the negative propaganda. He

reiterated what we know about Bill Gates and his support of polio eradication. He shared that 2 years ago Bill Gates was checking in the sewer system looking for the polio virus; Bill Gates is a partner that really not only has great influence, but is hands on.

DGE Kevin stated that he is very excited about the opportunity to serve as DG. He just attended the Zone Institute last week and enjoyed meeting with a couple of his classmates, including a DGE from Russia.

- Greg Norton will be his District Conference Chair next year in Holiday Valley, Oct 24 25, 2015.
- PETS 2 will be held first and and then PETS 1 will be combined with District Training Assembly....and another date to be determined.

VI. **District Governor Nominee's Report** (see attached report): Bill Clevette DGN Bill stated he is very proud to be a part of the AGs – such a great team to work with. He commented that when he asked if the District was putting too much on them (the AGs), they all responded "bring it on".

He noted he has taken on looking into the web page and face book and even twitter as ways to share the good work of Rotary.

He thanked all for sending Marge and he to the Zone Institute last week - noting it was a great experience, he made good connections and learned a lot.

VII. <u>Conference Report</u>: DG Jack for Amy Thompson who is otherwise occupied.

DG Jack first stated, "Honestly, we are down on the numbers". He went on to share that instead of the 350 they expected, there would probably be closer to 250 in attendance. He indicated that the piper will be paid with a check and a dram of whiskey, there will be some excellent speakers: Josh Covey at lunch, the RI Rep tomorrow night at dinner where Russell Salvatore will be receiving a Paul Harris, and the Sunday speaker will be Joe Roberts, the author of *Skidrow CEO*. He also noted some other differences including moving up and eliminating the Sunday morning ecumenical service will instead kick off the conference on Saturday morning and be a celebration of life.

- RLI 48 people have gone through all 3 parts of RLI. Rick Sterne, Chris Cutler and Marlee Diehl going to Kitchener for more training as trainers for RLI. 150 people have done parts I or II. Have rescheduled the Jamestown training for March 2015 due to lack of participation.
- Visioning 16 or so clubs have gone through visioning program. Grand Island is coming up.
- PETS 2 Training planning has already begun.
- Release Your Inner Rotarian will be a session tomorrow.

<u>Service Projects</u> (no report): Willy Heidbeuchel, Director, absent DG Jack noted that World Community Service which is the primary component of Service Projects is going well.

<u>Youth Services</u> (see report attached): Greg Norton, Director Updated his report noting the three outstanding young Rotarians from our District that presented at the Zone Institute, Jen Middleton, Matt Pomeroy, Darren Luong – all part of our Rotary youth programs that are now Rotarians.

Greg announced that effective October 1, PDG Rick Sterne has agreed to chair Interact on the Canadian side of our district.

<u>Public Relations</u> (see report attached): Paul McAfee, Director, absent DG Jack noted that Paul is overseas but his report is attached. He also noted that Chrissy Casilio and Roseanne Morissette are phenomenal in helping the clubs and the District get the word out about Rotary.

<u>Membership</u> (see report attached): Brian Carmichael, PDG, Director, absent DG Jack noted that membership is on the rise and specifically noted the newly chartered Buffalo Niagara Medical Campus Rotary Club now has 86 members.

<u>**The Rotary Foundation**</u> (see report attached): Karen Oakes, PDG, Director At the Foundation Dinner scheduled for November 21 recognitions include:

- Roy Sheldrick will be receiving a special recognition
- Top 3 clubs per capita member giving Delhi, Niagara Falls, ON, and Ancaster
- 16 EREY clubs
- 8 Sustaining Member clubs

Other comments included:

- 100% compliant with grants as per the Stewardship Committee review.
- District Scholarship available in the amount of \$5000; applications due December 31, 2014

- Team leader for VTT has been selected, Ms. Lezlie Murch, of the Rotary Club of St. Catharines South.
- 17% of the clubs have submitted MOUs for grants in 2015-2016. The deadline to get the MOU to John Teibert is November 30, 2914.

Director Karen asked Wally Ochterski, PDG, Chair of Stewardship Committee to address the meeting. Per Wally, one of the things they look for is irregularities, in numbers, contracts etc. Look also at final reports that come in. Have looked at 5 projects out of the 17. 3 on the Canadian side, and 2 on the US side. 2013 – 2014 grants – letter has been sent to Karen, saying that our review the annual financial – checking accounts reviewed, "unanimous that all were conforming to good practices".

District Governor's Report

District Council Meeting 11/22/2014 and 1/24/2014

Since my last <u>official</u> report, I attended the Zone 24/32 Institute. It was a great event with much of the program developed by PDG Karen Oakes and PDG John Heise. It was a learning experience AND an opportunity to meet with and compare notes with classmates from as far away as Russia and as close as Burlington. What stood out is that our district continues to be a leader in all things Rotary. I was honored to accept, on behalf of PDG Kevin Crouse, Club Extension and Polio Eradication awards which exemplified the leadership of 7090 within the Zone. Representing the Canadian Rotarians in our district, I had the opportunity to meet The Right Honourable Stephen Harper, Prime Minister of Canada, who accepted the Rotary Foundation Polio Eradication Champion Award for his longstanding support and continued leadership in efforts to eliminate polio around the world. Quite a gentleman, he took the time to meet each of 17 DGs and chat with each of us.

We had approximately 250 Rotarians and guests attend the Bash (this year's conference) and all who have provided any feedback said that they enjoyed it immensely. Unfortunately, we were not able to attract the number of attendees needed to cover our costs. With a tighter budget, lower cost meals and accommodations than in the past, a central venue and (I believe) some compelling speakers (to say nothing about the great party on Saturday night), we found out that the annual conference is apparently not of interest to more and more of our district members. I'm still trying to massage the numbers but we will have lost upwards of \$16,000 because the attendance was less than half what we'd hoped for and a third less than we needed to cover the hard costs. As a result, I'd recommend reconsidering the concept and structure of the conference in the future. PDG Joe DePaolo has agreed to form a committee to review the entire process and recommend ways to make it work in the future.

The annual Foundation Dinner was a victim of Snow-vember on 21 November, when we expected over 150 Rotarians and guests to come together and celebrate the good work done by and in the name of The Rotary Foundation. PDG Karen Oakes, Foundation Director, has rescheduled it for Friday February 13 and we are hopeful that many of our members will make it for this one. She's also heading up the committee to run District 7090's first Million Dollar Dinner.

Our newest club, the Buffalo Niagara Medical Campus Rotary Club, continues to grow and is now the fifth largest in the district. Membership Director PDG Brian Carmichael is looking for similar underserved disciplines where we might duplicate the success of that club. As a result of BNMC's growth and the ongoing addition of new members by many of the clubs in the district, our membership numbers are improving, in spite of the business climates in our two home countries.

I will also be visiting the members of the about to be chartered Hamilton Community based Rotoract Club in February to meet them and welcome over twenty new Rotoracters (with thirty or so in the wings). Following close behind, a community Rotoract Club is forming in the Norfolk area. They've had an informational meeting and are hopeful of chartering shortly.

Electronically, the district continues to evolve our ways of communicating with each other. Public Information Director Paul McAfee's Social Media program is underway and a number of clubs are expanding their social footprint and attracting new members. District Secretary Pene Hutton with a little help from DGN Bill Clevette has implemented a new version of ClubRunner, one which promises to be more marketing oriented while continuing the reporting capabilities of the current version. If you haven't been on the page lately, take a look.

Thanks for all you do in the name of Rotary.

District Governor Elect Report

January 24, 2015

Since the previous District Council on 11/22/14, I have:

- Facilitated District Leadership Team GoToMeeting sessions on 12/2 and 1/8
- Participated in various meetings with other District leaders regarding: PETS, District Training Assembly, and preparing clubs for the new RI billing procedure. District Training Assembly will be renamed, "Club Leadership Training" in order to emphasize the focus on developing club leaders. More details may in the report of Training Director, John Heise.
- I continue to work with the planning committee for the multi-district PETS program that will occur March 6 & 7 in Toronto. This event, previously known as "PETS 2" had been renamed, "Multi-district PETS" in light of the fact that we are not doing a "PETS 1" program.
- I Pprticipated in several meetings to discuss plans for the 2015 District 7090 Conference at Holiday Valley in Ellicottville, NY. We have had several online meetings as well as face-to-face meetings with committee members and members of the Ellicottville, Olean and Salamanca Rotary Clubs. We hope to open online registration for the District Conference by the end of March.
- In collaboration with DG Jack, DGN Bill and DGND Marlee, we have have initiated three proposals that will be presented to District Council:

End Polio Now: A Year in Review

As we look back on 2014, we have made tremendous progress in the fight to end polio. Here is a review of all of the major milestones that we reached this past year:

- On March 27th, the South-East Asia region of the World Health Organization (WHO) was declared polio-free. [Unbelievable!]
- More than 90,000 people from 170 countries added their photo to Rotary's *World's Biggest Commercial* to support the fight to end polio. [Is your photo there?]
- World Health Organization (WHO) declared Nigeria free of Ebola in October. Experts attribute this success to the infrastructure put in place due to polio eradication efforts. [Thanks, Rotary!]
- We had the most successful World Polio Day in Rotary's history. Twenty-four thousand viewers tuned in to the World Polio Day livestream from over 25 countries and supporters donated over \$240,000 in October alone. [Did you join in?]
- The Center for Disease Control (CDC) reported that we may have seen the last of the type 3 polio strain. November marked two years since the last case due to wild poliovirus type 3 (WPV3) was reported. [One, two, three strikes you're out, polio!]
- More than 300 Rotary members smashed two Guinness World Records on the Sydney Harbor Bridge and raised over \$108,000 to protect children against polio. One for the most flags flown simultaneously and another for the most people on the Sydney Harbor Bridge at the same time, a record which was previously held by Oprah Winfrey. [And the next record? A polio-free world!]
- Nigeria has reduced cases of polio by 90%, a record low for a nation that, as recently as 2012, was home to more than half the world's cases. [We're this close!]

The fight to end polio is a massive effort that Rotary and its partners cannot do alone. Help secure support from governments, non-governmental organizations, corporations and the public. Your advocacy efforts help ensure that no child will suffer from this crippling disease ever again. [On behalf of the children of the world, I thank you for your commitment in 2014!]

- The District is deciding what, if any, Public Image budget we will have in the 2015-2016 Rotary year.
 - I recommend \$5,000, but that may not be available.
 - If not, then I recommend at least \$1,000.
- We will encourage clubs to do their own Facebook marketing in 2015-2016.
- We need to determine who will handle traditional public relations in the next year. That is, sharing news releases with print, radio, and TV media.
- During the 2015-2016 year, we will need to find a replacement for me in this role.
 - I expect to be in Vietnam during this period doing my Ph.D. dissertation research.

District 7090 Public Image Director Report

District 7090 Public Image Campaign Goals

- To create awareness of the Rotary clubs and their activities in our District.
- To encourage people who are generally in the 25-65 year age range to show an interest in our Rotary clubs' activities by clicking **Like** on the clubs' Facebook pages.
- People who click **Like** subsequently receive notices whenever the club posts on their Facebook page. The ads we run on Facebook show both the club's Facebook cover photo, and the most recent post put on the page by the club's Facebook page administrator(s).
- Through the information received from the Rotary club's postings, encourage new people either to support the Rotary club, or to develop an interest in joining the Rotary club.

Notice that the campaign can get new people to follow the activities of a Rotary club in our District. **The campaign cannot generate new Rotary club members by itself. This is the responsibility of the clubs.** They must post information on Facebook that is interesting to non-Rotarians. When a new candidate shows an interest, the clubs must work with these people to bring them into their clubs.

TRAINING DIRECTOR REPORT

January 24, 2015

Director: John Heise

First, some good news. Next year is my third as Training Director. PDG Ralph Montesanto has agreed to replace me.

<u>Club Leadership Training Assembly</u> (Anne Bermingham)

Our GoToMeeting group has expanded and begins to actively plan the spring Assemblies. In addition to DGE Kevin Crosby, Anne, and me we have been joined by DGN Bill Clevette, DGND Marlee Diehl, PDG Brian Carmichael, PDG Ralph Montesanto, John Mullen and Reg Madison. We currently have a couple dozen possible topics and will next begin to identify the presenters and topics for each Assembly. The Post PETS training will also occur during each Assembly. Given that each Assembly will have three different time sessions, it was decided that the PEs and AGs will meet separately for two session and then combine during the third session. This will give AGs an opportunity to interact with the PEs in their areas and to begin planning together.

Rotary Leadership Institute (Marlee Diehl)

We had a very successful session in Hamilton on Saturday, December 6^{th.} Currently I believe we will do OK with the numbers, Level I is near to ideal maximum size for effective facilitation. We had approximately 50 participants signed up for the three levels. Because of the number of enrollees for level 1, Marlee added a second group.

Another session is being planned for Saturday, March 21. This session will be at Niagara County Community College.

Release Your Inner Rotarian (Marie Bindeman)

Two back-to-back 45 minute sessions of the workshop for new and proposed Rotarians titled, "Release Your Inner Rotarian", were held during the Buffalo Bash on Saturday, October 25th. A total of approximately 35-40 people attended the sessions which included many veteran as well as newly inducted Rotarians. Kevin Crosby, our DG Elect, spoke briefly on the structure of Rotary and Vincent Davis, a graduate of RYLA, detailed the impact of his experiences during the leadership retreat. Handouts included a glossary of common Rotary terms and an informational flyer on the organizational framework of Rotary.

We will be scheduling another session during the Club Training Assemblies this spring.

Visioning (John Boronkay/Anne Bermingham)

The U. S. team held a session with the Albion Rotary club. Participation and attendance by club members was good. A session was also held with the Albion Rotary Club.

PETS 2 (Brain Carmichael)

The title of this has been changed to the Multi-District PETS, which better describes what it is. Another multi-District planning session was held as a GoToMeeting. Speakers for the Friday dinner and Saturday luncheon have been identified and are being asked to participate. The multi-District group will continue to meet electronically each month until the event is held.

2015-2016 Budget (John Heise)

The first budget committee has met and began the process of agreeing on a budget to recommend to the PEs this spring. We still have a couple more meetings before we finish. The group wants to keep the requested dues increase to zero or as close to zero as possible.

Membership Report January 24, 2015

Short Term Work with the AG's to encourage clubs to

- Input into Rotary Club Central a club Membership growth goal. This is a considerable challenge for all Districts right across the 2 Zones. Clubs have yet to "buy into" this new RI feature. I have written a request to our Zone Rotary Co-ordinator asking if there might be a District somewhere in our Zone or even in North America that has had success in having clubs adopt/use Rotary Club Central. If there is maybe we could adopt some of their practices.

- Encourage clubs to appoint a membership chair along with committee members. The Membership Committee is presenting at 2 Area meetings. Nov 18 - Area 14 and Nov 25 - Area 12. We will get a good sense whether clubs have in fact responded to the District Assembly suggestion that clubs set up an active club Membership Committee.

- Prepare clubs to transition to the new Rotary International Membership Dues invoicing system that takes effect January 1, 2015

A considerable amount of effort has been spent trying to prepare clubs for this change. A coordinated approach that includes the AG's and the District Secretary is supplementing the efforts of RI. RI has been sending messages to those clubs who have registered their club officers with RI. 6 of our clubs have been identified as having at least 1 officer not registered. To be updated at council meeting

- Encourage AG's to have Membership as an agenda item at each of their Area meetings and to include issues/concerns on their reports. *This is an ongoing effort. The District Membership chair continues to meet with the AG's at their monthly online meeting*

New initiatives since the last District Council report.

The Committee is working on a 30-60-90 day plan

Membership Numbers. We have become aware of a discrepancy between the membership numbers as reported on ClubRunner as compared to the RI numbers. According to RI we are down 43 members but according to ClubRunner we are up about 25. We are investigating. To be updated at council meeting

World Community Service Committee Minutes Wednesday January 14, 2015

The meeting was called to order at 6:00 p.m. by Chairman Sabih Uddin.

Members in attendance:

<u>Minutes:</u> A motion was made to accept the minutes of April 30, 2014 by Willy Heidbeuchel and seconded by Cathy Henry and unanimously approved.

Projects for discussion and review:

India Project opportunity:

Area 4 AG Dave Elliott described a project opportunity in India that he has visited recently; one which is looking for an international partner. A Global Grant application for a physiotherapy and hearing loss center has been recommended at the local level in India. It is "ready to go" and Dave will send any potential partner a report. The India club is looking for a \$10,000 contribution. PDG Karen noted that before recommending or endorsing we need to look at the Global Grant application.

Trees That Feed :

Cathy Henry gave an update that all of the 650 breadfruit trees in the district grant have been allocated to schools in Jamaica. The 60 trees planted in September have taken hold and are growing and all 650 trees in the grant request have been data-based. A final report is forthcoming. The Ocho Rios South Club has written a schedule for the schools to care for the trees and there are about 2000 trees to be given to schools. She stated that any extra breadfruit flour will be purchased by a group in Harlem NY.

Cathy also described the pilot breadfruit project in Pakistan and asked if that project will need separate approval to go club to club as there fundraising needs advance. The answer was yes.

Entebbe Uganda School Project:

Jackie Van Lankveld discussed this project. The overarching need is for a new school building. She described that the families who can pay tuition will offset the tuition coast for the community's orphan population of about 70 students. PDG Ralph reminded her that TRF doesn't support brick and mortar efforts. The Rotary Club of Entebbe is involved. Several suggestions were given to Jackie on how best to move forward. Equipment and water and electrical needs can be worthy Rotary projects.

MOTION: A motion was made by PDG Karen and seconded by Roy Sheldrick to recommend to the District Council support for the Uganda School Project by allowing club to club solicitation by the St. Catharine's Club. Jackie is also looking for a U.S. partner to be able to apply for a grant from the Dorothea Haus Ross Foundation.

New Business:

DG Jack introduced AG Melisa Schrock and Kate Vacanti from LOTOL (Let Them Laugh Out Loud). (For more information see LOTOL.com) Kate showed a video presentation which explain the well drilling projects she and her husband have been involved in for the past five years in Sierra Leone. She is looking to involve any Rotary Clubs in the district which may be interested in this work and Kate is also to apply for a Global Grant if feasible. Melisa noted that a group from Akron-Newstead Rotary traveled there to visit a well that A-K had been responsible for funding.

There was a lot of discussion around the best way to be considered for a Global Grant focusing on the maintenance aspects of the wells. Karen noted that there was potential here to develop a Vocational Training Team to be of assistance.

At this time it seems more work needs to be done before this can be considered a project Rotary would fund. There needs to be a partner club in Entebbe and the actual Rotary connected project has to be initiated and controlled by Rotarians.

It was suggested that perhaps Kate could work with PDG Karen and Roy and bring the project back to WCS in the Spring 2015.

Bihari Relief Project and Nepal Stove and Latrine Project:

Dave Johnson updated the group on the Biari Relief Project which has been endorsed by Buffalo Niagara Medical Campus Rotary Club. Dave asked for and received advice on what to focus on in order to be eligible for a Global Grant and is working with Roy and PDG Karen to that end. The partner club is the Rotary Club of Dhaka, Bangladesh.

He also updated the group on the second round of stoves and latrines in Nepal in partnership with the Rotary Club of Kathmandu. Sabih suggested an outfit in Californian and Virginia which may be able to help with stoves. It was suggested that Dave select one project to fundraise for at a time and he thinks it will be Bihari Relief, then the Nepal project.
