



#### MINUTES OF DISTRICT COUNCIL MEETING Saturday, June 27, 2009

**Attendance**: 22 Rotarians

**Chair:** Ralph Montesanto, District Governor 2008-09

Welcome & Invocation: DG Ralph called the meeting to order at 8:48 a.m. John Heise, DGD gave the invocation. Governor Ralph asked attendees to introduce themselves and to share a personal Club involvement activity of which they are particularly proud of this year.

#### **Secretary's Report:** Pene Hutton

Executive Secretary Pene reported that the Official Minutes of the April 25, 2009, District Council Meeting were posted in advance of today's meeting for review.

MOTION TO APPROVE THE MINUTES OF DISTRICT COUNCIL MEETING OF APRIL 25, 2009, WAS MADE BY DGD JOHN HEISE, SECONDED BY AG JOHN BORONKAY. MOTION CARRIED.

<u>Treasurer's Report</u>: DG Ralph Montesanto for Marlene McGraw (see attached report) DG Ralph referenced the report and also noted that the billboard grant monies of \$6000 had been received from RI.

MOTION TO ACCEPT THE TREASURER'S REPORT BY PDG BOB BRUCE, SECONDED BY DGD JOHN HEISE. MOTION CARRIED.

#### **District Governor's Report:** Ralph Montesanto (see attached report)

Governor Ralph noted his report and particularly noted the charter of the new EarlyAct club at Mother Theresa's Catholic School, the Membership event at Grand Island club and the Niagara Falls, NY Paul Harris dinner. He also noted the Club Visioning session he had attended and his interest in being involved in Club Visioning program in the future.

#### **<u>District Governor Nominee's Report</u>**: Karen Oakes (see attached report)

DGN Karen referred to her report on the table. She commended her Trainers and also noted the high caliber of the Assistant Governors over the year.

#### **District Governor Designate's Report:** John Heise (see attached report)

DGD John noted the immense number of forms he has had to complete in his new office among other things.

#### **Director's Reports:**

<u>Public Relations</u>: (see attached report)

Comunications Committee: Pene Hutton, Chair, gave an update on the District Website and noted the new counter was installed on the website and the work on the menu on the home page. She also noted that a Google search function is to be installed soon. She noted that the AGs have extra access to many of the ClubRunner functions on the Admin Page and that they can check on their clubs to see which of their clubs are keeping the website database current.

PR Committee: Paul McAfee, District PR Director 2009-2010 shared his goals for the coming year referencing his report. He also noted the preparation of a grant request to RI for marketing monies for radio advertising and explained his methodology of thorto

<u>Membership</u>: Andy Skrypniak, Director (see attached report) Director Andy noted that as of May, the membership had increased by 10 over the July 1 SAR count reported to RI. He also reported that new this year, he had implemented following up on leads that have been referred to clubs and that the process was working well.

Rotary Foundation: PDG Bob Bruce, Director (see attached report)

Annual Fund: PDG Bob noted that he expects the District to make it's goal of \$241,439 to the Annual Fund. AG Marty Quinn presented Bob with a check to the Annual Fund from the Cheektowaga club.

<u>Scholars</u>: Chair John Tiebert, reported the selection of Eve Williams as Ambassadorial Scholar. 5 applications were reviewed and approved for interview, 4 applicants showed up for the interview, 2 from US and 2 from CA. The committee were unanimous in their approval of Eve who will be studying in Uganda. John also noted that incoming scholar KeiOkajima from Tokyo will be with us for two-years and attending SUNY Buffalo. John is looking for a club to host him.

<u>Polio Plus</u>: PDG Bob noted that RI is closely approaching it first million dollars in meeting the Gates challenge grant. Our District has recorded contributions of almost \$190,000 as of June. Bob also reported that to date approximately Thirteen Billion Dollars has been spent on Polio eradication, 1 billion from Rotary, smaller amounts from our eradication partners and the bulk of the financial contributions has come from governments around the world.

<u>Youth Services:</u> Kevin Crouse, Director (see attached report)

Director Kevin reported for his committee chairs and noted the following:

Youth Exchange: Noted that the first Annual Meeting of the Youth Exchange Board was held recently. (see elections in report).

<u>Slapshot</u>: Total of 88 participants, the best Slapshot to date. Next year's date is set for April 30 – May 2, 2010.

<u>RYLA</u>: A record attendance of 50 at this year's RYLA. Director Kevin specifically commented on Jennifer Middleton's tireless efforts.

<u>EARLYACT</u>: No report but new school was chartered and a couple of more are in process.

<u>Service Projects</u>: John Heise, Director (see attached report) World Community Service: Roy Sheldrick, Vice Chair

MOTION TO APPROVE NEW CRITERIA FOR APPROVING INTERNATIONAL PROJECTS TO BETTER ALIGN WITH THE GOALS OF ROTARY INTERNATIONAL WAS MADE BY DGE PRAVIN SUCHAK, SECONDED BY PDG BOB BRUCE. MOTION CARRIED.

The new criteria is stated as follows:

For a project to be approved by the World Community Service Committee for recommendation to District Council that the sponsoring club be allowed to solicit funds from other District clubs, the project must meet the following criteria:

- Benefit a large number of people.
- Be of a self-help nature
- Work to achieve a better world through one or more of the following:
  - Peace and conflict prevention/resoluntion
  - Disease prevention and treatment
  - Water and sanitation
  - Maternal and child health
  - Basic education and literacy
  - Economic and community development
- Involve a number of Rotarians in both countries
- Be identified as a Rotary-supported project
- Be initiated, controlled and implemented by Rotarians
- Becoming self-sustaining after initial funding has ended.

MOTION TO APPROVE 18 CLUBS TO GO CLUB TO CLUB TO RAISE MONEY FOR THEIR PROJECT WAS MADE BY PDG BOB BRUCE, SECONDED BY DGN KAREN OAKES. AFTER DISCUSSION, THE MOTION WAS AMENDED AND SECONDED AGAIN BY THE SAME PARTIES TO INCLUDE THE AFGHANISTAN SCHOOL PROJECT WITH THE CAVEAT THAT A DISTRICT CLUB MUST SPONSOR IT FIRST. MOTION CARRIED.

Training: PDG Wally Ochterski, Director

- COMMITTEE ARRANGE AND SELECT FACILITATORS FOR OUR DISTRICT AND ATTEND TRAINING IN TORONTO.
- COMMITTEE EDUCATE CLUBS REGARDING THE RLI
  PROGRAM AND HAVE CLUBS BUY INTO SUPPORTING
  MEMBERS TO ATTEND RLI SESSION TO THE EXTENT THE
  COMMITTEE DEVELOPS THE COURSES BY THE CLUBS
  SENDING SENDING CANDIDATES.
- FUND THE PROGRAM \$200 TO JOIN THE SHINING WATERS RLI AND \$1200 TO REIMBURSE FACILITATORS FOR OUT OF POCKET CASH TO ATTEND THE TRAINING IN TORONTO. THE FUNDS ARE TO BE ENCUMBERED FROM THE 2008-2009 TRAINING BUDGET.

<u>Visioning</u>: AG Nan Bruce and PDG Dick Earne, Co-Chairs (see attached report) AG Nan reported on visioning activity and noted that there are 3 sessions each side of border pending.

Friendship Exchange: AG Nan Bruce, Chair (see attached report)

Chair Nan announced the arrival of the inbound New Zealand team September 10 – 25<sup>th</sup>. She also announced that an exchange with Bulgaria is in the offing and that the exchange with India is on hold temporarily.

#### **DG Review and Thank You:** Ralph Montesanto

DG Ralph said it was time to say good bye and thank you, to turn things over to DGE Pravin. He noted that the "team" did all the work, he just reminded people to move along the continuum of the Rotary experience. He thanked the District leadership for serving beyond the club level and particularly thanked the leadership who are leaving their positions and taking on new positions, like PDG Bob Bruce, Director Andy Skrypniak and DGD John Heise. He also thanked the AGs leaving their terms.

<u>Presentation of the Gavel</u>: Ralph Montesanto, District Governor to Pravin Suchak, District Governor Elect.

DG Ralph told the history of the gavel and presented it to DGE Pravin advising him to "not take himself too seriously!"

#### **District Governor Elect Report**: Pravin Suchak (see attached report)

DGE Pravin made several announcements including that the GSE from Belize, Honduras and Guatemala would be here for the District Conference. He also thanked the District leadership especially his trainers, PDG Dick Earne, Kevin Crosby and Bruce Baum. He announced a new slogan created by RI as to membership – "Reach One, Keep One."

DGE Pravin outlined his goals for the coming year (see report). He noted that we have a great group of incoming presidents, we need to support them to achieve District, RI and their own goals as well. He stated, "My job is to give them the will, your job (District leadership) is to give them the plan."

#### **District meetings**

My big thrust during the last six months has been on President-elect training and the District Assembly—Thanks to the tireless work of District Trainers Dick Earne, Kevin Crosby & Bruce Baum all the training events were well planned & executed and were well received by the Presidents-Elects at PETS1 and PETS2 and by clubs officers as well as other members of clubs at the District Assembly.

#### **District Assembly**

The District Assembly was held on Saturday May 9 at Niagara Falls High School on Porter Ave, Niagara Falls, NY. There were 36 sessions, covering a wide range of topics for club leaders, and general membership. We had special sessions designed for President-elect, Secretary, Treasurer and various committee chairs. #### District 7090 - PR Director Report for 2009 - 2010

- 2) The PR Director conducted a survey of the District's and Club's leadership. We identified radio stations that will provide the best coverage of the two halves of our District, yet will fit within our low (from a Radio advertising perspective) budget.
- 3) The PR Director will create a draft plan after consulting with the selected radio stations to obtain demographic, pricing, and free PSA placement details.
- 4) The plan also will include use of "real" public relations activities. These include press releases and story pitches to all media channels, including print, TV, and online.
- 5) The plan also will include options for individual clubs, or groups of clubs, to piggyback on the District's campaign.

  This will enlarge the scope of the program, providing greater geographic and demographic coverage, as well as more frequency.

## **District Council Report** *June 27, 2009*

#### **Bob Bruce, District Rotary Foundation Director**

This has been another good year for our District Rotary Foundation Committee. This success is due to the diligence and leadership of the Sub-committee Chairs and the willing efforts of the 51 committee members who work assiduously to help us make our Foundation stronger so that we may fulfill the mission of Rotary International. Their efforts and the support of our 73 clubs with 2940 Rotarians are deeply appreciated.

Below are reports about the Sub-committees of The District Rotary Foundation Committee.

#### Annual Programs Fund and Permanent Fund Sub-committees

#### Karen Oakes, Permanent Fund Chair

Art Wing and Joe DePaolo, Annual Programs Fund Co-Chairs

#### **Annual Fund Goals:**

a. Each club to target a minimum of \$100 per member for a total of \$277,600.

As of June 22 APF contributions were \$241,439 (or \$86.97/member), which is \$36,131 below our target. 8 clubs had not made any contribution as of the June 22 report, but we know that there are a number of contributions that have been sent in but not yet posted.

#### b. Increase Sustaining Members by 200.

We now have 582 Sustaining Members in the district. We started the year with 464.

c. Increase the number of Paul Harris Society by 12.

We now have 30 members to date. We started out with 24.

#### **Permanent Fund Goals:**

#### **Increase Major Donors by 3**

1 new Major Donor realized and 1 new Bequest Society Members recognized. Total contributions to the Permanent Fund in 2008-09 are \$537,170.

#### Total donations to The Rotary Foundation @ June 22: \$920,168

#### The Rotary Foundation Dinner:

On Friday, November 14, 2008, The District 7090 Rotary Foundation Annual Dinner was held at Salvatore's Restaurant, with 225 Rotarians, partners and friends in attendance. Guest speaker PRIP and PTRF Trustee Frank Devlin enthusiastically explained the goals of the Foundation and touched the hearts of many as he explained the work of the Foundation and its ongoing needs.

Our thanks go to DGN Karen Oakes and Executive Secretary Pene Hutton and all the other people who worked to make this evening a success.

### The Grants Sub-committee

#### Don DeMeo, Chair

The Grants Sub-committee has received funding for the 2008-09 District Simplified Grants and has allocated these funds as reported at our last council meeting.

The Grants Committee has had much difficulty in obtaining final reports from clubs who have received DSGs. As the Rotary Foundation only allows Grant Funds to be open for two years, we have been unable to obtain new grant

money until all the reports from 2006-07 were finally submitted. Failure to report by even one club delays all other clubs waiting for grants from getting their projects underway.

All 2008-09 (and future) approved District Simplified Grant funds will be issued to clubs only upon receipt of the final report. It is hoped that this process, followed by many other districts, will enable us to let clubs proceed much more quickly with their approved projects. We have already received 2 of the 13 final reports from 2008-09 clubs.

#### **Group Study Exchange Sub-Committee**

Keth Lindberg, Co-Chair Bert Rappole, Co-chair

#### Goal:

Recruit GSE team for District 4840 (Arentina/Paraguay visit in the spring after hosting a team from District 4840 in the fall.

A report was given to council after the 4840 team visited last fall.

Susan Thompson, the GSE leader of our team to Argentina/Paraguay, has submitted this report:

#### "Reasons for participation:

I am a people person, I like meeting new people, seeing new things, and learning from other people. You can always learn new things even if it is not in one's vocation. I have been involved in hosting other GSE Team members and their leaders and it was a wonderful experience. I could just imagine what it would be like to be on the receiving end, and I wasn't wrong. It was wonderful. I once was told by the Team Leader from a Swedish team that I would make a good leader and that pecked my interest further. It was great seeing how other Rotarians from another country did fundraising and held their meeting. I have made new friends, and am trying to help another Rotary Club get funds for a mammography unit.

How did the materials or training that you received from the Foundation and your sponsor district prepare you for the exchange? What specific suggestions do you have for improving the orientation process?

The 2008-2009 GSE Pre-departure Requirement Checklist was very important for me. It was easy to follow and alerted me to the different things that needed to be done and when. The "To Do List" that previous Group leader and GSE C0-Chair Keith Lindberg gave me with the email, address and phone numbers for the GSE Team and RI Contacts were invaluable. The samples of past brochures and business cards helped with our designing of our own brochure and made sure that we had the right information on the business cards. The informal pictures on the written information were a nice touch. The fact that our brochure and our presentation was in Spanish was well received. I would suggest that the brochures and presentation be in the language of the other district/country for other GSE groups if it is at all possible. It saves time with interpreters. I would suggest that other teams meet at each others houses when putting together their presentations. You get to know a lot more about the people you are going to be traveling, and living with for the whole month. The help that Bob Morrow (Alternate Team Leader) gave me helped me from learning things the hard way, seeing as I was never an alternate. I firmly believe that if you find the right person to be the Team Leader they do not need to be an alternate first with the kind of support I had from these two experienced gentleman. It was unfortunate that the team was selected so late because they missed the orientation. I know it was hard to get candidates with the focus of the group being water related. The good thing I believe about the group belonging to a related field is that it made it easier for the host district to pick worthwhile vocational experiences for them. The frustrating thing was the travel agency insisting that I needed the visas first before they would issue the itineraries, while the Consulates were needed the itinerary before issuing the visas. Thanks to Keith for straightening things out for me.

How has your experiences changed your outlook on your host country and sponsor country? What professional experience did you gain from the exchange? What was the most important aspect of the exchange?

My experience did not change my outlook of the host country because I went with an open mind and sometimes it is better to go with the thought of learning a whole lot about that country and its people then having preconceived ideas.

My professional experience as a physiotherapist: I had one vocational experience in Asuncion where I was taken to a private hospital that gets no funds from the government. It was a rehabilitation hospital for children and trauma victims. The hospital was in great need of equipment, most of it was donated because they do not have the funds to buy new or what they need. There was very little exercise equipment or modalities for the physiotherapist to use. The hospital hired 20 physiotherapist, all of them work part time which is unheard of in Canada. They have patients that come in for outpatients after discharge and if the weather is bad they don't show up. The patient's rooms have a bed in it and a dresser. Other things like bar fridges, small appliances for making coffee, etc. are brought in by the family and the family looks after the patient. It is just different and they do a good job. They could do more with more funding. One of the Rotarians came too me after twisting his ankle. He told me that publicly funded physiotherapists don't have the time to spend on education and exercises following an injury, they just help decrease the pain. The most important aspect of the exchange was the meeting of the people and the exchange of information that was shared between the professionals. It will be beneficial to all countries.

- Saw the Centro de Artes Visuales Museo Del Barro
- Visited several water treatment plants and a couple of residual water treatment plants
- Visited a Rehabilitation Hospital
- Went to a Rotary Fundraiser
- Visited the town of Luka for shopping and had a typical Paraguayan lunch
- Saw the Independence House and there White House (Independence day in Paraguay)
- Visited Lake Ypararai and Alto- Presentation by Rotarians about the state of the lake
- Interviewed on TV and then a radio station, this happened a couple of times (Coronel Oviedo)
- Visited the Hydro Generating Plant ITAIPU and their Museum, also another area that does studies of fish and aquatic plants in the area. (Ciudad del Este)
- Entertained by a guitarist and a harpist, typical Paraguayan music
- Iguazu Falls from the Argentina side (included the boat ride) and then from the Brazil side (Puerto Iguazu)
- Lunch and dinner at various restaurants
- Boat ride on the Parana river (Eldorado)
- Experienced night life three times
- Visited an Aquarium, very educational (Eldorado)
- Visited the Garden of Birds, a water fall, city tour(Obera)
- Visited an experimental Park where they went down 1250 meters to the aquifer. The water was 42-49 degrees C, they added cold water to bring it down to 104 degrees for the pools.
- We meet two different Mayors, different cities
- Saw a tree that was 2,000 years old, Tea fields and Yerba trees (Mate)
- AESA Recycling Waste Products (dump in Posado)
- Carried the Canadian flag to the stage in the opening ceremony for the District Conference
- Presentation at the Conference
- Went to a political, election platform and heard the candidates speak, a concert followed
- Visited a Biological Centre
- Audience with the Goverador de Department of Itapia, the Minister of Environment and other employees re water, environment, etc. (Encarnacion)

#### Goals:

#### a. Select one Rotary Ambassadorial Scholar.

On Saturday May 31, 2009 a committee comprised of me, Laetitia de Witt, DGN Pravin Suchak, DG Ralph Montesanto, Steve Keefe, Bruce Williamson, Tony Ronci and Dan Fogel interviewed four candidates for the Ambassadorial Scholarship. We started with seven, one decided that he did not want to apply for the one year scholarship, but would rather apply for the Cultural Scholarship. Unfortunately our District does not offer this Scholarship and the Foundation recently withdrew funding for this scholarship. Another applicant withdrew because May 31 did not fit with her travel schedule – she was out of the country, and a third was a no show.

All four ladies were very talented in their own rights and after a brief debate the committee selected Eve Williams as our District's representative. Eve was sponsored by the Rotary Club of Buffalo Sunrise and Barbara Ochterski will be her counselor.

We do have an inbound Scholar, Kei Okajima from Tokyo Japan visiting us this year (2009-2010, 2010-2011). He is here on a two year scholarship. He will be attending the SUNY Buffalo. I am still looking for a club to host him.

I would like to thank everyone who assisted in this year's selection process.

#### b. Work to acquire Peace Scholar applicants.

This continues as a work in process and we need to work more diligently on advertizing this program to attract worthy applicants. The District has committed \$25,000 of DDF to the pool of funds that make this program possible.

#### The Polio Plus Sub-committee

#### <u>Dudley Ericson, Co-Chair</u> <u>Roger Crysler, C0-Chair</u>

Since the announcement of the Gates Foundation 100 million dollar Challenge Grant in late November 2007, clubs and the district have supported Polio Plus and Polio Plus Partners with \$189,773 in contributions as of June 22, 2009. Actual contributions are listed in the June, 2009, *District 7090 Newsletter*.

These contributions include a \$25,000 Challenge Grant from the District Designated Fund in 2007-08 and a contribution of \$25,000 in 2008-09.

Rotary International has challenged all clubs to contribute a minimum of \$1,000 in each of the 2009-10, 2010-11 and 2011-12 Rotary years as a result of the additional \$255 million challenge contribution from Bill Gates so that we may match his total contributions with \$200 million from Rotary clubs. To date Rotary clubs' contributions are at the \$76 million mark!

In the endemic countries the latest figures are heartening: Nigeria reports 288 cases, with 68 of them Type 1: India 59 cases, 18 Type 1; Pakistan 17 cases, 10 Type 1, and Afghanistan 7 cases, all Type I.

Africa has experienced 8 re-infected countries in the last 12 months. By areas these are in West Africa, 64 cases; Horn of Africa, 56 cases, Central Africa, 14 cases; and Chad 3 cases.

Nepal reports no new cases in 2009.

Polio eradication will only succeed if the necessary funds are made available, and with strong political commitment in polio-affected countries. More than 10 million children will be paralysed in the next 40 years if the world fails to capitalize on its US\$7billion global investment in eradication.

#### **Appreciation**

The Rotary Foundation is our lifeline, our charitable arm, as we reach out to "Do Good in the World".

None of the work of our Foundation would happen without the support of all our members and clubs, and little of the organization would take place without the willing support of the District Rotary Foundation Committee and its many sub-committees. To all of these members I offer my deepest thanks. Your efforts have helped our Foundation grow and make the world a little better, one project or one individual at a time.

Special thanks go to *Governor Ralph Montesanto* for championing our foundation throughout his duties as governor.

Several sub-committee chairs are stepping down and to them very special thanks for their service are due.

**Don DeMeo has** done fine work as Chair of the Grants Sub-committee. He has managed to pull together all the various reports necessary to satisfy TRF staff and put the committee on solid basis for future work. Don will continue to serve our Foundation as the Area representative for Area 12 and our District as Treasure in the upcoming year.

**Roger Crysler** and **Spud Ericson** are stepping down from the co-chairs' roles on the PolioPlus committee, but typical of their dedication to helping eradicate polio they are staying on as Vice-chairs of the committee. We wish Roger every success in his new role as President of the Ancaster Rotary club.

*Jean Armitage* is retiring from her role as Alumni Sub-committee Co-Chair. We are indebted to her for her work both in this role and as a GSE co-Chair over the previous 3 years.

#### **Youth Exchange**

#### **Interact**

#### Rotaract

The two Branford Rotary Clubs joined forces with the new Brantford Rotaract Club to help beautify the courtyard at Participation House as part of their Rotary at Work Day. Jennifer Middleton and seven Rotaractors from Laurier Brantford as well as exchange students from Spain and the Faroe Islands were actively involved in supporting this project which benefitted 26 physically disabled residents living there. Chartered on

April 3, 2009, the Brantford Rotaract Club is currently running a Boston Pizza night and planning a Harmony Square Funfair for September 26 to support their community service project – The Child Development Unit at the Children's Aid Society.

The Hamilton McMaster Rotaract club raised over \$300. 00 for their Kenyan Ceramic projects to purchase stoves there. Kelly Veerman and volunteers held Pizza parties to congratulate kids involved in the Sir John A. MacDonald Homework Club. Megan Vincent spearheaded the 2<sup>nd</sup> annual Rotaract gala that raised \$3000.00 for Shelterboxes and the PoliPlus Button campaign is currently being held to raise money for purchasing Polio vaccines. Buttons were designed by Kelsey Horten who is running the project. Members also assisted the Hamilton A.M. cub with their Christmas Breakfast at Hess Street School.

#### **SLAPSHOT**

A total of 88 registrants representing 34 Rotary clubs participated in this May 1-3 program. Program highlights included Joel Hilchey, High Ropes, Matt Pomeroy, Rotaract support, Interact sessions and Student issues presentations. The event took place at Canterbury Hills in Ancaster. For details of the program see the June District newsletter. Two excellent presentations by the President of the Brantford Interact Club featured the mechanics of starting an Interact club. A number of participants were interested in starting clubs in their schools when they returned home. Excellent support from 12 Rotary volunteers including four Rotaractors from the Brantford club made this Slapshot program the most successful one to date. Jennifer Middleton, MattPomeroy and Fred Farnham made exceptional contributions as well The event was also financially successful, netting a profit of approximately one thousand dollars. Next year's program will take place once again at Canterbury Hills on April 30 – May 2, 2010

#### **RYLA**

A record attendance of 50 Rylarians made this year's RYLA program an outstanding success. #### SERVICE DIRECTOR'S REPORT

June 27, 2009

#### **World Community Service Committee** (Chair: David Johnson)

The committee met earlier this month and reviewed the summary reports submitted by the approved programs. Based upon these summaries the committee is recommending that the following projects be approved for the 2009-2010 Rotary year.

- Gift of Life (Hamburg Sunrise)-provides life-saving open heart surgery to patients infancy to 21 years of age.
- Salama Shield Foundation (Hamilton A. M.)-mentorship program geared towards extended family members for HIV/AIDS education.
- Water for Life (Ancaster)-installation of wells and sanitation systems in Artibonite Valley, Haiti.
- Himalayan Healthcare-Nepal hospital (Grand Island)-continued hospital construction and support of income-generating programs in rural villages.
- Adrie's House of Hope (Lincoln)-construction of residential homes, education, and vocational training and food garden.
- Literacy and poverty reduction in Pakistan/Afghanistan (Brantford)-fast-tracked literacy training and primary school education for teachers.
- ShelterBoxes (Akron-Newstead)-club sponsored emergency shelter kits.
- Belarus' Children of Chernobyl respite (Stoney Creek)-temporary home stays arranged in Canada and U. S. for several children of Chernobyl to provide healthy environments.
- Orphanage for children of HIV/AIDS parents (RYLA/Welland)-RYLA alumni fundraising to support education, operations, and expansion of orphanage.
- Wells and bridges in Ethiopia (Grand Island)-drilling of three wells and construction of one bridge to connect rural villages to area of education, health, and commerce.
- Drilled wells in Niger (Olean)-hand-drilled water wells in a local village.
- Water filters (LeRoy)-provide 4000 families in rural Guatemala with ceramic water filters; done with District 5110.
- RADAR (Welland)-raise awareness of AIDS responses available through Rotary.
- Microcredit (Norfolk Sunrise)-establish micro banks to provide small loans to business prospects in Machala, Ecuador.

The committee also discussed criteria for approving projects. These criteria better align our District WCS projects with the goals of Rotary International. The criteria that have to be met are that approved projects should:

- Benefit a large number of people
- Be of a self-help nature
- Work at the cause of hunger, poverty, illiteracy, or poor health
- Involve a number of Rotarians in both countries
- Be identified as a Rotary sponsored project
- Be initiated, controlled, and implemented by Rotarians

these criteria. These programs, however, were already on-going before the new criteria were proposed. In the future new programs will have to meet these guidelines before being recommended by the committee.

#### **Vocational Service** (Andrea Aldinger)
