Attendance: 23

Chair: Kevin Crouse, District Governor 2013 – 2014

Welcome: DG Kevin called the meeting to order at 9:55 am welcoming everyone

<u>Invocation</u>: AG John Boronkay. Differences around the world in invocations. Religious leaning doesn't matter. It is a way of getting you launched into the meeting. Less about your religion and more about your faith – faith in each other, the project – in working together to help the people of the world. We come here today to see how we can continue that work.

<u>Introductions</u>: DG Kevin asked council members to introduce themselves and describe their most recent Engaging Rotary Moment in membership in their club and area.

Secretary's Report: Pene Hutton, Executive Secretary.

MOTION TO ACCEPT MINUTES OF THE DISTRICT COUNCIL MEETING DATED NOVEMBER 9, 2013 BY JOHN HEISE, SECONDED BY MARLEE DIEHL. MOTION CARRIED.

<u>Treasurer's Report (see attached revised report)</u>: Don DeMeo, Treasurer absent. Current assets of \$369,926; current liabilities of \$56,203; retained earnings of \$254,377; net income year to date of \$59,346.

MOTION TO ACCEPT TREASURER'S REPORT BY KAREN OAKES; SECONDED BY JOHN HEISE. MOTION CARRIED.

District Governor's Report (see attached): Kevin Crouse

Governor Kevin shared his graph of membership data; we are losing about 85 members a year and if we continue this spiral, we will no longer be viable. His goal and emphasis is to grow membership this year.

Announcement: Patty Johnson reported on a new club on the Buffalo Medical campus being sponsored by Buffalo Sunrise. District has approved the decision to go

ahead with this new club. Recruitment has started. Within a couple of years, 17,000 people will be working on this campus and there is a lot of enthusiasm for it there.

District Governor Elect's Report (see attached): Jack Amico

Just back from San Diego and the RI Governor's Assembly. One thing he wants to report is that our District is one of the best run districts in the world.

Announcement: Marlee Diehl, AG. Last year Jack encouraged us to go to our clubs and bring back best practices. Marlee has compiled some information. Will share with the AGs and with their help, we should end up with a workable document.

District Governor Nominee's Report (see attached): Kevin Crosby

A couple of things to mention – continues to meet with AGs and that is productive. Thomas Brock is acting AG for a temporarily smaller Area 5. Melissa Schrock is new AG for Area 12. Still need an AG for Area 17.

On tables is the agenda for District Team Training seminar on February 22. Everyone in this room should be there – a few have conflicts. Please get registered. This is the one time of the year that we get to get together with incoming DGs to hear from them and prepare.

Directors' Reports:

Membership (no report): Pravin Suchak, PDG, Director, absent.

Co-Director Brian Carmichael noted that it was covered well in DG Kevin's report.

Public Relations (no report): Phillip Beckermann, Director, absent.

Concern expressed regarding the grant and direction to the clubs on utilizing the grant for 2013-2014. Also – noted that RI may be cancelling the third year of the grant (2014-2015).

<u>The Rotary Foundation (see attached report)</u>: Karen Oakes, PDG, Director Director Karen invited her team up.

- John Teibert Scholarships. Received 25 applications, 20 of which qualified for distribution to committee for selection.
- Roy Sheldrick Grants. Old system, all on time with reports. New system of Global Grants, a couple of grants approved.
- Bob Gosselin VTT. Had to cancel the program with Argentina –
 Paraquay. New proposal on a project in St. Maartens, educational
 program. Moving along fairly well. Need to hear from the Rotary Club of
 St. Maartens to respond in the affirmative and then can proceed with
 sourcing a team similar to GSE process.
- Bob Bruce Paul Harris Society. Made up of people who pledge \$1000 or more per year. 3% contribute 35% of what is raised a year for the Annual Fund world-wide, more like 10% in our district.

• John Teibert. Today is the last day to apply for grant for 2014 – 15.

Director Karen noted and stressed that we need to have reports in timely so that District can pay out funds committed, as noted: **District grant funds will not be released until the previous Rotary year's District Grant is closed.** The members of District Council were reminded that our 2013-2014 District Grant must be fully completed and closed before our 2014-2015 District Grant Spending Plan will be even considered by The Rotary Foundation Trustees. Therefore, it is imperative that all participants engaged in our 2013-2014 District Grant Spending Plan submit their final report to 2013-2014 District Grant Chair person, Bob Munroe, ASAP, and not later than early May 2014.

<u>Training (see attached report)</u>: John Heise, PDG, Director

PETs: PEs have received email to register for PETs 1 & PETs 2. AGs encourage your PEs to register.

District Assembly: Marlee Diehl, Chair. This is the year to pre-register, pre-select and pre-pay. John Burroughs is helping with this online process. Well on way to getting the agenda in place by next weekend. Looking for AG helpers as Sergeant at Arms to help with crowd control and directions.

Youth Services (see attached report): Greg Norton, Director.

Director Greg reports that all is good in Youth Services. He did report that off topic: He attended a recent Rotary Club of Fredonia meeting recently and it dawned on him that in his father's generation, Rotary, Kiwanis was expected. That is no longer the case in this generation. We do what we do now because we want to.

Heading up to Algonquin this week for the Winter Wilderness Experience with Youth Exchange. Glad to see winter finally returned to Canada.

<u>Service Projects (see attached report)</u>: Willy Heidbuechel, Director, absent.

<u>CRCID</u> (see attached report): Karen Oakes, PDG, Representative for District 7090 Karen began by reading excerpts from president of CRCID. Motion being considered today by members, to wind up the operations by March 31, 2014. Karen gave her proxy to Jim Johnson, CRCID Treasurer. Will keep us apprised of the result.

MOPP Revisions: Karen Oakes, PDG

Karen invited her team up consisting of Bob Bruce, Jack Amico, John Heise, Kevin Crosby, Dick Earne and Rick Sterne. She also noted that it had not been updated since 2008-2009 and it is supposed to be updated every three years.

DGN Kevin noted that they divided up sections of the manual. Each spoke as to Karen's leadership and the process. Noted was that the manual was updated to reflect what we actually do now.

MOPP intended to be done in time for the PEs to pass at District Assembly with the 2014 – 2015 Budget. Will come in final form to District Council at its April meeting. Will be distributed to clubs 21 days in advance of vote.

Council on Legislation (see attached report which replaces his November 9, 2013 report to District Council): Dick Earne, PDG, COL Representative

PDG Dick referenced a survey gone out to COL Reps of past to get ideas on future planning. He also noted the new club constitution that reflects the changes to the RI constitution and documents. Suggestion to clubs – do not update your club constitution, replace it. As noted previously, the club constitution is fixed, only the club bylaws can be amended by the club.

Strategic Planning:

IPDG Rick Sterne reported on strategic planning session. We are going to take a new approach to our plan. Already heard today that our District's plan is one of the best. This year in updating it, the new approach will include 6 webinars prior to the day's planning event to get input from clubs. On Saturday April 5th, we will be having a final discussion at Brock University.





We have **lost 851 members** over the last 5 years. As of July 1, 2013 we lost another 29 members to bring District's total membership **to 2403**. That is an average loss of 85 members per year. If this loss were to continue, our district would be reduced **to 2007 members by the year 2018**.

The good news is that we have added **a new E Club** this past summer and Pravin Suchak indicates that we will have a **new Buffalo club** soon. We have also seen an **increase this year of 19 members** as of December 31, 2013. That means our current membership is now 2422, not 2403. RID Bryn Styles also indicates that membership is improving in adjacent districts. Of course, membership inevitably declines in July as clubs attempt to "clean house".

Let's do everything we can this year to make our clubs more vibrant, increase retention and Engage Rotary and Change Lives



District Grants Committee Report (2014-2015)

Chair John Teibert, 2014-2015 District Grants Chair

The District has set aside \$50,000 in matching grant funds for clubs to access in the 2014-2015 Rotary year. [Maximum - \$2,000 per club] In order to be eligible to apply for the matching grants clubs have to complete three steps; have two club members attend the District Grants Seminar on October 5, 2013, submit appropriately signed agreements by November 30, 2013; and send in a properly completed grant application on or before February 1st, 2014.

53 out of 69 clubs were properly represented at the District grants seminar on October 5, and as a result completed step one in becoming eligible to submit a District Grant Application.

Of those clubs, 50 submitted a properly signed Memorandum of Understanding and Addendum.

To date (as of January 24, 2014) five applications have been received, three have been approved by the committee and two are pending – waiting for additional information. In total \$10,000 has been applied for.

Polio Update for District Council on February 1, 2014

On January 13th, 2014, India passed the three-year mark since its last case of wild polio. This is a landmark achievement for global public health and the worldwide effort to eradicate polio. Bravo, Rotary!

Experts once considered India the most technically difficult place to end polio. India's success against polio is a significant achievement in public health and proves that the disease can be eliminated in even the most challenging of circumstances.

As a Rotarian, you'll already know that polio has been reduced by 99%. And we are closer than ever to ending this crippling disease forever.

The fight to end polio is led by the Global Polio Eradication Initiative, which includes Rotary International, the Bill & Melinda Gates Foundation, UNICEF, the U.S. Centers for Disease Control and Prevention, the World Health Organization and governments of the world, with the support of many others around the globe.

Both Rotary and the Bill & Melinda Gates Foundation have extended their partnership during the critical endgame phase of the Global Polio Eradication Initiative. Until 2018, every US dollar that Rotary commits to polio eradication will instantly become three dollars, thanks to a 2-to-1 match by the Bill & Melinda Gates Foundation.

But the fight to end polio is a massive effort that Rotary and its partners cannot do alone. Your advocacy efforts - at the International, Zone, District, Area, Club and personal level - help ensure that no child will suffer from this crippling disease ever again.

Remember that for as little as US60 cents, a child can be vaccinated against polio for life. With your help, we can end this crippling disease and help make history.

I call on you and your Club to become polio eradication advocates. Please sign a petition. Share your voice over social media. Launch a fundraising campaign. Tell your personal polio story to local news media.

Vocational Training Team Committee Report

Bob Gosselin - Dan Smith District 7090 - VTT Chairs.

As you are aware, we have been in pursuit of a VTT project with District 4845 in Argentina-Paraguay with the Area of Focus being Water – prevention of contamination. While this project held great promise and we fully expected to have a plan in place and Team selected, we have been unable to have adequate communication and cooperation from the target District 4835. We have repeatedly attempted to make this project move forward however due to lack of response we had no choice but to terminate this project and move on to seek another opportunity.

Subsequently we sent out a notice to all Clubs in the District searching for a VTT proposal that could be executed in this Rotary year with a requested response by January 17th. We have received a VTT proposal from a Rotarian in the St Catharines Rotary Club which we believe has great promise. The focus is based on sport education and literacy for children on the Saint Martin island part of District 7020 . It is based on providing sport specific education camps to children, teachers, parents, volunteers, and coaches in order to:

- introduce them to leading healthy active lives
- give them hope for further education and literacy
- reduce gender disparity and demonstrate all inclusiveness
- expose them to the values of commitment, discipline, fair play, and sportsmanship through recreation and sport.

The District VTT Chairs and the Foundation Director have reviewed the proposal and agree in principle subject to being provided with further details and clarifications. The proposal is in the process of being circulated to both the District VTT Committee members and the District Foundation Committee for support - feedback.

The Ideals of Rotary Rotary District Scholarship Olivia Schultz

As I have volunteered with Rotary and gone to events, I am continually encouraged by those who work with us and am humbled when I hear about what Rotary believes in. The Four Way test is something that I have grown to really appreciate especially with regards to my interest in development and I will explain why.

The first part of the test, or "Is it TRUTH?" is very important to me. In our world today, there are so many projects and corporations put into developing countries that claim to help the country it is working it, however in the end it doesn't. In most cases, corporations such as Coca Cola and others move into developing countries and tell the government that there will be positive economic effects in their country and the locals will benefit when really it is not the case. They exploit the environment, privatize the water and then the profit leaves the country in a process called capital flight. What the corporations tell people all over the world is not truth. I strongly believe that in our world today we need to work on having transparent governments and also transparency in corporations. Therefore, I love that this is an Ideal of Rotary as it promises that anything the Rotary works with will first consider whether or not it is truth, and that Rotary will practice transparency in the projects and relationships the members have.

The second part to the test, "Is it FAIR to all concerned?" is also something that is vital in development. Something that I am interested in is sustainable development practices. What I mean by this is, instead of simply working in a developing country with an organization to help the people, I want to teach them agricultural processes so they can sustain themselves and teach others to do the same. In so many projects that take place in the developing world, although there are good intentions attached, they end up being more harmful than good. For example, when organizations are constantly bringing things such as clothing into developing countries, it takes away from sales from the local trying to sell his clothes. Additionally, when aid from the UN is brought in every few months for free, it puts the local farmers out of work as no one buys their food so they stop farming. I am not trying to say that these things are all bad, in fact they are sometimes necessary. However by continually doing these things, people become dependent on the larger forces and forget how to help themselves. This is not fair and I believe that organizations and governments need to be more aware of how their actions affect the third world. This is why I am so happy that Rotary participates in this as it encourages fairness in all it does locally and internationally.

The third part to the test, "Will it build GOODWILL and BETTER FRIENDSHIPS?" is a really great part of the Ideals of Rotary. This is because in most scenarios, companies and organizations look for ties that will keep them networked so that they have 'connections' for the future, but they mainly focus on themselves. In this ideal of Rotary it focuses on the other side of the story, and that prior to doing any project Rotary makes sure that it will create better relations between the people who are involved and thus create a welcoming and friendly environment.

The fourth part of the test, "Is it BENEFICIAL to all concerned?" is really easy for me to relate with. In our society, we live in a capitalistic world based off of free trade. In a lot of situations, the core countries of the world try to partner with developing countries to participate in free trade of their farming, products and more claiming that it will benefit the economy and help all those who are concerned. What has happened instead? According to the 10 Point Agenda (created by the Canadian Council for International Cooperation), most of the world's hungriest

people are those who farm in developing countries and then are forced to give up so much of their product for trade that there is not enough for their family or for themselves to sell locally. In addition to this, these farmers barely make a wage. Is this beneficial for all involved? No, it is beneficial for the countries that they trade with because they take the product and raise the price prior to selling it and the farmers get almost no benefit. As a result, hearing that this is something that Rotary promotes is so wonderful, as our current world system is careless about it, as long as they are benefiting. However, together we can make a difference.

"Service Above Self" is a model to live your life. You do not have to be in international development or working in Rotary to live by this. Anyone anywhere is capable to do this. Simply by working to not benefit yourself but to benefit others, whether that be by working to put a smile on someone's face at work, working alongside a child as they go through depression, or by volunteering your spare time for causes that makes you passionate. This is why I love this ideal. Every occupation is important and can be used to benefit those in our local communities, the Rotary and also our international community if by a commitment of "Service Above Self".

In the above paragraph, I briefly touched upon the second object of Rotary of the importance of each occupation for service, however all the other objectives are also important and all work towards the goal of opportunity for service, application for service and the advancement of world understanding and goodwill. All of these are so important for any organization to have in order to create change and to empower the world around them. It is for all that I have talked about that makes me so pleased to have been able to work alongside Rotary in the past and continue to do so in the future, as the ideals are so important and connect so much to what I want to see the future of our communities and world looking like.

This part of the committee is also discussing going back to clubs which have undergone the process to see what worked for them and what did not.

Rotary Leadership Institute (Patty Johnson)

PETS 1 (Mara Huber)

Plans are almost finalized for the PETS 1 sessions on February 18 (Hamilton), 20 (Elma/West Seneca), 24 (Fredonia), and 27 (St. Catharines). President Elects have been sent an email requesting that they register for one of the above sessions and for the March PETS 2 Training in Toronto. President Elects can register through our District website.

PETS 2 (Brian Carmichael)

Plans are almost finalized for the March 21-22 session at the Bank of Montreal Training Centre in Toronto. President elects have been asked to begin the registration process.

We still have about a dozen clubs who to date have not identified their President Elect. I hope to reduce this list by the time the Council meets and will have, for the meeting, a list of those clubs who still have no identified leadership for next year.

SELECTION PROCESS

Clubs are encouraged to seek applications from young people who are known to members of their club (e.g. former exchange students and SLAPSHOT candidates) or through contacts in business or at local colleges and universities. Note that applicants may be current students or recent graduates. Program organizers like to see a balance of students and graduates. Because the RYLA experience is so exceptional, some businesses and not-for-profit organizations have voluntarily paid for their staff to attend.

Applicants first present their applications to individual clubs, who then make a selection and forward their selections to the registrar.

Be sure that applicants understand that this is an intensive leadership seminar and that they must commit to full participation for the entire duration of the program. Candidates must be free from work or other commitments during the entire week, 24 hours a day.

Clubs should review applications to ensure that they are complete, including complete contact information and emergency contact information.

Clubs should contact personal references.

Clubs should conduct a personal face-to-face interview with two or more Rotarians in attendance.

Criteria for Selection

When selecting your participants, look for maturity, commitment to RYLA, motivation, communication and leadership skills. Assessment of "potential for future leadership" may be difficult, so be sure that all criteria have been tested. RYLA requires selflessness, self-awareness and previously exhibited leadership qualities. In order to achieve maximum benefit from the program candidates need the ability to communicate effectively and to work well with other young men and women.



REGISTRATION INFORMATION

Cost: For 2014, the program cost is \$675 US (Early Bird) per participant. Rotary clubs across District 7090 pay the cost of registration on behalf of the candidates they select. The payment must be sent to the Registrar with the completed application. There are <u>no refunds</u>, so it is suggested that you may want to select an alternate participant.

Deadlines: Clubs may want to book a spot or spots for prospective candidates by forwarding registration fees to the registrar in advance of deadlines. Remember that there are no refunds, so consider having an alternate candidate.

THIS REPORT MAINLY DEALS WITH THE NEW RI MOP, AND THE NEW CLUB DOCUMENTS WHICH INCLUDE THE CHANGES TO THESE DOCUMENTS AS THE RESULT OF THE ITEMS PASSED AT THE 2013 COUNCIL ON LEGISLATION

Suggested steps to follow:

- AGs should check with your Club Pres and or secretaries to see if they have received their copy of the new RI MOP 2013, which includes the aforesaid changes. They should have received an email from Council Services, which went out Oct 22, 2013 with links to the new RI MOP. Some of the links are listed here:
 - https://www.rotary.org/en/document/468 All in Part IV page pg 121
- 2. Clubs now need to revise their Constitution and by-laws to comply with the new RI CLUB Constitution or replace your current constitution and adopt the new one (suggested). The new RI MOP has the new revised Club Constitution and recommended by laws.
 - -Club Constitution-There are changes through out the document, which you must adopt.
 - **-You are however** asked to fill in and make choices in Articles: 2, 3, 6 and 9. In addition to the RI MOP see link for standard club constitution below. The two other links are for the other two RI governing documents, which the COL has the right to change. RI Constitution and the RI By-laws.
- Constitution of Rotary International (PDF) (Word)

As stated, all clubs admitted to Rotary membership must adopt this form for their club constitution.

- 3. The major changes to the standard Club Constitution are as follows:
- -Article 1 and 2 expanded to include e-clubs and satellite clubs.
- -Article 5,5 changed New Generations to Youth Services

- -Article 6 Meetings(there are two forms of Article 6 first is for a regular club the second for e clubs (**regular clubs** sec. 1 d deals with Satellite Clubs)
- -Article 7 deals with several changes.

In section 2 the definition of Active Members has been expanded, see Art 5 Sec2 of the RI constitution, which now allows persons who are no longer actively employed or are active in childcare, or work for their Rotarian spouse,

- In Section 4:
- a) Potential members dealing with transferring or former member from another club, deals with:
- -former club can propose
- -former club needs to supply financial status of potential member
- -requesting proof of the financial status and in b) if not supplied presumed to be current
- -also classification can be the same as in former club (unclear, as if exceeds new club limit then not sure how long temporary is or maybe will exceed until someone changes do to change of job etc).

Section 5 deals with Satellite club membership member of sponsoring club

- -Article 9 attendance, allows provisional club members to be members of the existing club to which the satellite club is a part and thereby meet their attendance reqt.
- -Art 9 Section 1(a) (5) allows for a club's board to approve projects etc as substitutes for meetings. Also see Art 12 Sect 4 (a) (1) the 50% requirement for attendance can be met by 12 hours spent on projects and other events. (I read this to be the projects approved by the Club's board in Article 9 1 a 5. Further, it is up to the club to decide how the 12 hours of service are to be meted out i.e. only 1 hr per day of project. Following comment on this point by Club and District Support (CDS)
- "Regarding the 12 hour service makeups, because the policy itself does not specify how clubs should enact the decision to allow service projects to count as makeups, clubs will have the autonomy to decide how to implement the policy. Some clubs may choose to require a full 12 hours of service before granting any makeups for the 6-month period, others may opt to equate increments of service projects towards individual makeup sessions (i.e. 1 hour of service=1 missed meeting), and there may be other ways that will work better for other clubs. Clubs should feel empowered to use the policy to best fit their own needs."

Bob Goslin Pres Elect for the St Catharines club raised an interesting point. The make up provision which allows members to make up either two weeks before or

after a missed meeting. is still in effect Since it is does that mean that you can only use service projects performed during the four week period, as a result even if a Rotarian worked 12 hours during the 4 week period. The Rotarian can only apply it for the 4 meetings during the four week period. This is being checked out with Club and district support, as soon as we get a reply the answer will be distributed.)

Section 3 a Excused Absence Board's authority expanded when reason for missing meetings is for health.

-b. the rule of 85 has again been changed taking 654 years of age out of the calculation of the rule of 85, so it is back to age plus years in Rotary of 85 or more

Art 10

- -Sec 4 Secretaries are now mandatory members of board
- -Sec 5 c). Before a member can be nominated for club Pres must have been in Rotary 1 yr, unless DG waives)
- -Sect 6 New, Governance of Satellite clubs

Art 12 Duration of Membership-Termination of membership several minor changes makes it more liberal. Also, deals with letting past members rejoin.

Section 4 a) 1) to keep the 50% reqt of meetings every six months expanded to include meetings at satellite clubs, "or engage in club projects, other events and activities for at least 12 hours in each half of the year, or a proportionate combination of both

Again, not sure how the time for a project is to be either computed and or applied and how it fits into or is to comply with the other attendance rules ie. Missing 4 consecutive meetings, make ups to be within 2weeks before or after a missed meeting. How does one deal with a member who works a fund raiser or project for lets say 12 hours in a 2 week period is that sufficient for minimum attendance for a 6 month period.

In trying to get an answer I have spoken to and sent an email to Club and District support and also to the district in Australia that proposed it for clarification. If I don't get back an answer quickly I would suggest each club address it in their by-laws. If no answer is decided on. I suggest that a club or the district send a memorandum to the RI Board for clarification as it is two years until the next COL

These are the major changes.

3. The club by-laws. RI has revised their suggested by-laws. Clubs can pass what they want as long as they don't conflict with the other Official RI Docs. This link will take you to the new recommended RC By-laws

Clubs can tailor these bylaws, as long as their changes align with Rotary's constitutional documents and the Rotary Code of Policies. If you have doubts about your proposed changes, please submit them to the general secretary for the RI Board to consider.

bylaws are only recommendations. Club bylaws should be used to supplement the Standard Rotary Club Constitution with the common practices and processes of your club.

- -You may update the club bylaws to reflect the current practices of your club as long as the changes do not conflict with the RI Constitution and Bylaws, the Standard Rotary Club Constitution, and the Rotary Code of Policies.
- -Your club may also determine how to define a quorum for voting purposes.

There are however certain changes that are mandatory:.

The new edition of the Recommended Rotary Club Bylaws removed:

- -the sections on Avenues of Service and Leave of Absence as they are found in the Standard Rotary Club Constitution.
- -The section Order of Business was also removed to allow clubs more flexibility. For meeting agenda details, see Rotary club leader manuals. For questions, consult your district governor. AGs Please have your Clubs review their by-laws in relation to the new club constitution

World Community Service

- The Committee held a meeting on January 28, 2014
- No Motions were made during the meeting, which would require District Council discussion
- Various Projects were discussed and reviewed:
 - <u>El Salvador</u> San Jose Villenueva (PDG Bob Bruce) a multi-district (earthquake-prove) home building project with a smokeless stove and water filtration system. To date 18 homes have been built at a cost of \$6,000 each. Currently, an application for a Global Grant involving several Rotary districts is underway so that the village receives needed sanitation and water services.
 - Jamaica Trees That Feed Cathy Henry Following a pilot project this project is now raising money to purchase 3000 more breadfruit trees in partnership between Ocho Rios Rotary Club, Jamaica and the Rotary Club of St. Catharines South. These trees have the potential of reaching about 28,500 children, their families and surrounding communities. Twelve Rotarians have signed up for September 2014 to plant the trees. There is also a feasibility project underway in S. Pakistan.
 - <u>Bihari Relief Bangladesh– Dr. Dave Johnson</u> The concept is to provide schooling to the Bihari people - victims of an ethnic cleansing – after the division of India in the 1940s. Most able bodied men lost their lives and the surviving women and children are today still living in camps, stranded in a hostile country. Currently ideas are being solicited for a possible Global Grant for this project.

- Maniche Medical Clinic Haiti John Harbison The project has now been completed, and had begun 2003 with the building of a clinic. That effort was followed by a series of temporary mobile clinics. Based on the successful model of a nearby permanent clinic, a mountain village clinic was built at a cost of \$70,000, which has 4 exam rooms and one laboratory. Costs to patients is \$1.50-\$2.00 a day to see a doctors who comes once a week or a clinician who is available five days a week.
- <u>PDG Karen Oakes</u> provided an update on the situation of Global Grants and District Designated Funds.
