

## Rotary International District 7090 Annual General Business Meeting Minutes Monday, June 29, 2020 Zoom

Marlee Diehl, PDG, Finance Chair called the meeting to order at 7:05 pm. She turned the welcome over to Melisa Schrock, IPDG.

Melisa Schrock, IPDG welcomed attendees to the meeting. She then explained the requirement of RI to produce Financial Statements to the District Membership, as noted.

15.060.4. Annual Statement and Report of District Finances. Within one year of serving as governor, the immediate past governor must provide each club an independently reviewed annual statement and report of district finances. The immediate past governor must provide the statement and report and have it discussed and adopted at a district meeting to which all clubs are entitled to send a representative and for which 30 days' notice has been given.

She indicated that all have received the required reports of the auditor within the thirty-day window.

Financial Report Overview. Rino Bidenti, CPA, CA, CMA, explained the purpose and scope of the audit by performed by outside firm Lumsden & McCormick CPAs. He also reviewed the Management Letter and cited the Auditor's Opinion, as follows:

**Opinion.** In our opinion, the financial statements referred to above present fairly, in all material respects, the financial position of the District as of June 30, 2019 and 2018, and the changes in its net assets and its cash flows for the years then ended in accordance with accounting principles generally accepted in the United States of America.

Mr. Bidenti also commented on the few recommendations for more timely deposit and recording of transactions and the expectation that the few recommendations have implemented. Pene assented that this is the case with the implementation of the new online QuickBooks.

District Finance Chair Marlee Diehl asked for a Motion to Accept Audit.
