

## Helpful Hints for YOUR Club to achieve your Rotary Foundation Goals!

As you know, our Rotary Foundation is one of the important aspects of Rotary which sets us apart from other local community service organizations. The Rotary Foundation transforms our support into service projects that change lives both in our own communities and around the world. It is because of your support of The Rotary Foundation each year that we are able to generously award so many District Grants and Global Grants in support of your Clubs' Projects!

Our District's Foundation Giving Goals for the current Rotary year include the goal of having each of our Clubs **average at least \$120/member to The Rotary Foundation (TRF) Annual Fund**. The following information is intended to help your Club achieve this goal, and as a result increase our capacity for Doing GOOD in our communities and the world.

### A. How do I know what my Club's Annual Fund Per Capita currently is?

Go to [Rotary Club Central](#) on the [MyRotary.org](#) website (*you will need to sign-in if not so already*).

Click on "Reports", then choose the "Rotary Foundation Giving" tab.

Select "Club Foundation Banner Report" report, choosing the current year.

Your Club's "Annual Fund Per Capita" is shown in the upper right corner.

This results from your total Annual Fund Contributions divided by the annual "July 1 Members".

If your Annual Fund Per Capita is less than \$120, subtract the AF/capita amount shown from \$120, then multiply that times your "July 1 Members" to know the amount needed to achieve the \$120 Annual Fund Per Capita Goal (taking care to round up, as the AF/capita may be shown rounded).

### B. Can I donate online using a credit card?

YES, that's preferred! On the [MyRotary.org](#) home page, click on [Donate](#) in the upper right corner.

Select the Rotary Fund of your choice (Annual Fund if you're working on your AF/capita goal).

Complete the other requested information including amount, name, address, club, etc.

If making a donation on behalf of your Club (not you individually), provide that information.

### C. Can a Club still submit our donations using a check?

Yes, of course, although be aware that to count for the current Rotary year, it must be dated and postmarked before June 30.

There is abundant information, including an individual donation form, on the [TRF Donate website](#).

For Clubs wishing to donate on behalf of some or all of their members, TRF has a Prepopulated Multiple Donor Form which will make achieving your Club's Annual Fund Goal very simple.
