
The Monadnock Rotary Club is once again preparing to host the Rotary Youth Leadership Award (RYLA) event. The oneday conference will take place on Saturday, November 10th from 8:30 am to 4:30 pm at Nature's Classroom at Sargent Center in Hancock, NH.

This RYLA leadership conference is open to Junior and Senior high school students from District 7870. Last fall over 15 Rotary Clubs registered 50 students for the event. Clubs are free to devise their own selection process to sponsor a maximum of four candidates from their local high schools though the involvement of Interact members is encouraged. The cost of the program is \$95 per student and the young men and women who attend generally do so at the generosity of their sponsoring club.



The students attending this RYLA conference will participate in several dynamic and thought-provoking seminar sessions. Each session is designed to provide opportunities to explore, practice and discuss aspects of leadership such as communication, team-building, conflict resolution, and leadership styles.

The Monadnock Club encourages all Rotary Clubs in District 7870 to get involved with RYLA by identifying and sponsoring young men and women from their local high schools who will benefit from this leadership development day. Space for the conference is limited and the registration deadline is October 31st. It is recommended that interested clubs submit registration information for their students as soon as possible. ### ROTARY CLUBS AND THE IRS

For many years, the District warned our Rotary clubs and Foundations of the end of the old rule that clubs with less than \$25,000 of gross revenues (dues, meal fees, plus fundraising) did not have to file returns with the IRS as of fiscal years that ended in 2008. We had a number of clubs that failed to do this and they lost their non-profit status. After arduous efforts, all have settled with the IRS and are non-profits once again.

This year we have had several clubs receive letters (and one received two \$1,800 penalties) for not filing in subsequent years. They are currently negotiating with the IRS to resolve this.

Please note the following from the IRS (it has been edited to apply to Rotary Clubs):

e-Postcard (Form 990-N) - Electronic Filing Requirement for Small Tax-Exempt Organizations - Annual Electronic Notice: Small tax-exempt organizations (those normally with annual gross receipts up to \$25,000 (\$50,000 for tax years ending on or after December 31, 2010) are required to file an annual electronic notice, Form 990-N, Electronic Notice (e-Postcard) for Tax-Exempt Organizations not Required To File Form 990 or 990-EZ. This filing requirement applies to tax periods beginning after December 31, 2006, and applies to organizations that previously were not required to file returns.

## PDG JAN MCELROY NOW A CERTIFIED PRESENTER FOR THE CLIMATE LEADERSHIP CORPS

Past District Governor Jan McElroy spent 3 days in San Francisco this month training to be part of the network of grassroots presenters on the climate crisis. Jan first became of aware of the warming trends in the earth's oceans and the changes in the atmosphere when taking courses in Marine Biology at Scripps Institute of Oceanography in La Jolla, California in the '60s. As a former biology teacher who taught the subject from the environmental point of view, she has maintained an active interest in the growing data from multiple scientific fields confirming the fact that climate change is real and that it is driven by human activities. Global warming due to human-made gases, mainly CO<sub>2</sub>, is already 1.44°F and disastrous climate impacts are growing worldwide.

Jan said, "We can't wait until it goes any higher, before we start doing something. We have to act now-and every day thereafter.'

Jan is now a certified presenter for the Climate Leadership Corps -- a network of over 4,500 volunteer who have been trained through the Climate Reality Project to deliver presentations about the climate crisis to people around the world.
