



Key Passages from The Chartering Agreement

The Local Council agrees to:

 Provide primary general liability insurance to cover the Charter Organization, its board, officers, Charter Organization Representative (COR), employees, and adult volunteers for authorized Scouting activities. Indemnify the Charter Organization in accordance with the resolutions and policies of the National Executive Board of the Boy Scouts of America.

"The general liability policy issued to the Boy Scouts of America provides primary liability insurance coverage for all chartered organizations for liability arising out of their sponsorship of a traditional Scouting unit. Evanston Insurance Company provides the first \$1 million per occurrence coverage. Additional policies, all providing primary coverage to the chartered organization, have been purchased so that more than \$10 million in primary coverage is provided. There is no coverage for those who commit intentional or criminal acts. Liability insurance is purchased to provide financial protection in the event of accidents or injury that is neither expected nor intended."

The Charter Organization agrees to:

- Use Scouting to further the Charter Organization's aims and values for youth.
- Charter organizations must utilize the Scouting program to accomplish specific objectives related to one or more of the following: youth character development, faith-based youth ministry, career skill development, community service, patriotism and military and veteran recognition

- Weekly Troop Meetings -- Thursdays, currently 7-8:30pm in Acton but check the calendar for locations updates - if there's school that day, we meet
- Monthly outings -- As announced on the website calendar
- Patrol meetings -- As coordinated by the patrol
- Patrol Leaders Council (PLC) -- Monthly during school year, second Monday of the month;
 listed on scoutlander calandar
- Adult Committee Meeting -- Monthly during school year, Wednesday after PLC usually; listed on calendar
- Annual Summer Camp (Wanocksett) first full week of Aug ('week 6')
 - Dublin, NH, right next to Mt Monadanock
- Possible Summer outing
- Annual Planning Conference (APC) -- once a year in Aug or Sept

Service Projects

- Annual Fall & Spring Cleanups at the Church (Acton)
 - Troop-wide events with ~20 folks raking and leaf-blowing
- Eagle Projects
 - Eagle scout projects have rigorous requirements for organizing & leading the project with the beneficiary, with the BSA, and with the crew
 - Recent example: Picnic Table building for public space in West Acton
 - Upcoming example: Gravel path building in Auboretum to ensure handicap access
 - Upcoming example: Free STEM-orient learning event for K-6 hosted in the spring
- Individual community service hours required for most ranks
 - Usually organized indivdually with Scoutmaster approval
 - For example, Star rank requires 6 hours of service

Advancement

- Scouts advance via rank & merit badges
- First Class and up scouts sign-off with an 'initial' in the book for most rank requirements
- Merit badge counselors approve meritbadge requirements
- All Ranks require a Scoutmaster Conference
- Tenderfoot and up also require a Board of Review with the Committee
- Advancement Chair records advancement in Scoutbook & procures the badges
- Awarded/presented at Court of Honor (2-3x per year)

- Eagle (0 current)



 - Two-person rule applies always include a parent & an adult leader on messages




Logistics



- The Rotary approves all adult members
- All adults going on overight Troop events must have taken BSA Youth Protection Training (YPT)
 - CORI had been required when we could get them via St E's but now we are still looking for a way to get CORI's
 - This is a Troop Rule
- All adults regularly working with youth should be BSA members
- Any adult attending an event for 72+ hours must be a BSA registered member (e.g. Camp Wanoksett)
- Josh Haines, Committee Chair, can help with this
 - Records stored here:

Youth Protection Training (YPT)

- All adults working with youth and/or going on overnight events must have YPT training that is current (w/in the last 2 years)
- Key Tenets or "Barriers to Abuse"



Adult Supervision

Responsibility Shared responsibliites

Adult leaders and youth members share the responsibility for the safety of all participants in the program, including
adherence to Youth Protection and health and safety policies. In addition, adult leaders are required to adhere to the
Scouter Code of Conduct.

One-on-one contact between adult leaders and youth members is prohibited both inside and outside of Scouting.

either in person, online, over the phone, or via text. Two-deep adult supervision by registered adult leaders 21 years

"Two Deep" Leadership at Events & No 1-on-1 Contact at all

Accommodations Seperate Accomedations for gender and ages (>2yr difference)

 Separate accommodations for adult males and females and youth males and females are required for tenting, lodging, and restroom facilities. Youth sharing tents must be no more than two years apart in age. In addition, Adult participants age 18-20 are treated as adults and cannot share tents with youth participants.

Program Requirements Buddy System & Transprent Program

 Adult leaders emphasize the buddy system in unit planning, and training activities. Buddies must stay together during activities. Scouting is a transparent program with parental involvement.

Reporting Requirements Strict reporting requirements for bullying & abuse

 Adult leaders and youth members have a responsibility to recognize, respond to, and report All Youth Protection violations and abuse including, mandatory reporting to law enforcement.
