#### I Gave to Rotary—and Rotary Gave Back

When I was President of the Rotary Club of Pittsburgh in 2010-2011, my then soon-to-be husband, Jerry Bruce, faced a battle with stage-four cancer and impending major surgery. I was living in Pittsburgh and he still resided in his long-time home in Ohio, except—best case scenario—he was facing an extended hospital stay. I wanted to be with him as much as possible—but I did not want to shirk my President duties. As a result, I pretty much lived on the highways between the states, and kept my Rotary clothes in the car, to make quick changes for Rotary meetings and everything else that went into juggling my consulting business while I was on the road.

Everyone's cancer experience is different. In our case, the situation was tense and overwhelming. We prayed the Rosary together and stayed close, with long weekend support from Jerry's adult children, who flew in from CA, MA, DC and MD. The Bruce tribe knew their father and I would need ongoing post-surgery support and care. For me, I was experiencing internal turmoil and showing external calm as we approached a soon-to-be twelve-hour procedure. So many unknowns ... so many fears.

I reached out to legendary Rotarian Lou Piconi (now deceased) for a contact in District 6330 who might own a car rental agency offering favorable rates, because airport rental cars were so expensive. At that time, Jerry had a company car but his children weren't covered by that insurance plan. Lou told me not to worry.

The next day, RI Trustee and Lou's great friend, Mike Johns, visited us at Cleveland Clinic. Jerry was being prepared for surgery. Mike asked me to step out for a quick hospital lunch. I wasn't eating or sleeping much, and I welcomed the respite. As soon as we sat down, he smiled and shared that I was not alone and that a delightful and caring lady, Jane Swan, of the Rotary Club of Fairlawn, OH, was offering her support, by lending us a vehicle. He handed over a set of car keys and told me that the vehicle was now located in Jerry's driveway for use by the family for as long as we needed it. I can't say enough about how incredibly blessed I felt.

The thoughtfulness, generosity and support that came to us this way buoyed us at so many levels. After the surgery, Mike Johns came to our rescue again by facilitating our admission to an assisted living facility, run by another Ohio Rotarian, to help in Jerry's recuperation.

We returned the car to Jane with our love and gratitude, and new replacement brakes!

Oh, yes...Jerry made an impressively positive recovery; we have since been married four years. Jerry is now a Rotarian of the Rotary Club of Bedford, Ohio. He actively supported my year as District 7300 Governor in 2016-2017.

#### A Surprising Way Rotary Gave Back to Me

When Linda Fischer Bruce stepped in as District Governor not too long ago, I had already agreed (happily) to serve as one of her Assistant Governors, when I realized she did not yet have a newsletter editor or newsletter staff. Taking a deep breath, I said, "Linda, I'll do it!" She agreed.

It was one of those "How am I going to do that?" moments, but I didn't let on. Inside my head, I knew I had a steep learning curve ahead. I purchased Adobe Pro software and learned how to do cool stuff like file size reduction, optimization for web and mobile--practical desktop publishing stuff I knew nothing about before.

#### What I didn't realize was the professional benefit I would reap from this.

A few weeks ago, under terrible time pressure, one of my technology company clients needed to produce certain due diligence documents to corroborate positively settled lawsuits, for review by an incoming new institutional investor. The company needed literally hundreds of legal documents back from me, basically by return electronic mail, to provide consolidated single pdf files with hundreds of pages each. All I had to work with was an endless series of individual documents, some from the courts, some from my associated litigation counsel, and some from my client.

If I hadn't learned Adobe Pro skills to work on the District newsletter, I would NEVER have been able to "stitch together" all these legal documents AND THEN to reduce the file sizes to something that would transmit by e-mail, and get it all done in a super short time.

#### A Dedicated Past District Governor

What was that whirlwind that flashed across District 7300 from July 2016 to the end of June 2017? Was it a bird? Was it a plane? No, it was super District Governor, Linda Fischer Bruce.

Most members of District 7300 were impressed by her devotion to Rotary, her willingness to help all clubs, her leadership skills and her quiet energy. Those who weren't impressed weren't paying attention.



Linda has always worked hard. She has achieved success that has been widely recognized. She served as the Rotary Club of Pittsburgh President during its Centennial Year in 2010-2011. She chaired the Pittsburgh Rotary Foundation in 2011-2012. She served as Assistant Governor in 2012 to 2014.

With the Rotary International theme of "Building Communities and



Bridging Continents" Linda and her Pittsburgh Home Club focused on "Rebuilding Pittsburgh One Block at a Time." They coordinated two projects. One was a large sign stating "Welcome to Uptown." The other project was a successful Mentorship Program for Stowe Rocks High School.

Linda received the Rotary International Presidential Citation with Distinction and Significant Achievement Award in 2011 for fellowship and service. As District Governor 2016-2017 Linda received a Certificate of Recognition, as well as being acknowledged for assisting District 7300 towards its Centennial Foundation goal of raising 1.2 Million for doing good in the world.



Linda grew up on Pittsburgh's North Side in the

Observatory Hill area and attended Perry Traditional Academy. Upon graduating with a diploma in Business, she became a Secretary, then a Legal Secretary/Administrative Assistant while attending night classes at Robert Morris University. She graduated in 1980 with a Bachelor's degree in Business Administration. Wanting to continue her education, she completed her Masters in Business Education from Robert Morris University in 1994.

Her first professional job was with Westinghouse Credit, liquidating a surface coal portfolio. Then she progressed to Commercial Real Estate before becoming intrigued with selling telecommunications systems. She started her first consulting practice in 1987, which evolved into McKinley Group, Ltd. in 1990.

Linda is the president/owner of the McKinley Group, a certified Women Business Enterprise, which provides independent telecommunications expertise focusing on School Districts. She assists them in the procurement of voice and network services. Linda has launched three tech-based companies sustaining success with McKinley Group, Ltd.

Always having a desire to challenge herself, she facilitated workshops and seminars in Leadership and Organization which resulted in being invited to become an adjunct professor at Point Park University. This has become her dream job and one that she fully embraces. She teaches freshmen public speaking and presentation skills.

Linda gives me credit for introducing her to Rotary in the fall of 1995. She says that Rotary has changed her life. Because of her hard work with Rotary, many lives have been positively affected. She has recruited a good number of new Rotarians, thus multiplying her impact.

To add to all that, Linda received the 2013 Woman of Integrity Award presented by Pittsburgh Professional Women. She has certifications in women in crisis intervention and protective services counseling. She was involved in delivering Meals on Wheels for ten years and continues to provide Elder Advocacy services. Seems she's wired to work tirelessly, volunteering in her local community fund raising efforts, and in supporting church based activities.



#### Rwanda Reflections

It's been a while since I posted observations from Rwanda, so this post is meant to get you caught up on our activities and observations. Amy began teaching English classes for the teachers at Urukundo Learning Center last week. I've been playing a support role in that effort, but I couldn't help her when a major rainstorm caused such a din on the metal roof of the classroom on Thursday (the second day of class) that she and the teachers couldn't hear each other speak for an hour. She had to give them a writing assignment to do during the storm and only resumed teaching once the storm had abated to a light shower. This is the rainy season, so we anticipate more problems before classes are over. They wrap up on Friday the 19th at the end of the school's semester break.

Once the English classes are finished for the teachers, Amy will begin working with staff members (all of whom have some skill in English) and the sewing center staff (who have no familiarity with English).

I have been writing job descriptions for the positions at Urukundo Village and now will move on to writing them for the Learning Center and Sewing Center. I am also putting together performance evaluation forms for use by managers. Once school begins on January 22, I will be doing classroom observations and providing feedback for teaching improvement. I am also working with the ICDL Foundation in Kigali on marketing and funding (grant exploration) issues as well as working with Urukundo's ICDL program.

It has been good to finally focus on our purpose for being here after using our first two months to become acclimated to the culture and rhythms of Urukundo Village. During the month of November, we lived in the main house with Mama Arlene and spent a lot of time with the kids. We ate breakfast with Arlene, but lunch and dinner with the kids. Institutional food, heavy on the starch, wasn't our cup of tea, so we didn't find many of those meals appealing. Devotions are held every evening, and we attended those with the children. Singing, dancing and a Bible lesson or story with a moral provides the mainstay for devotions. Songs are mostly in English, but the lessons mostly in Kinyarwanda, so we were in a fog for a good bit of the time unless a visitor from the U.S. was leading devotions at the time. There were a number of visitors present during November, so we weren't the only "Mazungus" (Muzungu = white person) in the mix. Sunday worship services are lead by a pastor who is a full-time employee of Urukundo. Services typically last two hours with dancing, singing, prayer and Bible lesson in the mix. Half the congregation is from the surrounding village. The service is delivered in Kinyrwanda but translated by Olive for those of us who only speak English. The pastor also attends evening devotions with the kids and often leads them.

Amy spent time with the kids in the library and the computer lab during November and December. I spent some time in the computer lab with them in the afternoons, but soon passed that duty on to Amy so that I could focus on completing job descriptions and preparing Urukundo to market the ICDL program.

In December we moved into our house, a four-bedroom place that's a 5-minute walk from Urukundo Village. We now have privacy and cook our own meals with food that we purchase ourselves or have our "girl" purchase. Okay, so our privacy includes a guard who has his own guardhouse on the premises and a 22-year old girl named Beatrice, who cleans, cooks, and watches the house during the day hours when the guard is off. Only recently have we asked her to cook some meals for us, since we

were tired of eating Rwandan food and made meals that were foreign to her. Watching her make her food made us realize that the food that we ate at Urukundo was institutional and not always representative of Rwandan home cooking. Beatrice's living quarters are on our property, but in a separate building behind our house. Our property is enclosed by a wall with broken glass on the top to deter robbers. In addition to the two buildings and guard house, there is a garage and a garden that is home to lettuce, beans, maize, cabbage and cucumbers. There are no deer or rabbits to interfere with our harvest and no need for pesticides.

December was a time of adjusting to our new home, new relationships and living conditions. We were also busy helping Urukundo prepare for the Christmas holiday as they commit to hosting three separate parties: one for staff and their children (around 200 people), one for the community (500+ people), and one for the children of Urukundo Village (29+). Amy and I have committed to doing "A Course in Miracles" during 2018. There are 365 lessons, so we are doing one a day and have kept up with it so far. Their website is www.acimi.com if you are curious. Being rather isolated in a foreign country seems like the perfect setting for the life altering experience that this course offers. We are also committed to completing a 1000-piece puzzle that we started on Christmas Day. Well, I am anyway. It's level of difficulty should make it last to at least mid-January.

The weather has been cooler than expected. Yes, we are near the equator and happy not to be in Pittsburgh where cold, wind and snow are the norm, but I have been wearing a sweater in the morning and evening recently. Today is particularly chilly with clouds sitting on our hilltop and temperatures in the high 50's to low 60's. Glad I brought warm clothes along with my summer togs.

I'm going to stop here, to give you a break and start on the next post.


