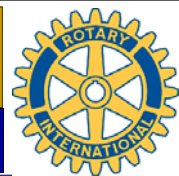

Virginia and I would like to extend my warmest wishes to our Rotary family and friends for very happy holidays filled with peace and love.

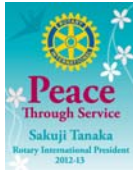

The club is responsible for nominating the individual. The deadline for the submission of the paperwork is December 31, 2012. Please submit the completed application for the 2015-2016 Governor to:

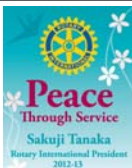

CALL FOR DISTRICT MATCHING GRANTS

Through Matching Grants, The Rotary Foundation matches contributions raised for international service projects by Rotary clubs and districts in two or more countries. The Foundation provides a one-to-one match for District Designated Funds (DDF) contributions and a US\$0.50 match for every new \$1 cash contribution. DDF is allocated each Rotary year based on the annual giving of clubs to The Rotary Foundation. Matching Grant awards range from \$5,000 to \$25,000 and Competitive Matching Grants range from \$25,001 to \$200,000.

Matching Grants are exciting to work. They are one of the best ways to see Rotary dollars in action. Matching Grants projects are based on international partnership: Rotary clubs / districts in at least two countries must work together to plan, implement, and complete a sustainable project. Donated dollars are leveraged within the Matching Grant process to optimize funding. As a result this process must be managed diligently and thoroughly by those involved. The management and progress of the grant will be overseen by the club and monitored by the district. The application must be approved by the District and reporting requirements of The Rotary Foundation, must be fulfilled.

At the present time, for the remainder of this Rotary year 2012-2013, we still have District Designated Funds available. If you have an ongoing relationship with Rotarians in another country but just haven't made application for a Matching Grant, you are a good candidate for funding. The key is to file an application and have three key Rotarians, in each country, to manage the grant project from start to fruition. This is an absolute requirement for success. We, at the district, encourage you to file your applications, as soon as possible, for funding this year.

Rotary clubs serve communities around the world, each with unique concerns and needs. Rotarians have continually adapted and improved the way they respond to those needs, taking on a broad range of service projects. As a suggestion for project ideas, you may want to focus on Rotary's six areas of focus ranging from lack of access to clean water to the need for immunization that prevent deadly diseases.

The most successful and sustainable Matching Grant Rotary service projects tend to fall within one of the following six areas:

Peace and conflict prevention/resolution

Disease prevention and treatment

Water and sanitation

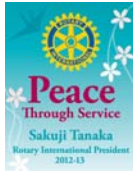
Maternal and child health

Basic education and literacy

Economic and community development

Rotary International and The Rotary Foundation recognize these six areas of focus as or-

They are included in the application. For ideas, you may find consulting the publication Rotary's Areas of Focus very helpful.

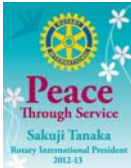

DISTRICT SIMPLIFIED GRANTS

District 5790 Rotary Clubs have a proud tradition of supporting The Rotary Foundation (TRF). When we support TRF, some of those donated funds after 3 years are distributed to District 5790 to be used for District Simplified Grants that clubs can use for their own club projects. Clubs prepare a budget for their proposed projects and submit for approval of a district simplified grant in which the club pays 50% of the project and the district simplified grant pays the other 50%. The district simplified grant committee discusses and approves the matching grant for all qualifying projects and clubs. To qualify, all the clubs members must participate in the TRF Every Rotarian Every Year program.

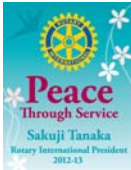
During the 2012-2013 Rotary Year, 28 clubs qualified and were granted a total \$30,068 for their projects. The maximum awards were matching grants of up to \$1,200.

This years DSG projects are as varied and innovative as our clubs are. 13 clubs distributed over 10,000 dictionaries to 3rd & 4th graders throughout our district.



Three clubs used their matching funds to purchase back packs and school supplies for needy students returning to school. Two clubs used their district simplified grant to help fund water harvesting projects in their communities. Two clubs used their grant to help fund small international projects south of the border. There are two district clubs that are funding boot camps for new college students to give them a better chance at success in college. Another club used it's grant funds to provide training equipment for a local CASA volunteers dedicated to serving the needs children that are victims of abuse. Yet another club is using it's matching grant to purchase travel kits for foster children that have been uprooted due to family circumstances. These kits will contain a stuffed animal, a pillow etc that the children can take with them to their new foster family. Still another club is using it's matching grant to arrange a picnic where prospective adoptive parents can meet prospective adoptable children. And lastly, one club has used it's matching grant funds to arrange for pet food for the pets of shut-ins that receive meals on wheels.

When you see the great thing Rotarians are able to accomplish with matching grants through the District Simplified Grant program, it makes us all proud to be part of such a wonderful organization. Prouder still are those of us that donate regularly to TRF because we know the funds went to great causes right in our own back yard.



THE PERMANENT FUND OF THE ROTARY FOUNDATION

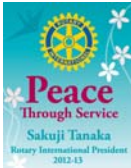

Most of the time, when we think of the Permanent Fund, we think “Legacy.” Because many Rotarians wish to be remembered after they are gone by establishing a named program through the Foundation in their estate plans. We believe that the long term results of a stable foundation will live for generations to come and demonstrate to future generations of our own personal desire to indeed, make this a better world. That is exactly what the Permanent Fund will do.

Of course, cash donations to the permanent fund will accomplish the same end. I should mention that while donations (cash or estate plans) to the Permanent Fund do not accumulate Paul Harris Fellow credits, they do accumulate benefactor recognition for the donor. It is also important to note that the permanent fund is just that- permanent. The principal is not spent- ever. Just the investment income is intended to be spent. And the higher the contribution to the Permanent Fund, the more options that the donor has. For example, at a level of \$ 250,000.00, the donor could designate the income from her or his contribution be credited to a Rotary Peace Scholar scholarship. There are many programs and levels available.

The basic or beginning level is \$ 1,000.00 included in your will. Your recognition will make you a “Benefactor.” Really, all Rotarians should be a Benefactor. The heirs will not miss \$ 1,000.00. The next level is \$ 10,000.00 and the donor is recognized as a member of the “Bequest Society.” Again, most Rotarians could easily include that amount in their will to the Permanent Fund with very little effect on the entire estate. There are numerous levels within the Bequest Society recognition. But what is most important is the good that their legacy will do in the world. Peace and conflict resolution, clean water and sanitation, maternal and child health, disease prevention and treatment, basic education and literacy, and economic and community development.

So, when you are making your estate plans, or if you have received a lump sum from the sale of stock, a business or some other large lump sum and have a tax burden, look at how you can insure the future of the Foundation. You will help insure that our Foundation remains permanent, and you will be remembered for it.

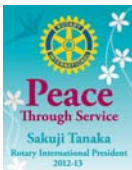

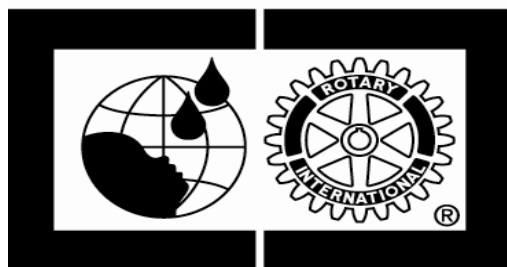

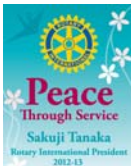

FUTURE VISION...

After reading the opening letter of the Rotarian recently, I thought a look at the past might help our readers understand Mr. Sakuji Tanaka's message about the future. His concept of "6 parts to Future Vision" was very interesting.

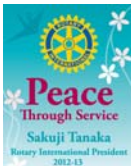
One of our own former President's, Barbara Lucas, (Arlington, Texas North Rotary-2005/2006) was the source of an interesting tale back in 2003. But let her describe the story in her own words:

"In November 2003, my husband, Ken, and I flew to Guatemala City to see the country and use a week in a time-share I had won through Arlington North Rotary. I chose Antigua, Guatemala as our final destination after our two-week tour of the ancient Mayan cultural sites. On our first evening in town we discovered the small Rotary club meeting at a nearby hotel restaurant. They were so cordial; there was instant rapport despite our deficiencies in Spanish. We also met Rotarians from Canada who were there to visit their shared water project in the hillside villages. We were asked if we wanted to see what was going on, and we jumped at the chance to see the authentic Guatemala and learn more about Rotary international projects.

The next morning we all boarded four-wheel drive vehicles and went up into the mountain villages surrounding Antigua to see their completed water project at the top of a large hill near the local schoolhouse bringing fresh water to the village for the first time. Then we were asked if we wanted to visit their stove project. We stopped at a small hut with soil as the floor located on the side of a green hill. The lady of the home graciously said we could visit, but asked us to wait until she "straightened up" the one-room house. She was so proud of her new stove and her home. Meanwhile, her children and the chickens ran around outside.

Stoves fuelled by wood were designed by local engineers and were set on 11 concrete blocks at working height topped by a metal grid for cooking. The stove is safe to touch except for the cooking plate. The smoke was vented outside through a chimney pipe. Thus, it eliminated many respiratory problems, the second largest cause of death in the country, as well as lung and eye diseases. Likewise, it made open fires, which had caused children many serious burns, obsolete. In addition the stoves used 70% less fuel than open fires on the floor, helping to slow the rapid deforestation of a beautiful mountainous area and significantly decreased the 20% of a family's income spent for purchased wood. Most women were able to pay for their own concrete blocks. The project was successful because it involved not only the local Rotary Club in town, but also native community organizers who recruited and trained the women involved and were there to follow up. It is my understanding that some women, because of the time saved preparing meals using the stove, were able to sell homemade tortillas in the local market and also do handicrafts to supplement their families' income.

Our club ended up doing two stove projects using district matching grants, the first in 2004 helping 187 families, and the second delivering another 200 stoves in 2005 and developing a twin club relationship with the Antigua Rotary Club District 4250.

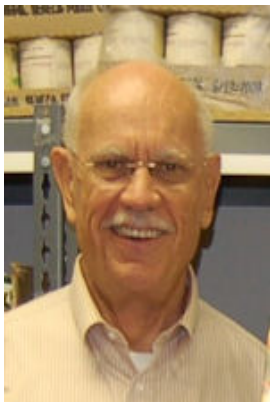

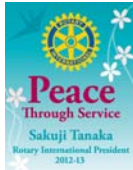
We have teamed up with Carter Blood Center to have people spend two days at the mall encouraging people to give blood.

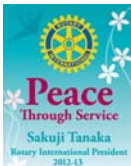

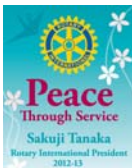

The Rotary Club of HEB just completed its second annual Dictionary Project to benefit the Hurst-Euless-Bedford ISD. The Club has supported public education and literacy for many years, with Rotary Readers visiting HEB ISD elementary schools. Last year the Club increased its commitment by giving each third grade student in HEB ISD – nearly 1,700 – their own personal student dictionary.

This is not just a dictionary. It is a gazetteer, or geographical dictionary, that includes maps of the world, a chapter on planets, the Declaration of Independence, the US Constitution, biographies of the US Presidents, Periodic Table of Elements, multiplication tables, the American Sign Language alphabet, and more.

Each year the Club President appoints a Dictionary Project chair who assembles teams of Rotarians to visit half of the 19 elementary schools in HEB ISD. Our project partner, the Mid Cities Pacesetters Rotary Club, delivers books to the remaining schools. This year's chair is Bob Sarpalius. He contacted each campus principal to set a date and time for delivery and then teams signed up for campus visits.

This year the Fort Worth Community Credit Union purchased the dictionaries and donated them to our Club so that this project did not impact the budget. Representatives Brandy Scarlett and Kat Chang visited one school and helped deliver books.

The children love their books. The content is rich enough to be used for many years in their school career. There are 21,600 students in HEB ISD and 56 percent of them receive free or reduced lunch, which places many of them at risk at an early age. Having a book they can call their own and that can help them academically goes a long way to keep them engaged in school.

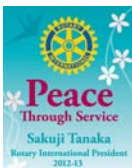
Our Club's Board of Directors recently met with Governor Hollis Lackey and presented reports on activities that are in progress, have occurred, or will soon occur, which included the following:

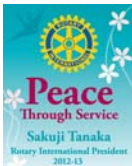
