There are now 27 Interact Clubs and 2 Rotaract Clubs in our District. Efforts are underway to establish several new Rotaract Clubs. DG Paul has set a goal for two new Interact Clubs and two new Rotaract Clubs this year, and that looks like an attainable goal.

Rotary is based upon high ethical standards, fellowship, and service to others, both locally and internationally. These are powerful ideals that we all strive to teach our children. Interact and Rotaract are structured ways Rotary has developed to help inculcate these values in our youth. In District 5790, we are fortunate that so many Rotary Clubs...and so many members within those Clubs who have agreed to serve as Sponsors have accepted...the responsibility to sponsor these important New Generation services.

In addition to creating some new Clubs and re-energizing others, as District Interact/ Rotaract Chair, I have some other goals. Every Club has great ideas for developing membership, finding ways to serve their community, developing international projects, or how to energize their Club. These ideas should be shared with others so that other Clubs could also benefit and grow. For example, one Club is seeking permission from their school to have an Interact presence when other students come to get their text books (Book Days), so they can make others aware and recruit members. An electronic Interact Newsletter would be an easy way to circulate these ideas through the District, as long as Clubs are willing to share.

Although it is short notice, and is still preliminary and tentative, we are trying to organize a District Interact Conference for Interactors during the time frame of Interact Week in the RI calendar (1st week of November), which seems like a great way to jump-start the new year. We have contacted several other Interact Clubs to ask their participation in the planning. As of now, we are working towards a one day event, tentatively October 30, in Weatherford. The goal is to make it a youth-centered day, with fun and fellowship, as well as some learning. RYLA leadership has agreed to participate. It would be a fun way for our young people to meet others and to share their Interact excitement. We have already advised sponsors of the proposed event. Watch for details to be announced as plans hopefully come together.

RYLA—ROTARY YOUTH LEADERSHIP AWARDS

Think about spending four days with 100 high school kids at Leadership Camp. If your first thoughts are "that would be boring", or "no way, kids are rotten today", then you need to think again. RYLA is an awesome experience for the students attending, the Rylarian Counselors who are returning for a second, third or even fourth time, and for the more seasoned Rotarian Counselors and Staff who pull together to make everything happen smoothly, on time, and with plenty of excitement.

Complaints heard most often all concern...lack of sleep – and no, that is...not a complaint from the Rotarians, that is the complaint from the students! Camp begins at 7:30AM and the day continues until after 10:00PM and includes events, activities, lots of action and plenty of food.

As most of us begin our weekly Rotary meeting, RYLA days begin with one group leading the pledge a prayer and the Four Way Test. Each group chooses an outstanding leader from the day before and then we are off. Off to learn about Rotary, experience leadership and team building games, participate in group discussions about how and why activities had certain results. There is time for physical activity and time for seeing Rotary in action with a service project. Rotarians have the opportunity to share their own Rotary stories, answer questions and ask more probing questions of the students'. Students learn about Polio Plus, scholarship opportunities, other Rotary Projects, City Leadership, State Leadership, proper dining etiquette, and have time to make friends with other students of similar age. Oh, they also have to work together to create a skit interpreting the Four Way Test. No wonder they want nap time scheduled in.

RYLA is just one way Rotarians teach young people about Rotary and leadership. The yearlong preparation by the RYLA Committee is well worth the time and effort; and if you ever doubt that our future is not in good hands, then you just might need to come to RYLA yourself and see the awesome young leaders that clubs around the District send. Because of the widespread District participation and the generosity of so many clubs, and Rotarian and Rylarian volunteers, RYLA truly is an amazing event and an awesome experience for our young leaders.

On Aug. 20, 2010 Camilo Castro left Santiago, Chile on a 10-hour non-stop flight to DFW to meet his new host family, Perry and Lorna Hoover and his Rotary Club Sponsor, The Kennedale RC.

Meanwhile, at DFW, Drew Marshall sponsored by the Metroport RC was taking off for his 10-hour flight to Santiago to meet his new host family, Hortensia and Ennio Aguirre and his 11 year old host brother, Cristobal from Curico, Chile, a city south of Santiago.

That night, flying near Columbia in northern South America these two boys crossed paths at about 40,000 feet some miles apart and at different altitudes being linked by one common experience, the Rotary Youth Exchange Program. They also linked us. During this summer we had American students in Europe, European students in District 5790, an international student who returned home from around the world after spending a year with us and our students returning home with new perceptions of the world after being gone for almost a year.

Now, we have a new group of students who just arrived. More on them next month.

Right now, lets plan to give our students in this district an opportunity to participate next year in either a short term summer exchange or a long term year exchange to countries as diverse as Brazil, Taiwan, Finland, France, Germany or Denmark to name only a few. This is the deal.

Starting in September, we hope that Rotary Clubs all over the district will inform their high schools and students about our Youth Exchange Program. If you do not have our new Youth Exchange posters for schools, we can get you some. Phyllis Catton, Southlake RC, is the District Committee Chair for our Outbound Program and Gary McNeil, Arlington South RC, is working with her to help clubs interested in recruiting students for our program.

We now have a 10-minute video for American students. It is posted on our district website under International and then click on Youth Exchange. We also have a lot of other information posted there as well. We will have posted shortly a new short preliminary application form that will be used by Clubs and the District for interviews

New RI Club Builder Award Nominations Due Soon

Who will be your Club's nominee?

It's time to start thinking about the newly created Club Builder Award. This is a very prestigious award which will be given to only one person in each District.

<u>BUT</u> nominations will be due from the Clubs to the District Governor very soon... October 15.

<u>BUT</u> there are specific guidelines to follow to determine who will be suggested as Club Builder from each Club.

The nominee from a Club must be recommended by three past Club presidents of their own Club or of a past Club if the nominee has belonged to his/her current Club less than three years.

DG Paul will then convene a panel of PDGs to determine the one person's name to be submitted to RI for their consideration.

For example:

- The nominee must be in good standing with at least ten years' membership in the current club or a total of ten consecutive years in more than one Rotary Club.
- The nominee must have served as Club President.
- The nominee must be in a Club with at least 30 members in the three years immediately preceding the nomination. *Our District has 36 Clubs that qualify.*

The RI Club Builder Award is designed to recognize Rotarians who:

- Have personally <u>recruited at least five members</u> during the past three years who are still active Rotarians at the time of nomination.
- Participated in Rotary training in their Club during the past 12 months.
- Participated in at least <u>one meaningful club-level vocational service project</u> during the past 12 months.
- Attended at least <u>two district meetings per year</u> in the three years immediately preceding the nomination.

There are so many outstanding Rotarians in our District who meet, nay, even surpass these requirements. Our Clubs will be remiss if we fail to send a nomination to DG Paul by October 15. SOMEONE IN OUR DISTRICT NEEDS TO BE AMONG THE FIRST GROUP OF RI CLUB BUILDER AWARDS!

We need to make our voices heard and our light shine. It is surely inconceivable that other Districts could have better programs and Rotarians to implement them! Right??!!?

FRIENDSHIP EXCHANGE

Friendship Exchange programs with Rotary International are simply a vehicle to foster and expand the principles of Rotary: Fellowship. The Rotary Friendship Exchange program gives Rotarians and their families the opportunity to host and visit Rotarians around the world. In addition to experiencing other cultures and making lasting friendships, an exchange provides a strong foundation for carrying out other international activities and service projects. The primary goal of a Friendship Exchange is to build greater international understanding and goodwill among Rotarians and their families. In addition, exchange participants can:

- Learn how their vocations are practiced in other parts of the world;
- Observe new customs and cultures;
- Promote an appreciation of cultural diversity worldwide

There are two main types of Friendship Exchanges: the visitor exchange and the team exchange. In both types, the participating districts agree upon the number of people or couples participating, length of stay, and other details. Rotary Friendship Exchanges are expected to be reciprocal.

Visitor Exchange: The visitor exchange gives individual Rotarians, who may be accompanied by family members, the opportunity to spend a few days in the home of a Rotarian in another country. The typical visitor exchange lasts from three to seven days.

Team Exchange: The team exchange allows several Rotarians or Rotary couples to travel to different communities in a host district for a period of up to one month.

Univocational Exchange: A unique aspect to incorporate into either the team or the visitor exchange is the univocational exchange, where both the guest and host Rotarians are members of the same profession. A univocational exchange gives participants the opportunity to explore a common interest.

Volunteer/service Exchange Volunteer or service exchanges include opportunities for visiting Rotarians to participate in the service activities of a host club during an exchange.

This year we have two current Friendship exchanges taking place one from India and one from Mexico. They are simply visitor exchanges. The current list of District Friendship Exchange Chairs can be found at the Rotary International website. IRS OFFER—SMALL CHARITIES

WASHINGTON — Small nonprofit organizations at risk of losing their tax-exempt status because they failed to file required returns for 2007, 2008 and 2009 can preserve their status by filing returns by Oct. 15, 2010, under a one-time relief program, the Internal Revenue Service announced today.

The IRS today posted on a <u>special page of IRS.gov</u> the names and last-known addresses of these at-risk organizations, along with guidance about how to come back into compliance. The organizations on the list have return due dates between May 17 and Oct. 15, 2010, but the IRS has no record that they filed the required returns for any of the past three years. "We are doing everything we can to help organizations comply with the law and keep their valuable tax exemption," IRS Commissioner Doug Shulman said. "So if you do not have your filings up to date, now's the time to take action and get back on track."

Two types of relief are available for small exempt organizations – a filing extension for the smallest organizations required to file <u>Form 990-N</u>, <u>Electronic Notice (e-Postcard)</u>, and a <u>voluntary compliance program (VCP)</u> for small organizations eligible to file <u>Form 990-EZ</u>, Short Form Return of Organization Exempt From Income Tax.

Small organizations required to file Form 990-N simply need to go to the IRS website, supply the eight information items called for on the form, and electronically file it by Oct. 15. That will bring them back into compliance. Under the VCP, tax-exempt organizations eligible to file Form 990-EZ must file their delinquent annual information returns by October 15 and pay a compliance fee. Details about the VCP are on the IRS website, along with frequently asked questions.

The relief announced today is not available to larger organizations required to file the Form 990 or to private foundations that file the Form 990-PF.

The IRS will keep today's list of at-risk organizations on IRS.gov until Oct. 15, 2010. Organizations that have not filed the required information returns by that date will have their tax-exempt status revoked, and the IRS will publish a list of these revoked organizations in early 2011.

Donors who contribute to at-risk organizations are protected until the final revocation list is published

The <u>Pension Protection Act of 2006</u> made two important changes affecting tax-exempt organizations, effective the beginning of 2007. First, it mandated that all tax-exempt organizations, other than churches and church-related organizations, must file an annual return with the IRS. The Form 990-N was created for small tax-exempt organizations that had not previously had a filing requirement.

Second, the law also required that any tax-exempt organization that fails to file for three consecutive years automatically loses its federal tax-exempt status. The IRS conducted an extensive outreach effort about this new legal requirement but, even so, many organizations have not filed returns on time. If an organization loses its exemption, it will have to reapply with the IRS to regain its tax-exempt status. Any income received between the revocation date and renewed exemption may be taxable.

Ending Polio is Rotary's number one project. What has your club pledged toward the project this year? Have you, personally, given to end polio lately? There is a way your club can generate donations to end polio and give your community a chance to help, too. Since people give to people, the process we suggest involves asking your friends, family, business associates, and area foundations and charitable funds to give to end polio. Almost every family in our country was affected by polio in the '40 and 50's so when you ask others to help end polio they will know how important it is to stamp out this dreaded disease. They will know the crippling effect and even death polio brought to their family and friends. Who would not want to donate to rid the world of polio?

Rotary has almost eliminated polio all over the world, but we are not quite there. We need just a few thousand dollars more. It is our job as Rotarians to "get 'er done". We can raise the money but we need to ask others to assist us. District Governor J. Paul Lucas has provided the leadership for each of our 65 clubs to ask for and generate donations for the District Polio Fund. Materials that will make it convenient for you to ask for donations are included in this newsletter and on the district website. They will also be available at the Membership /Foundation Seminar in Mineral Wells on August 14. However, if you need materials before then please contact Sharron Miles. The color form titled "World Polio Fund" has a place for any donor to indicate the level of giving comfortable for them. In the middle of the form is a place for donor information and at the bottom a place for them to use Master Card or Visa for their donated amount. Please ask the donor to make checks to The Rotary. Foundation and note that it is for the World Polio Fund. You should collect the checks you receive and send them to Sid Johnston as indicated on the line in the middle of the form. You will want your club to receive the credit with Rotary so be sure your club is identified with the checks you send to Sid. If you need current information about Rotary's efforts to End Polio see the "Talking Points" at the end of this newsletter.

Time is important in raising funds to End Polio. Rotary International has a goal of next spring. However District Governor Lucas says to be recognized at the World Polio Day Dinner on October 5th and the Foundation Banquet on October 6th checks need to be received before October 1, 2010. For recognition at the District Conference checks need to be received by March 31, 2011. To count in the yearly totals you will have until June, 2011.

You,... raise money? Yes, you can. The most important thing is to donate yourself and then ask others to join you in riding the world of Polio.

(You might want to consider sending this donation request to everyone on your e-mail list and ask them to send it to everyone on their list. The last person that I know that did this hoped for \$2,500 but received over \$25,000.)

VERNON ROTARY CLUB "CHILI FUNDRAISER"

As is the burden for every club across the nation, finding that niche fund raising event for the Vernon, Texas club has been no easy task. After many attempts to undertake an event that would catch on and be embraced by the community and prove a successful event for the Club, this past April the Rotary Club of Vernon, Texas finally hit a bases-loaded homerun!

April 10th, 2010 marked the first "Vernon Texas Community Chili Feed", organized and held by the Rotary Club of Vernon, Texas. It all started as a simple idea for a club fund raiser. What it turned into was two days of fun, fellowship and food.

To start things off, the club enlisted the help of some of the member's wives to each prepare a pot of chili using various recipes. The board then undertook the huge task of having a working board meeting to sample each of the chili's prepared to decide on the recipe to be used for our first community chili supper. While it was tough work, we were finally able to decide on the perfect recipe, by secret ballot. It was a close vote but we narrowed it down to the best based on taste, spice and texture.

We all know how to cook chili for 5 or even 10 people. But how about for over 500? We divided the responsibilities amongst the Chili Feed committee. One member was in charge of securing the chili meat, another bowls and spoons, etc. We sat down with a calculator, did a bit of quick math and PRESTO... Had our formula for the right amount of meat per person, per cooking pot. "What about beans?" somebody asked "I like them in Chili." Another responded, "But that is not how real 'Texas Chili' is made." So, we compromised. We cooked a separate pot of good-ole chili beans and offered them on the side!

Then the cooking day arrived. Bright and early the Friday morning before the chili feed several Club members showed up at the county auditorium kitchen and began "The Cooking of the Meat." It was quite an experience and a lot of fellowship was involved. We had many, many members show up to help and get involved that often do not participate. It really brought the club together.

The next day was the big event. I am proud to say that we sold out every bit of our chili, save one or two pints of take out. It was a huge success for our club and for our community. In fact, it was such a success we have decided to officially move our Chili Feed date to correspond each year in December with the Annual Lighted Christmas Parade. Folks will be able to come and eat warm chili before the parade starts and then head out to Main Street for the festivities.

We believe this project was a shining example of the 4-Way Test in Action. We truthfully fulfilled our goal of a fund raiser for the club through a fair for all event that was built on good will and friendship that was beneficial to both the Club itself and our community as a whole.

BROWNWOOD ROTARY CLUB "Past, Present & Future"

Woodrow Wilson, reflecting on the significance of our lives, once stated, "You are not here merely to make a living. You are here to enable the world to live more amply, with greater vision, and with a finer spirit of hope and achievement. You are here to enrich the world. You impoverish yourself if you forget this errand." The Brownwood Rotary club has spent more than 90 years enriching the community of Brownwood and has made a broad impact both in our nation and around the globe.

The Brownwood Rotary Club (#1770) held its first meeting March 19, 1920 while Woodrow Wilson served as president and is the second oldest club in Rotary District 5790. Fort Worth Rotarians, along with District Governor, Robert E. Vinson, President of the State University, visited Brownwood during September of 1919 to survey Brownwood as a possible site for a new Rotary Club. They met with a small group of businessmen and presented the idea of Rotary to them. The organization of the club was an outgrowth of a commission given to French W. Thompson, president of Daniel Baker College who had been a Rotarian in Kentucky.

By January 1, 1922, the club was meeting weekly and soon moved their luncheons to the Southern Hotel. During the first two years of the club's existence it became involved in several community projects. Members launched a tree planting program in Brownwood which resulted in more than one thousand pecan trees being planted in Brownwood. The club gave leadership to the establishment of the Boy Scout organization in Brownwood from 1921 to 1924. In addition, the members launched the idea of a public health service for the city and county during the winter months of 1920-21 that resulted in the establishment of health services in the area. The club also developed a campaign to finance the health services effort for the first few years and helped raise enough funds to fund the Red Cross for a year. In 1923, the first annual Boys Week was established in Brownwood.

Since our humble beginnings, the Brownwood Rotary Club has given countless hours of service and money in support of various programs in the community. Current projects include buying and distributing dictionaries to all of the third graders in Brown County, hosting an annual Arts & Crafts Show and setting out U. S. Flags in the downtown area six times a year. Additionally, the club awards scholarships to local area students who are graduating from high school and planning to attend college. Those competing for the scholarships will have been involved with the Brownwood Rotary Club either through the RYLA Program sponsored by Rotary District #5790 or the Student Rotarian partnership program with Brownwood ISD or Early ISD.

Rotary in Brownwood has had a rich history and current members continue to find new avenues to enrich the lives of people both on a local level and abroad. Together, as a part of the larger Rotary family, we stand ready to serve with a renewed commitment to the enduring principles that are the fiber of Rotary International. The future is bright as we embark upon new ways to spread the principled and values of Rotary to the generations that follow.

FORT WORTH ROTARY CLUB "Combating Low Literacy in Tarrant County"


Low literacy in the workplace often means the inability to read well enough to fully understand important written material (e.g. safety manual, infectious disease material, training material, shipping invoices or operation instructions. Low literacy skills cost businesses and taxpayers \$20 billion in lost wages, profits, and productivity every year. In Tarrant County, one in five adults cannot read well enough to succeed at a fourth grade level. Almost 2/3 of those are unemployed or only marginally employed.

The Rotary Club of Fort Worth hosted a Workplace Summit last year to raise awareness of the issue of workplace literacy and how it affects the lives of everyone who lives and works in Tarrant County. International workforce literacy expert Dr. Edward E. Gordon was the keynote speaker. He explored how community groups, businesses and educators can address this critical skills shortfall.

This year we will launch a new effort to combat literacy in Tarrant County. Details on the new project will be coming out soon. It is truly an exciting and bold project.

We continue our STARS program at Riverside Middle School and have added a Math and Science camp at the University of Texas at Arlington campus in our mix of Adopt-A-School activities the last two years. Pen Pal correspondence is another very rewarding experience for our Rotarians and the students at Riverside Middle School.



In the past few years, flag subscriptions have dwindled. This year the club has made a renewed effort to get many more flags out and it's working. Subscriptions are up and with more subscriptions we have more money coming in so we can provide more money to various projects we sponsor in the city. Our main emphasis has been on programs that target children. We are one of the oldest sponsors of the the Wichita Falls Boys and Girls Clubs. We have managed to give thousands of dollars over the years, a figure that just keeps growing and growing. LEWISVILLE ROTARY CLUB "Exceptional Student of the Month Program"

Many Rotary clubs have a "Student of the Month" program whereby they recognize a student from the local high school due to outstanding academic and extracurricular achievement. We have such a program at the Lewisville Rotary Club, but it inspired an entirely different type of program – the Exceptional Student of the Month.

What is different about our program—is that it is for students with special needs. Should they not be recognized as well? After all, a child faced with the special challenges that a disability sometimes creates can attain a spirit unobtainable by those of us considered "normal" by society's standards. So at the urging of our 2009-2010 President, Mike Pope, we started the program. Our club was already involved with the Lewisville ISD with a Student of the Month program and an Interact Club, and we also supported as a service project and through donations the *Grand Ball*, an event that provides a high school prom experience for students with special needs or disabilities. Our club decided to do something further to let special needs students know how much we valued them.

The creative juices churned and the idea was born: The Exceptional Student of the Month. Contact with the appropriate persons at LISD drew immediate support for the program, and it was launched! The rules were very simple – select one student each month to be highlighted as our Exceptional Student of the Month, invite the teacher or counselor who selected them to receive the award to attend our lunch meeting and tell a little about them, and parents were invited to attend the lunch meeting and observe the event. A certificate is framed and presented once a month. Of course in true Rotary fashion, our invited guests lunch for free! When the award is announced, all our members give the award recipient a standing ovation. It is such a joy to see the excitement of the student and parents.

The Exceptional Student of the Month program is an opportunity to recognize students with special needs who, despite any physical or mental limitations, excel in character and attitude. The award was based on characteristics such as good citizenship, classroom participation, demonstrating responsibility, respect for peers and teachers, good attendance, work ethic, extracurricular activities and sometimes good grades. The Exceptional Student of the Month award is often the only time in the student's life that they are recognized by community business leaders. It's a win-win for everyone.

2010-11 will allow us to add something else to the program: One of our newest members owns a web publishing company and often produces videos for his clients. He has agreed to produce a short video each month that will highlight the accomplishments of the student, with family photographs and interviews with school teachers or coordinators. Provided the family signs a waiver, we plan to not only show the video at the regular lunch meeting, the video will go on the club's YouTube channel along with releasing it to LISD for use on their closed circuit district-wide television channel.
