My dear Rotary friends,

Every year, Rotary's Presidential Citation program helps Rotary clubs around the world focus their efforts and achieve more in their service.

This year, for the first time, the Presidential Citation was data-driven: we asked you to increase membership, contribute to The Rotary Foundation, and to use online tools such as Rotary Club Central and Rotary Showcase to report your accomplishments throughout the year.

As a result, clubs have been able to monitor their own progress via their club dashboards, and we at RI have been able to see that progress as well.

The purpose of the Citation is to honor the efforts of the many clubs who have worked so hard toward their Rotary goals this year. Seeing how many of you have made great strides in your service, without reaching every goal needed to achieve a Citation, I sought a way to recognize that work as well.

As a result, I am pleased to announce that this year,

the Citation will be modified and issued in three levels: Gold, Silver, and Bronze. The Gold citation will recognize those who met the high bar of all seven goals; Silver citations will go to those who have achieved six goals, and Bronze will go to those who have attained five (including, in all cases, the mandatory goals).

No action is needed on the part of any club at this point; the citation results are now being tabulated here in Evanston from the data that has already been collected online.

I hope as we look to the last three months of our term that you will not slow in your efforts or in your service. The true rewards for Rotary endeavors, of course, do not come from Evanston: they come from the satisfactions of service well delivered, and the knowledge that our clubs have been A Gift to the World.

Schenectady, NY on April 12th.



This message is to inform you that the current liability policies will expire 1 July 12:01 a.m. New insurance policies will be purchased to provide continuous coverage; however, we want to advise you that policy terms and conditions may reduce coverage or be more restrictive than the

expiring policy based on the underwriting information provided to insurers. We will make every effort to provide the same broad coverage as per the expiring policy.

Reminder: As you are planning your fundraising events, please review the insurance documents posted on the Portal, specifically, the policy exclusions. Note that there is very limited coverage as relates to fireworks. Fireworks are considered a high risk activity by insurance underwriters; the Program’s coverage is limited to liability arising out of selling pre-wrapped fireworks purchased from a licensed third party or a fireworks display that is part of an event where a third party (not the Named Insured i.e. your local Rotary club) has contracted with a pyrotechnic company. If the Rotary Club is a sponsor of an event where there are fireworks, the pyrotechnics company should include the Rotary Club as an Additional Insured on their policy (in addition to the party contracting with the pyrotechnics company).

District History Book Published

After three years of research, my history of the district has now been published. Entitled "The History of Rotary District 6630: The 'Home' of Arch C. Klumph," the 500-page first edition of the book was introduced at the All Ohio P.E.T.S. meeting in Columbus in March by DGE Jim McKee. A copy of the book was presented to RI President Elect John Germ, and Mr. Germ autographed several copies to be auctioned off at district events in the coming year.




Early on in the project, I decided that I wanted to have a chronological record of the founding and development of the district, a biography on each of the past district governors, and a history on each of the 69 Rotary clubs that have existed within the geographical limits of what is now District 6630. As I worked with the records, I decided that each club history would include a narrative history, a list of charter members, and a list of past presidents. As I used various sources of historical information, I ran across a number of interesting and little-known facts about clubs in the district, so I added a chapter that includes these stories.

Just in time for the recently completed 2016 District 6630 Conference of Clubs and District Training Assembly, a second edition of the book has been published. This version includes all the material from the first edition, but also includes an expanded appendix, which includes the following lists: past district governors, clubs by

charter dates, members of outbound GSE teams from the district, Ambassadorial Scholars from the district, Rotary Peace Fellows from the district, and district leaders who have served on the RI board. Also included is a club genealogy showing all district clubs and the associated sponsoring club(s).

TRC Solon Hosts 4-Way Test Speech Contest

On Wednesday, March 16th, the Rotary Club of Solon had the pleasure of hosting our seventh annual Four-Way Speech Contest, featuring six high school residents of Solon: Taleen Avitisian, Imogen Hobbs, Pranav Iyer, Aditya Giridhar, Nupur Goel, and Jaiydev Gupta. To say that these speakers have the gift for oration is an understatement! We were treated



to thought-provoking speeches varying from gun control to resume-padding, delivered by exuberant and articulate youths. The speakers were accompanied by families and friends, along with many Rotary members, and the contest was judged by the Mayor of Solon, Susan Drucker, Judge Michelle Paris, and Dr. Jim Persky, who had the challenging task of selecting the winning speaker.

Event organizer, Matt Liebson, summed up the event as he described our student speakers: "We are honored every year to hear from students who aren't afraid to tackle important cultural, political and ethical issues in front of a large audience, using the Rotary Four-Way Test." Our contestants applied the attributes of the Four-Way test – Truth, Fairness, Benefit, and Goodwill – to sup-

port their positions.

After careful deliberation, our judges selected Nupur Goel, a student at Gilmour Academy, as the evening's winner. Her speech on the misguided goals of education today resonated with the audience and judges for its well-argued and topical nature, and reinforced Nupur's status as a recent state champion in original oratory.



Her win at our Club's contest then sent Nupur to the Northeast Ohio District Speech Contest in early April.

While Nupur ultimately did not win at the district level, we were very proud of how well she presented herself against very talented competition. Of the District Contest, Club member Bud Thomas commented: "The future of the United States is in good hands. If any of the folks I observed giving speeches today were running for president - I would definitely vote for them..." Nupur's delivery and topic were excellent, and the fact that she did not win the contest speaks to the high caliber of students we have in our community.

Also during our March dinner, we honored four Students of the Month:

Chisomebi Onyia and Gabriella Rapposelli from Solon Middle School, and Rebecca Ilic and Jordan Morlani from Solon High School. These students were recognized for their scholastic achievements and contributions to the community: their demonstration of "Service above Self." In addition to sports and other extracurricular activities, our Students of the Month volunteer at local churches and camps; serve meals to social organizations; and assist homeless veterans find work and housing. One of our Students of the Month was so busy she had to call in her acceptance speech from a bus trip to Florida with the Solon High School Band!

Our Rotary Club is truly fortunate to have such bright, articulate, and pas-



sionate students in our community, and we are grateful for the support they have received from their families, peers, and school staff members. They have dedicated themselves to personal improvement, and to giving back to others by embracing the guiding principles of Rotary's Service above Self.

For the last 41 years Rotarians and their significant others have attended the Fall and Spring productions of 6 area high schools, Fairport Harbor, Lake Catholic, Mentor, Painesville Harvey, Perry and Riverside serving as judges to evaluate best performances and best productions; recognizing the students and schools at the annual award ceremony.

To continue the memory of Robert Tischer, his family as sponsored an-



nual scholarships awarded to any student involved with their schools theater program.

In addition to the awards and scholar-



ships, the event is a celebration of the students' efforts with each school performing a cameo scene from each

of the 12 plays produced throughout the fall and spring seasons.

ShelterBox in Ecuador

I have new information about our Ecuador response. (Text in gray means no change since the previous update)

Key points:

- 7.8 magnitude earthquake struck near the northern town of Muisne
- The earthquake has triggered heavy landslides and more than 130 aftershocks
- The devastation has been huge - Streets have cracked and many buildings have collapsed, leaving 26,000 people to seek refuge in temporary shelters
- The current count is 650 dead and 16,600 were severely injured, crowding the few hospitals that remain standing
- Flooding had already poisoned crops around Portoviejo, and infrastructure damage has now left families without safe drinking water
- The water filtration plant in the Municipality of Portoviejo, 40 kilometers inland from the Pacific coast epicenter of the quake, was severely damaged in the earthquake and is now unable to dispense filtered water

Our Response:

- The ShelterBox operations team has been monitoring the situation since the earthquake took place on Saturday night
- Alongside Shelter Kits, containing tools and waterproofing to repair damaged homes or to create basic shelters, we are now arranging delivery of 1,700 water filters
- The aim is for up to 2,000 families to receive a mix of Shelter Kits, water filtration, mosquito nets, cooking equipment, and all-important solar lighting as there is only limited power supplies
- Plans are urgently being made to ship all this equipment from Panama, and to call on Spanish-speaking response team members to oversee its distribution
- *Our plans are all subject to approval from the Ecuador Government for us to operate in their country, and they already have our letter of commitment*

This is the fourth year Dr. White has made this generous donation (a full orthodontic treatment or Invisalign treatment). It is a \$6280 value.

The 32nd Annual Gala will further the mission to establish sustainable congenital heart health for Children in Haiti (through the Gift of Life Project),

and equip an ambulance in Hudson with life-sustaining CPR technology by assisting the Hudson EMS in the purchase of a second Lucas CPR device so that a second ambulance can be provided this life-saving device. Our goal is to raise \$40,000 to support The Gift of Life Northeast Ohio and Hudson EMS, college scholarships for Hudson students, the Service Learning Program at Hudson HS and Boy Scout Troop 321.



New scoreboard, more food options greet Tribe fans

A huge, new scoreboard with 13,000 square feet of display space and lots of new food court options plus what many consider the No. 1 pitching lineup in the American League greeted Tribe fans as the Cleveland Indians opened their season one day later than scheduled on Tuesday, April 5.

Nate Janoso, the Indians manager of alumni relations, shared a preview of the upcoming season with Berea Rotarians on Tuesday, March 29. The home opener on Monday vs. the Boston Red Sox was sold out but attendance remains a concern, Janoso said. Last year, the Tribe's attendance numbers ranked 29th out of 30 teams. "Our goal this year – as it is every year – is the make the playoffs," Janoso said. "I am very optimistic for 2016," he said. He has several reasons to think big.

Manager Terry Francona is under contract through 2018. The Tribe has had three straight winning seasons under his leadership. Francona has had 11 consecutive winning seasons counting his previous stint with the Red Sox.

"We have such good pitching," said Janoso, who has been with the Tribe front office for 15 years. "The best moves we made in the off season were the ones we didn't make," he said. The starting pitching led by ace Corey Kluber and bullpen headed by Cody Allen and Bryan Shaw is outstanding. It's essentially the same staff as last season.

Hitting should be no problem. Carlos Santana led the team with RBI and home runs last year. Francisco Lindor finished 2nd in rookie of the year balloting and Michael Brantley hit .310 for the season. Add to that Jason Kipnis and Yan Gomes and off-season acquisitions Mike Napoli and Rajai Davis – all with potential to score runs.

The team should be the main attraction but Progressive Field has seen some changes too. The new scoreboard is 59.5 feet high and 221 feet wide. Happy Dog, Ohio City Burrito, Brew Kettle, Fat Heads and Dante's Inferno are among the food options. The stadium has been enhanced with walls knocked out to open up the concourse. There is a new Home plate Club for season-ticket holders.

Tickets can be purchased online or at the Team Shop. Bleacher seats remain only \$10.

Notable dates: Rotary District 6630 Night at the Indians will be July 29. It's Dollar Dog Night and there will be fireworks.

The Hall of Fame Induction Ceremony will be July 30. Jim Thome, Frank Robinson and Albert Belle are the honorees.

was invited to the memorial service by one of Haggerty's best friends, Johnny Crawford (of "Rifleman" fame). Crawford also was part of the Best of the West program.

"It was like nothing I had ever seen before," Russ admitted. "I knew I wasn't in Ohio anymore." When other guests found out Russ had produced the Malabar Farm program, they started auditioning. "I guess they thought I was a real producer," Russ said. Flabbergasted, he asked Crawford about it. "Just go with it," Crawford told him.

Russ said Haggerty was a down-to-earth guy, no frills. When Russ wanted to send Haggerty an e-mail about airline reservations to Cleveland, Haggerty replied, "Let's do this the old-fashioned way. I'll get a pencil."

Actually, the actor had been to Malabar once before very early in his career when he filmed a B western about Paul Bunyan. Best known for his Grizzly Adams role, Haggerty

also had appeared in a wide variety of movies, including "Muscle Beach Party" with Annette Funicello.

Haggerty was into motorcycles and owned the original Harley from the movie "Easy Rider." He and his wife, Sam, rode their own cycles frequently. Unfortunately, she was killed in a cycle accident in 2008. He never got over that.

He was just a regular guy, Russ said. There were more than 200 people at the Celebration of Life and every one of them counted him as a friend.

"If you met Dan, you felt like he'd been your best friend forever," Russ said.

From patients to procedures, a lot has changed in health care

After 30 years in the health care field, William Young, the new president and CEO of Southwest General

Health Center, says he's seen a lot of change.

"Patients want to be included in health care decisions now," he said. "They want to know what we're doing



and why certain medications are prescribed." He said some patients research their symptoms online even before consulting a doctor and some bring their iPads to the appointments.

ObamaCare also has changed health care, he said – mostly in a positive way. "All this talk about repeal, that train has left the station," Young said. ObamaCare has eliminated concerns about pre-existing conditions, has allowed young people up to age 26 to remain on their parents' plans and allowed Ohio to expand Medicaid coverage. On the other hand, Young said, "there are some things that need to be fixed. Medicare itself was not perfect when it started. We have to work to fix ObamaCare."

Young began his new job at Southwest on Jan. 1, taking over when Tom Selden retired. He previously was president and CEO of St. John Medical Center in Westlake. He said he has spent the last 90 days getting to know the staff and the community. "My job is to listen," he said. "How can we make this a better place." He has talked with school superintendents, mayors and other public officials and is making the rounds of community groups, such as Berea Rotary.

The health care field is very competitive, Young said. "You have choices. Our job is to make sure we deserve to be your choice.

Still More Berea

"If patients aren't happy, we get dinged," Young said. "The days of being treated like a number are gone."

Offering state-of-the-art services helps. The hospital's latest addition is a partnership with University Hospital's Heart Institute, allowing top UH physicians to offer care to Southwest patients. The newly opened Pandrangi Tower includes private rooms. Southwest is also one of the very few local hospitals with a behavioral health unit with both inpatient and outpatient programs.

Southwest also is gearing up for the Republican National Convention in Cleveland in July. While the focus will be downtown, local police and fire and hospital personnel are training to deal with possible protesters in this area. Young said protests along I-71 are a possibility. Decontamination tents are being prepared to deal with several scenarios. Staff is also being trained to identify human trafficking victims.
