Dr. Lori Basey knows no limits when working with traumatized populations and mobilizing others to respond to devastation.

She is a keynote presenter, delivering presentations to thousands and quoted throughout the globe in publications such as the Los Angeles Times, Huffington Post, Daily News America, Orange County Register, People, Times of Mumbai, Daily Oklahoman, and Sierra Leone Times. Dr. Basey has been broadcasted within the United States and internationally, and had an article published in Advance, a therapeutic magazine.

Since 1991, she has specialized in acute psychiatric care, including trauma-informed therapeutic intervention following the Oklahoma City Murrah Federal Building bombing as well as the 9/11 disaster in NYC and the 2010

earthquake in Haiti. She is an expert consultant in trauma associated with war, exploitation, and natural disaster.

In 1997, Dr. Basey and her husband, Dr. Tom Basey, DDS, began responding internationally with their professional expertise. Dr. Lori Basey has traveled to many countries, including Israel, Honduras, Haiti, Belize, Moldova, India, Turkey, and Sierra Leone, in response to manmade and natural disasters. In 2006, Dr. Basey co-founded No Boundaries International (NBI), a non-profit organization run solely by volunteers in Oklahoma City, OK. As President of NBI, Dr. Basey provides training on trauma-informed care and mobilizes volunteers to help those in the local community, especially those affected by human trafficking.

Vicki Behenna, is the newly elected District Attorney for Oklahoma County and the first female ever elected to that position. She is a former Assistant United States Attorney for the Western District of Oklahoma. During her tenure as an Assistant United States Attorney, she tried numerous fraud cases including bank, wire, mail, corporate and healthcare and was responsible for the prosecution of complex public corruption cases. Behenna's background and extensive investigative experience with complex investigations resulted in the conviction of many high-profile defendants.

Among her noteworthy prosecutions, Behenna was selected to participate in the Oklahoma City bombing case against Timothy McVeigh as a special attorney to then U.S. Attorney General Janet Reno. Upon completion of the case, Behenna was selected by U.S. Attorney Pat Ryan to serve as senior litigation counsel for the Western District of Oklahoma. Behenna has tried numerous bank fraud cases including a case against State Senator Paul Taliaferro and Dale Mitchell. She was involved in the investigation and prosecution of two high profile public corruption cases involving the Oklahoma State Treasurer's office and the Senate Pro Tempe. She also was involved in an off-label marketing case that resulted in a criminal conviction of Wyeth Pharmaceuticals and a settlement to the government in the amount of \$491 million.

Behenna left the U.S. Attorney's Office after 25 years and entered private practice representing clients charged with a variety of state and federal crimes. Immediately upon leaving the U.S. Attorney's Office, Behenna joined Crowe &

Dunlevy as an advisory director and then opened her own firm of Behenna, Goerke, Krahl & Director of the Oklahoma Innocence Project at the Oklahoma City University School of Law. Behenna is an active speaker and a member of the Oklahoma Bar Association, Federal Bar Association, American Bar Association, Oklahoma Association of Women Lawyers and William J. Holloway, Jr. American Inn of Court. She served as an adjunct professor at Oklahoma City University School of Law instructing on trial practice and evidence courses.

Behenna received her Juris Doctor from the Oklahoma City University School of Law and her Bachelor of Arts in journalism from the University of Oklahoma.

Emmanuel "El Punisher" Rivera, a former street kid from Chicago, is now the executive director of The Come Up Foundation in Oklahoma City and an MMA analyst on Sports Animal.

A former professional MMA fighter and dance instructor, Rivera has practiced martial arts for 13 years, and says it helped turn his life around. He's now giving back to disadvantaged youth to keep them off the streets and on the right path. Proficient in striking, Rivera's health challenges put a hold on his career as a professional MMA fighter but sparked a new passion to "pay forward" the valuable lessons he learned.

Rivera continues to train fighters, and to learn new lessons in life and business while he teaches and mentors The Come Up kids. As a proud second-generation Mexican-American, Rivera prefers to say he's an American of Mexican descent. Rivera works with disadvantaged youth across Oklahoma, partnering with other nonprofits and churches with plans to expand into schools. He works daily to grow the program to create a culture of mentorship in the martial arts community. Rivera says kids need to be addicted to martial arts disciplines and healthy living instead of cellphones and game consoles. He says martial arts is a lifestyle.

A former small business owner and MMA and color commentator, Rivera spent his early childhood roaming the streets of Chicago, but credits his single Mom with moving him to Henryetta, Oklahoma, because she feared him affiliating with gangs. Rivera said he still found trouble and moved out on his own at 16 and left for Las Vegas at 17, where he ran around with the wrong people but his love for his family and desire to pursue boxing caused him to return home and get on the right track. Rivera learned boxing from his uncles in the yard of his family home in Henryetta. He practiced relentlessly, sparring with cousins and anyone willing to go a few rounds. He started fighting in public in Toughman competitions in his early twenties. After he won three straight tournaments, he turned his focus to mixed martial arts.

Rivera quickly learned that martial arts is about more than fighting – it helps with stress relief, mental balance, overcoming unhealthy habits, and more. Rivera had a promising career. He had 15 amateur and 8 professional fights in the cage (and one professional boxing bout), losing only four times. But winning in life is the message he hopes to spread to youth.

Come Up kids are asked to "commit and oblige" themselves to be honest, hard-working, strong and respectful. It's a personal contract recited during training sessions.

"I want to impact kids like me, so they don't make the mistakes I made. I want to give them the same opportunities I have had." The Come Up Kids already are turning their lives around.

Rivera also owns a small nutrition shop, but says his greatest achievements are his two children; Mila, age 2, and Cooper, age 10. Rivera's Come Up kids are important to him, too. He's also a mentor for the Young Latino Professionals. And he has a message to Oklahoma City:

"Watch out, because we are 'The Come Up Kids,' and we are OKC's leaders of the future."

Ray was chosen by Bob Moore for a Service for Service award and recognized on Channel 9.

After serving in the U.S. Navy, Richard worked a variety of jobs including in the oil fields as a roughneck in the scorching sun and in freezing Oklahoma weather. In 1964 a recruiter from the Oklahoma City Police Department came to Tulsa, Oklahoma providing testing for needed new recruits. Richard passed the test to became a proud member of the department that fall. His career began riding the downtown streets of OKC in a scout car. Within four years he was promoted to Detective. He would go on to serve 21 years rising to the rank the of Detective Sergeant in seven years. In the next fourteen years he headed up the first ever Sex Crimes Unit as well as overseeing the Auto Theft and Crime Analysis Units. After retirement from the OKC Police Department Richard was employed as by the state of Oklahoma as the first Environmental Criminal Investigator in Oklahoma State History. Over the years since leaving law enforcement, he began to gather research notes and ponder ideas for True Crime books. Using firsthand knowledge of criminal investigation and a number of interviews with survivors and family of the perpetrators and victims of the incidents that interested him, Richard began work on a series of books.

Things back then were very different from the high-tech world of today for the uniformed men who guarded the citizens of a fast-growing metropolis. From worn out old patrol cars with standard shifts, no power steering or air conditioning to fist fights with drunks, to low pay and long hours, this was a tough time to be an officer of the law. Fact is often stranger than fiction - so are the real stories of the events in Richard's time on patrol, before he traded his uniform in for a suit and hidden .38 snub nose.

Besides raising funds for building Mobility vehicles, some affiliates collect other used mobility devices such as canes, foldable walkers, crutches, and wheelchairs. Even if they need minor repairs/replacement parts, we receive and send them on to one of our distribution partners, Hope Haven International, in Iowa. They refurbish used mobility devices and distribute along with our Mobility Carts in over 100 countries to date.

Due to the size of the geographic area impacted and the funding resources available a collaborative effort among many disaster organizations was put in place called the "Oklahoma Disaster Recovery Project". For this, the Oklahoma United Methodist Disaster Response ministry was formed and staffed. The focus for this ministry was recruiting volunteers, managing the projects, and completing home repairs using volunteer labor and donated materials. The recovery project from the May 2013 disaster was completed in July 2015 following the states worst flooding disaster impacting 66 of the states 77 counties. More grant dollars became available allowing the Oklahoma United Methodist Disaster Response ministry to continue providing recovery efforts through the 2016, 2017, and 2018 disasters as well. On September 10, 2018 the staff was informed their last day would be October 31 due to shortages in funding. The remaining staff of Chad Detwiler, Kevin Walker, and Hal Wright created a new 501(c)3 nonprofit organization called Recovering Oklahomans After Disaster Inc. in order to continue this needed and beneficial service for the long term.

This curriculum is developed with the input of industry professionals, using skills standards to identify the knowledge and abilites needed to master an occupation.

In addition to helping students complete their education, obtain career technical skills and gain employment, Job Corps also provides transitional support services, such as help finding employment, housing, child care, and transportation. Job Corps graduates either enter the workforce or an apprenticeship, go on to higher education, or join the military.
