- 1. There was no guarantee that a grant will be approved and funded
- 2. Emphasis was placed on multi-club projects
- 3. It is possible for a grant amount to be adjusted by the committee
- 4. Selection criteria would need to be developed by the committee (and will change from year to year); the grant decisions for 2013-14 were made based on:
 - a. Rotary International Terms and Conditions
 - b. Rotary District 5650 additional criteria
 - c. The Mission of The Rotary Foundation
 - d. Some Grants / categories of grants would need to have reduced funding
 - e. The number of unique communities / clubs Served
 - Reducing multiple requests by clubsto one grant per club and/or limiting the match for any one singleclub project
 - g. Emphasis was placed on:
 - i. Multi-Club Grants
 - ii. Local Community Projects
 - iii. Unique Projects
