Designated Funds, applicants can be endorsed by any Rotary district. Would

US vs. Canadian Charitable Donations - A variety of difference between Canadian and US charitable donors have been identified in several studies. A recent study documented that the different banking systems results in Canadians more likely to use direct deposit donations such as <a href="TRF Direct">TRF Direct</a>. **Arch Klumph Society** - The Rotary Foundation now recognizes three levels of Arch C. Klumph Society membership and is phasing out Major Donor recognition above US\$250,000. The new Arch C. Klumph Society recognition levels are the Foundation Circle (\$1 million and above), Chair'sCircle (\$500,000 to \$999,999), and Trustees Circle (\$250,000 to \$499,999).

Asking for Support for our Foundation - How can you increase support from your members? Ask outright and give them the opportunity to give. Do not assume they have been asked, nor assume that they know what is going on. Ask for more than \$25 a quarter. How about \$50? \$100? \$250? \$1,000?

- If a member prefers to make one gift annually, remind them to do that on their birthday each year or even better sign up for <a href="TRF Direct">TRF Direct</a>
- Have a club program on the Foundation every quarter, utilize RRFCs or the district Foundation chair. Make sure someone asks for people's commitment at this time.
- Set the expectation that each member donate every year. For some it will be a lot and for some it will be a small gift. What is important is that every member donate.
- Have the Rotarian's sponsor ask for the commitment or someone else of influence.
- Utilize your club's Foundation Recognition Points (FRPs).
- Ask all PHFs in the club if they would be willing to talk with anyone on the list that is not giving or to upgrade someone who should give more.
- Make sure to award all new Paul Harris Fellows and multi level PHF at club meetings with Pizzazz - make them special. Recognition is an important key.
- Are the club and district leaders setting the example by being contributors to the Foundation and a 100% example?

**Updated Statement on Polio Facts** - For the sake of clarity and consistency in all Rotary publications and information, the International PolioPlus Committee has adopted a set of frequently reported statements, statistics, and terms concerning the PolioPlus Program and the global polio eradication effort, and encourages all members in the global partnership for polio eradication to adopt similarly consistent statements and figures. The Committee has also requested a wide dissemination



within Rotary for these statements. The Committee reviews these statements at each meeting, to ensure that they remain current and appropriate. download the revised & updated statement
