

CONTRIBUTIONS UPDATE - For the nine months ending 31 March 2010, contributions to TRF totalled US\$109,944,697 up 6.33% over last year which is good news. Of that amount, however, contributions to the Annual Programs Fund of US\$61,724,062 are down 3.49% over last year's giving. We have achieved 63.6% of our Worldwide Annual Programs Fund Goal of US \$96,000,000. Contributions to the Permanent Fund totaled US\$7,678,975, an increase of 5.01% from the previous year. PolioPlus contributions continue to remain strong up 32.65% at US \$22,969,286. Restricted gifts totaled US\$14,673,144, an increase of 14.36% from one year ago. Unrestricted contributions to the Donor Advised Fund and contributions to the Haiti DAF being the reason for the increase of 46.35%.

GSE TEAMS - Nearly 600 GSE Teams are exchanging in 2009-10. The GSE Department saw a near record number of GSE teams launched, with almost 3,000 team members and leaders from almost every Rotary District criscrossing the world. The busiest time of year for GSE is currently underway, and with that we would like to thank all districts participating and acknowledge all the help received from GSE committee Chairs and Team Leaders in each and every Rotary district. At their April 2010 meeting the Trustees condintionally approved a partial World Fund subsidy to all non-pilot districts to send one GSE team during the 2012-13 Rotary year.

COUNCIL ON LEGISLATION - Last week the COL passed several enactments and proposals that impact on The Rotary Foundation. These include potential termination of clubs who keep members who have missused funds, reporting of Trustee expenses, selection of Trustees and requests for the Trustees and RI Board to consider possible new programs. The COL also rejected a number of proposals to modify the rules regarding family members receiving TRF funds. <u>read more</u>



ROTARY SUCCESS FORUMS - Zone 24 - West will hold two regional Rotary Success zone seminars, October 15-16, 2010, in Edmonton and October 29-30, 2010 in Vancouver. These seminars are for the district leadership team. The seminars will cover Rotary Foundation programs, fund development and Rotary International programs. District Rotary Foundation committee members, district committee members, AGs, DGs, DGEs and DGNs are encouraged to attend. All Rotarians are welcome. FUTURE VISION UPDATE - The future vision districts in Zone 24-32 are currently completing qualification of their district and training the clubs in the district as part of the club qualification process. The online global grant applications went live in mid April. Qualified clubs in future vision districts may now submit proposals for global grants which is the first step prior to a grant application. Future vision districts are currently preparing their spending plan as part of the process to apply for the block district grant. read more
