The rule is that districts must maintain at least a 70% compliance rate of all required interim and final grant reports having been filed on time. All but one district in Zone 22 met that requirement - with Districts 5020, 7070 and 7810 leading the way at 100% compliance. Congratulations to everyone concerned. Proper stewardship of donated funds is crucial. High compliance rates indicate that the partnership between sponsoring clubs and districts and their host partner clubs and districts are functioning very well. Keep it up!

	IMPORTANT CHANGES - Effective July 1, 2009 Foundation recognition points will only be transferred for transactions of 500 points or more; the individual donor will be the only person authorized to transfer recognition points and recognition points will expire upon the death of the donor or the death of the surviving spouse of a Major Donor. Club Foundation Chairs should review the Club Recognition Summary report now with regard to recognition points and establish the best strategy to use points of former members or deceased members. They should



work with the District Foundation Chair on how to best use recognition points.

PERMANENT FUND - As of August 31, 2008, the Permanent Fund net assets stood at US\$205.8

million. The estimated expectancies to the Permanent Fund stood at US \$383.9 million. Therefore, the net assets and expectancies totalled US\$589.7 million. The goal is to reach US\$1 billion in net assets and expectancies by 2025. Read more



**BEQUEST SOCIETY** - As of September 30, 2008, there were 6,375 Bequest Society commitments with an expected value of US\$270.7 million. These commitments represent a significant percentage of the expectancies to the Permanent Fund and an increase of 60 new bequests valued at more than US\$900,000 since July 2008. Read more
