Rotary Responds to Moore, Oklahoma, Tornado

Dear District Rotarians,

We at District 5170 are deeply concerned for the people of Moore, Oklahoma, in the wake of Monday's tornado. Many in the District have asked how we are responding to this disaster. I have been in contact with a friend from the Rotary Club of Oklahoma City and will be working through him to see how our resources can best be put to use for the people in Moore. Bob Medley of the Oklahoma City club was among a group of Oklahoma City Rotary Club leaders

who traveled with me and a group of District 5170 Rotarians to Guatemala on two Global Grants written by Area 7 & Area 8 clubs and supported by the Oklahoma City Club in 2011. I have set up a fund through the District 5170 Foundation to accept donations for the Moore, Oklahoma, tornado relief efforts. As we have learned with previous natural disasters, the cleanup and recovery work will be ongoing for the next few months and possibly years.



While Rotary is not set up as a first responder group, we nevertheless, are concerned for the welfare of those who have suffered great loss. We encourage

you and your clubs to make donations to the Red Cross, AmeriCares, Shelter Box and other organizations that are on the ground helping with the initial wave of relief efforts.

meet new needs for members and new service needs locally and around the world. While maintaining our core values, Rotarians around the world realize we must progress to survive. The central guide for all Rotarians is the Manual of Procedures. It is not a nightly read; but whenever touchy questions come up or guidance is needed, the Manual of Procedures, commonly known as the MOP, is where I look. Every Rotarian can access it through www.rotary.org.

To keep up with the times, every district sends a representative to an assembly every four years to decide on changes proposed by Rotarians through their clubs. Our representative this April was Past District Governor Arlene Greenberg. Many changes in the Manual of Procedures were made and reported on by Arlene at the May 1 District Leadership Meeting and Cabinet Meeting. Anyone can go to www.rotary.org to view the complete results.

Some of the changes at the Council on Legislation are particularly interesting and will impact you. Our district brought forward making Youth Services a 5th Avenue of Service. It was accepted in 2010 by the Council on Legislation; but through a compromise amendment, it was renamed New Generations. This label caused some confusion in Rotary Districts and clubs. In the recent Council, the 5th Avenue of Service was renamed Youth Services. Another decision was to continue the annual Rotary International dues increase amounting to \$1 per year per Rotarian for each of 2014, 2015, 2016, and 2017.

Other changes will give clubs more flexibility. Clubs may now form a satellite club that is part of their club but can meet at a different time. While the purpose is to encourage the development of new clubs, the impact is an opportunity for clubs to provide an alternate additional meeting time to expand membership to individuals who may want to join but can't make the club's current meeting time. It also could provide an avenue for retaining members who are having a problem making meetings due to work obligations or other obstacles.

Another change involves attendance accounting. Now, attendance at any club project can be counted as a meeting attendance when determining minimum attendance requirements. Also adding flexibility is a new classification for members. Currently, membership is for individuals who are businesspeople, professionals or community leaders. Now any adult who is on work leave for any reason or who has never worked is qualified for membership.

There are many more provisions you may want to read. My depiction above is not the exact wording but my summation.

Blankets for Babies: A local project to wrap your hearts around

Many premature infants and less fortunate babies will be keeping warm thanks to the efforts of the local Assistance League and Rotary Clubs.

Hundreds of baby blankets have been donated by Saratoga, Los Gatos and Los Gatos Morning Rotary clubs through a project known as Project Baby Blanket. These small blankets will be one

of the first things to touch the skin of countless newborns, and there will be more for families to take home, thanks to this project.

The Baby Blanket Project was the brainchild of Kathi Hamilton, a loving mom and grandmother who wanted to make a difference. She is the wife of Rotary District 5170 Gov. Joe Hamilton, whose duty it is to visit 53 clubs in an area spanning Oakland to San Juan Bautista. Traditionally, the spouse accompanies the governor on these visits. Kathi Hamilton agreed to accompany her husband if she could do something significant that could justify her time. Hamilton has



had a lifelong passion for babies. She's never met a baby she hasn't fallen in love with. She decided to launch a project that would help new mothers and their newborns, and Project Baby Blanket was born.

Checking, she found that hospitals are always in need of receiving blankets--a soft, lightweight blanket used to wrap and swaddle new babies right after birth. Receiving blankets can also be draped across a baby in a stroller for warmth, used for layers in baby bedding, spread on a surface for a quick diaper change, folded over the shoulder for burping or used to cover a baby for privacy while breastfeeding.

"We found a need," Hamilton says. "Having a worthwhile idea is one thing. Having it succeed is another." During her 53 visits, Kathi asked Rotary clubs for small donations for her project. Little did she realize the amazing and positive response she would receive. Over the past year, nearly 4,000 Baby Blankets have been collected for distribution. "I never expected such a response," she says, adding that she'll have packaged more than 4,000 blankets by the time the project is

TINISNED. "BIANKETS nave literally filled my garage and spare pedrooms. I'm flappergasted."



Out of the 53 Rotary Clubs in the district, Saratoga and Los Gatos Rotary clubs stepped up and donated 10 percent of the total number of blankets. The blankets will be distributed to Good Samaritan Hospital, El Camino Hospital in Los Gatos and the Saratoga-Los Gatos Assistance League. They, in turn, will give the blankets to babies where there is a special need. "What better way to enter the world than to be cuddled in a soft blanket? Many, many new babies will benefit," said Paul Christensen, president of the Los Gatos Rotary Club. "This project is a wonderful example of Rotary taking those who need

help and wrapping them in warmth and love."

Distribution of the blankets has just begun, but already women who've were given the blankets have expressed their appreciation. "Good Sam serves a very wide cross-section of our community," says Leslie Kelsay, vice president of marketing and communications at Good Samaritan Hospital. "For any family with a premature infant, or one with major health complications at birth, having a baby in our NICU is an emotionally challenging time. Something as simple as a handcrafted receiving blanket tells them their community cares about them and their child."

"Regardless of their economic circumstances, the gift of a blanket is a small moment of joy in very difficult times," she says. "Our friends and neighbors in the West Valley have big hearts, and these lovely blankets show how much they care for the smallest among us. Each time we're able to provide one of these blankets to a Good Sam family, we think of the larger community extending its support." It may be an unassuming piece of fabric, but for many needy babies and their families, these baby blankets represent generosity and caring that is woven into American lives.

Ambassadorial Scholar Visiting District 5170



District 5170 Vision 5000 states that by the end of year 2017, our district will have 5000 members. Currently, our number is 3839. We began the year at 3745. District 5170 has the third best net membership increase in the Western United States. We have made great strides, and I have been encouraged by how almost every club President has developed and carried out plans to increase the net membership in his/her club. Attached are the latest membership numbers for each district club. We still have a long way to go; and just as important as how many members clubs have on June 30, 2013, is how many club members your club has at the end of July, August, and September. Any progress we make this year is meaningless unless clubs retain their members better than we have in the past. If you know of a member who has stopped coming to meetings, stopped being engaged in Rotary activities, or has discussed with you that she or he might be dropping Rotary, please talk to the individual and, as a Rotarian, encourage the person to stay and

help the individual to re-engage.

Outside of death, almost every other reason for a person dropping can be solved. Attendance can now be counted for involvement in service projects if a Rotarian cannot attend most meetings. Clubs can form a Satellite Club that meets at a different time than the regular meeting. Some clubs have modified dues structures for those in temporary financial difficulties or temporary help can be sought from another member. Levels of involvement can be adjusted for those with time strain in the work or personal life. The thing that is most important in most cases is that another Rotarian in the club reaches out and connects with a member thinking of leaving; that can make all the difference and maintain a Rotarian who can benefit your club and benefit the individual. Finally, job changes and moving away are difficult reasons to address. There are ways to keep the

individual in Rotary. One thing we often overlook is finding a Rotary club in the location where the individual is relocating. If you have trouble finding the name of a club on rotary.org, I and/or our office are happy to help. Rotary is a great way for someone to get connected in a new community and to help an organization we all believe in maintain a member.
