Current News of District 5170 and The Rotary Foundation

From the District TRF Chair, Orrin Mahoney:

Next month Is Foundation Month for Rotary, and we are right in the middle of District 5170's Annual Fund Drive. The annual fund is critical to the District as it directly affects future DDF contributions that are the heart of our Global Grants doing good around the world. In order to promote the Foundation directly to the District membership, I again have been presenting the Foundation as a club program. I have done several presentations already and



they have been well received. I focus on the connection between your contribution and the leverage achieved through the Global Grant process. If done correctly, you can actually get more money back for your project than the total donated. While the total annual fund donation is critical, we also have a continued focus on EREY. While a generous District overall, historically, we have up to 40% of our members with no donation to the Rotary Foundation Annual Fund. In order to qualify for EREY, each member needs only to donate at least \$25.

TRF 2023-24 Drawing

Overall Annual Fund

- 1 point for every \$100 contribution to the Annual Fund (and polio)
- Prize is \$5,000 in DDF. Worth \$9,000 if used in a Global Grant EREY Drawing
- Each Club has an equal chance if they achieve EREY status.
- Prize is \$2500 in DDF. Worth \$4,500 if used in a Global Grant


We will be continuing the two drawings to encourage donations to the Annual Fund. For the first drawing, each Club will get chances in the drawing based on their total giving. The more each Club donates the better the chance of winning. The prize is significant as it is \$5000 in DDF, worth \$9000 when used in a Global Grant. In order to support smaller Clubs and promote EREY, there is a second drawing where each EREY Club has an equal chance at a prize of \$2500 in DDF, worth \$4500 when used

in a Global Grant. As you may remember, we had a record setting year in 2021-22, with over \$1 million to the Annual Fund, followed by almost \$1 million in 2022-23. I am confident that we can do it again this year.

THE UNCOMMON MAN

What a blessing in my life it has been to know Richard D. King. Just two days ago, some of us were having lunch with him after his recent time in the hospital, and he was joking about how his doctor told him it was time to "dust off some of his old speeches and get back to speaking." But now (Oct 10, 2023) that beautiful baritone voice is silent.



Rick was really more of a story-teller than a speech giver; he never used a Power Point presentation with bullet points to get his message across. Rather, he used words that touched our hearts and made us laugh or moved us to tears to make his points. A Rick King speech was more like a "magic carpet ride." Rick knew how to capture an audience and transport us to another time and place where he and Cheri had been, and Cheri was always an important part of every story. As a Past President of Rotary International, Rick with Cheri at his side traveled to every corner of the world, met with Rotarians, kings and queens, prime ministers, and the presidents of most of the countries in the world. But he told me when I was District Governor that "no club was too small for him

to come and give a talk." Rick believed that Rotary was how God used ordinary people to do his work on earth, and his personal and Rotary motto was "Mankind Is Our Business."

There are some people that are just "Bigger than Life" and Rick King was that to me. He served his country with distinction as a Captain in the United States Army during the Vietnam era. He served our District with distinction as District Governor in 1982-1983. He served our Zone with distinction as the Zone director in 1989-1991. And he served Rotary International with distinction as the International President in 2001-2002. I loved hearing Rick talk about "the early days" when he would be suing in the morning, singing in Las Vegas in the evening (where he met his wife Cheri), and then flying back home in the wee hours of the morning. When Cheri agreed to marry Rick, she asked him "how long does this Rotary stuff last," to which he responded—it is just for one year honey, so don't worry about it. But like their marriage, it lasted for a lifetime.

I know that we all have our favorite memories of Rick, and as I thought about mine, I first thought about the time Rick did his cabaret show at my District Conference in Monterey. Rick sang his favorite songs, Cheri danced, and I got to accompany him on my drums. I thought about the time I got to be his aid for three days at Richard Flanders's District Conference in San Ramon. But I think my favorite memory was two days ago when some of us got to just sit with Rick and chat at his favorite mom and pop restaurant in Danville, while having a burger & fries. We have all heard Rick give his speech about "the Uncommon Man", and ask the question "Who Touched You"? And for most of us the easy answer is Rick touched us, because he was the Uncommon Man.

Rest in peace my friend.

In the spirit of caring, 2023-2024 Rotary International President Gordon R. McInally, is breaking new ground by asking all Rotary members to "Create Hope in the World" and become champions in our effort to illuminate mental health needs near and far. This includes helping one another feel more supported, advocating for mental health services, and building bridges with experts in the field to expand access to treatment.



President McInally notes, "It's something that should feel familiar to every Rotary member – because everything we do is in the spirit of caring, giving, friendship and compassion, and has been from the beginning of our organization."

"What makes Rotary powerful isn't just what we do for the communities we serve. We also support and empower each other, by creating a safe space for our members to bring their whole, authentic selves. We show each other comfort and care."

"These connections are deeply meaningful. The U.S. surgeon general recently declared loneliness a public health epidemic. Dr. Vivek Murthy said, "We must prioritize building social connection the same way we have prioritized other critical public health issues such as tobacco, obesity, and substance use disorders.

President McInally states, "I am proud of what Rotary has done across generations to build those kinds of social connections — and the Rotary magazine focused on loneliness in its January 2023 issue. Our worldwide community and our foundational value prioritizing Service Above Self makes Rotary a powerful global advocate for mental health."

McInally notes that mental health care fits comfortably within several of our areas of focus. As of May, there are 41 global grant-supported projects with a mental health focus.

Rotarians believe that we have a shared responsibility to address our world's most persistent issues.

Basic education and literacy


Fighting Disease

Rotary Club of Gilroy Supports GUSD Middle School Suicide Prevention Week Gilroy Rotary Club provides materials for Mindful Jar Project

For its Summer Community Service Project, the Rotary Club of Gilroy came together and provided materials for 1,276 mindful jars. We provided these materials to the school counseling departments at all 3 middle schools in the Gilroy Unified School District, to be used by the students to create mindful jars during their Suicide Prevention Week activities.



Rosie Ramon, a school counselor at Solorsano Middle School, explained that these jars are a wonderful visual aid for helping the students relax when they experience stress, anxiety, or are overwhelmed for any reason. It is explained to the students that the jar represents their head, the water their mind, and the glitter their thoughts or worries. While their thoughts (glitter) are calm and quiet at the bottom of the jar, their mind (water) is clear, and they are able to focus.

Shaking the jar and creating a clouded swirl of thoughts and emotions (glitter) is representative of their mind during times of stress and anxiety. The simple act of paying attention to their breath and slowing it down while they watch the glitter slowdown in the jar is a very powerful exercise. When their mind is focused on the jar and they are taking slow, deep breaths, it takes the focus off their thoughts and emotions, and the brain chatter reduces.

Gilroy Rotary president, Nita Eddie-Mitchell pointed out that, "We are always looking for ways to make a positive impact in our community. Given that mental health is an area of focus for Rotary International this year, this project aligned perfectly with that goal." In addition to the materials for the mindful jars, Rotarians raised enough money to provide each middle school with \$755 to support the monthly Cookies with Counselors activity. In the past, the counselors have generously provided the cookies from their personal funds.

DO NOT READ – UNLESS YOU ARE AGED 70 ½

Hurrah! You have reached a milestone and joined over 23 million U.S. people aged 70 ½ and older. Once you attain this age, you receive an exclusive opportunity if you are charitably inclined *and* own an IRA (Individual Retirement Account).

You can direct a gift of any size up to \$100,000 per year to your favorite philanthropic causes – like The Rotary Foundation. This is called Qualified Charitable Distribution (QCD). Some IRA accounts will allow you to direct this transfer through your online account, or you can contact your IRA Administrator.

Once reaching the required beginning age, you are required to take a **minimum distribution (RMD)** that your IRA Administrator calculates. (Beginning in 2023, the age for RMDs increases from 72 to 73). If you are

Just as at age 70 ½, you continue to be eligible to make gifts of your RMD up to \$100,000 per year from your IRA.

fortunate that you or your family do not need the funds or would like the most efficient way to make charitable gifts, then directing your RMD using the QCD from your IRA to TRF (The Rotary Foundation) may be most advantageous. This process has the added advantage of fulfilling your RMD requirement.

But what about the tax impact, many people ask? Besides the euphoria of making a

charitable gift and seeing your gift support Rotary today, another benefit to you is that you do not have to recognize or claim the income on your income tax return, nor do you get to claim the charitable deduction. You direct the QCD to go directly from your IRA to The Rotary Foundation. Simple as that!

Since this method of giving does not count as income, it may also reduce your

annual income level, which may help lower Medicare premiums and decrease the amount of Social Security subject to tax. You receive the satisfaction of making a tax-efficient gift to support The Rotary Foundation, contributing towards your club goals for Annual Giving *and* your donation is invested to benefit future Rotary projects.

While we encourage and celebrate philanthropy, we always remind you to check with your professional advisors and family to determine what benefits your circumstances.

- Consider any shifts in family dynamics or relationships. New inlaws, new divorces, marriages, or deaths that impact my plans.
- Reflect on my overarching goals and objectives.
- Check in with professionals who've assisted with my estate plan. Will they retire and who are their successors?
- Ensure all documents have the proper signatures and witnesses under your appropriate state law.
- Set a routine for estate plan reviews. Any new family dynamic, wealth event, or federal tax change, might be a reason.
- Share updates with relevant parties, most importantly your beneficiaries. For example, if you want to leave 10% to charity in your estate plans, simply let your adult children know during your lifetime of your intentions.
- Create or update a comprehensive non-legal document to guide families and fiduciaries. This can include a wide variety of information such as burial arrangements, beneficiaries for your tangible personal property, directions for managing certain investments, and essentially everything else important to you that's not addressed in your last will.




Orrin and Carolyn Mahoney share their motivations for funding a Charitable Gift Annuity.




From the Grants Corner October 2023





RI Trustee Chair's Message

October 2023

On 24 October, we renew our commitment to our top humanitarian goal for World Polio Day.

This year, let's remember a young health worker in Pakistan known as Bibi Marjana (Miss Marjana). She braves the snow and cold in the mountains to vaccinate 84 children in rural areas, visiting each home, often miles apart.

Marjana is one of the thousands of frontline workers in Afghanistan, Pakistan, and outbreak areas I consider heroes in the final push to end polio. The work they do, coupled with the vision of our partners and the support you give, is moving mountains.

With Rotary's partnership, the Global Polio Eradication Initiative is aggressively pursuing two key goals from its 2022-26 strategy. First, we aim to halt wild poliovirus type 1 transmission. This year, only six cases have been documented as of this writing. Could this be the year we see the last of these poliovirus cases? We're cautiously optimistic that it might.

Second, we aim to report the final case of circulating vaccine-derived poliovirus type 2, or cVDPV2, in outbreak countries. About 80 percent of cVDPV2 cases last year occurred in subnational areas of the Democratic Republic of Congo, Nigeria, and Yemen. We must implement tailored strategies to stop the virus in these areas.

Other challenges persist, including political tensions, security risks and access issues, and the lasting effect of the pandemic in Afghanistan and Pakistan.

Despite these challenges, we are making progress. Poliovirus strains are diminishing, as is the number of affected regions where polio once prevailed. A new vaccine we have introduced reduces the incidence of the circulating vaccine-derived virus type 2.

Rotary is the organization that had the audacity to take on a global effort to protect children everywhere from disability or even death due to polio. We must have the tenacity to see it to the finish line.

What can you do to help us get there, you ask? Join or initiate a PolioPlus Society in your club or district and engage all members in this historic moment. And don't forget that the Bill & Melinda Gates Foundation continues to amplify Rotary's donations to polio eradication with a 2-to-1 match for every dollar.

You can also advocate the cause of polio eradication with governments to secure political and financial support and promote Rotary's leadership role in all media.

Like Marjana marching up the mountain, we have our goal in sight, and we will keep going until we get there.
