Sharon Tennison, the noted author of "The Power of Impossible Ideas" is a Rotarian who helped with bringing Rotary into Russia. Sharon has a career in international work and she runs an

international policy and education organization in the Bay Area of California.

Margarita Hewko, is the wife of General Secretary John Hewko and a noted national speaker. Margarita, who serves on the Board of Operacion Canasta, a non-profit organization that focuses on development projects in Argentina and who produced the Oral History Project of Ukraine chronicling the country's path to independence, will provide an uplifting message about service and Rotary.

Saturday afternoon will feature three former U.S. ambassadors talking about the countries and regions where they served and the overall importance of international service as a means to citizen diplomacy. Ambassador Richard Celeste (India), who is also the former governor of Ohio and former Peace Corps Director, will join Ambassador Craig Stapleton (France and Czech Republic) and Ambassador Vicki Huddleston (Mali and Madagascar) on a panel that will include an interactive Q & A session. Ambassador Huddleston was also our country's top diplomat in Cuba.

Jacqueline Lundquist, wife of Ambassador Richard Celeste, and author of "Letters from Vietnam: A Daughter's Search for Her Father" will tell the story behind the book, which is now under contract to be made into a screen play.

Saturday evening will feature Ben Parsons, Ambassadorial Scholar and founder of the Infinite Monkey Theorem Winery. Ben will also host a wine tasting as part of the dinner program.

Saturday's keynote speaker will be Lloyd Lewan noted national leadership speaker based in Denver, who will challenge Rotarians to think differently about how they exercise leadership in their daily lives. t's an age old question – what is success. and how is it. achieved? It's a question that pops up in our home quite often since we have a daughter

in high school and a son in college.

Recently my son was lamenting over the hours he had to put in for one of his mid-term exams and how he was missing out on some activities with his friends. I don't often think I have a good response when these moments arise, but this time I did. It just so happened that I recently attended a luncheon at which Denver Southeast Rotarian and past president, Mark Brown, talked about this very subject. Mark said that he is often asked what he had done to become successful. He recounted the early days of his career and how one of his first jobs required a long commute from Boulder to the Denver Tech Center and back each

day. It wasn't something he enjoyed or wanted to do, but it was required if he was to keep his job. He said that's what successful people do - they do the things other people don't. I've been thinking about that story and how Rotarians embody this attitude.

Polio has been eradicated from all but three countries because Rotarians have taken on a task that others did not. Villages in Africa and South America have clean drinking water because Rotarians gave their time, talents and resources to dig wells. Hungry school children here in Colorado now go home with food for the weekend because of backpack programs spearheaded and manned by Rotarians. There's a reason Rotary International succeeds and the PolioPlus program is recognized across the world as a model of publicprivate cooperation in pursuit of a humanitarian goal - it's because Rotarians do what others don't – give of themselves. That's what I call true success!

f you know of WATER AND SANITATION EXPERTS (Rotarians or non-Rotarians who would be interested in applying for the District 5440 VOCATIONAL TRAINING TEAM TRIP TO KENYA this summer please contact District VTT chair John Logan. Applications must be received by April 15, 2013.

Our first Vocational Training Team (VTT) Global Grant is awaiting final approval from Rotary International. A team of six water and sanitation experts from Districts 5440 and 5450 will travel to Nairobi, Kenya in June or July for four weeks. Travel expenses will be paid through a Rotary Global Grant. Our team will work with District 9200 Kenyans in Nairobi and four villages outside of Nairobi to train local officials.

Some of the subjects these experts will teach include:

- Resource mapping
- Urban community water management
- Community solid waste management
- Sanitation/hygiene practices
- Youth in business
- Water and sanitation as business in the rural context
- Water purification techniques
- Maintenance of boreholes and solar pumping equipment.

Our team members will work closely with a Kenyan Vocational Training Team (VTT) while in Kenya. The Kenyan team of four will travel to District 5440 and 5450 later in the year for more extensive training. The candidates will be chosen based on their experience and skills in the areas addressed above. Know Your Numbers, Be Welcoming and Be Proactive!

At the February Executive Committee (ExComm) meeting, we were presented the most recent membership numbers and reports for all 68 clubs. I was really concerned when I read that we had another drop in membership. I asked myself "How could this be?" My team and I have made ourselves available to clubs, especially those who struggle with maintaining or growing their numbers. Communication with clubs and Rotarians across the district has been consistent and informative for the past twelve months.

First of all, I reached out to team member, Sharon Maybee (RC of Commerce City) to review the numbers and use another set of eyes. She and her Rotarian husband, George, have a wealth of experience – much more than I do - in how the membership reporting works and they alerted me to a discrepancy between RI's timing for reporting and our District's process. The end result is that our district numbers are only down single digit which is wonderful news.

After I received the report I emailed all club presidents whose decrease in membership worried me. Even though I found out a few days later that the report wasn't as dire as I first thought, it was worth investing my time to send emails to gain insights on the drop in members. Presidents responded quickly which I greatly appreciated which gave me the pulse on their membership activities and my worries were set aside.

Membership activities and successes are alive and well in District 5450! Some lessons learned from my 13 months as your District Membership Chair: Know Your Numbers: Look at your numbers monthly and look for trends (good and bad). If you don't measure and report, you won't be able to grow. Naturally, processes for membership and follow through by your membership chair and committee are critical in managing the numbers.

Reach Out To Your Peers: It's OK to not know all the ins and outs of your numbers whether it's for Rotary or

your business. Seek out your peers or colleagues whom you trust for seeking counsel so you can learn.

Welcoming And Connecting With Prospective Members: When your club has a 1st time visitor, you all better make sure that your members are smiling, welcoming, offering a seat and asking questions of your guest(s). Every member is considered part of the membership committee.

Be Proactive With Follow Through: I firmly believe that prompt and friendly follow up with a first time visitor is one of the keys to growing membership. Personal experience confirms that first impressions make a difference in whether that guest returns for a second and third visit. Our guests have been appreciative of my prompt email or phone follow up and that represents an organization that is serious about membership. It adds to the warm, fuzzy feeling (a big intangible) that our guests take away after attending our weekly meeting.

Attracting Younger Members: If your club has members who are in the 25-35 year old range, visitors who are in that same age range will feel more comfortable and not feel like the odd person out. I don't expect most clubs to have a high percentage (eg. 30%) of members in this category; however, all you need are a few and all the other great things you do and the warm welcomes by all members will make a young visitor want to come back.

Follow Up: Follow Up must be the mantra for all. The leads may be ones that are generated from the RI website, something local like the recent Garden & Home Show, or someone contacting your club as the result of a web search and arriving at your club's website. Of course, the traditional lead of a member sponsoring a guest is also important. Just Follow Up! If you (you and your committee) don't follow up, please take ownership for the lack of growth in your club.

I look forward to sharing more membership insights that will continue to IGNITE your membership activities on a regular basis. This article is being written before my attendance at PETS from which I expect to have my eyes and ears opened up even more.

Stay tuned and be energized about Membership for it is the Foundation of your club's sustainable growth and success.

Microcredit Has Come to Colorado

As most Rotarians know, the concept of microcredit, making small loans to help the poorest of the poor start, maintain or grow a small business, was started by Mohammad Yunus in Bangladesh in 1976. Since then the concept has been put to work in scores of countries throughout the world. Rotarians have long supported microcredit and District 5450 has been one of the leading districts in the Rotary world in using Matching Grants to support microcredit in poor countries. Now we have the opportunity to assist the concept here in Colorado.

With the success of microcredit in developing countries it has become clear that many small businesses. either potential or existing, in developed countries could also benefit from small loans and business education. In Colorado this led to the formation of the Colorado Microfinance Alliance, a consortium of both domestic and international microfinance practitioners, donors, educators, students, and professionals. The Alliance is committed to raising the profile of microfinance in the Colorado region through a central organization that facilitates learning opportunities for the public, microfinance practitioners, and their clients. The Alliance brings one online location that offers information about the Alliances partner organizations, a central calendar of microfinance-related activities in Colorado, and collaborative tools designed for networking and practical use for those involved in local microfinance. Members of the Alliance operating in the metropolitan area include ACCION, the Colorado Enterprise Fund and the Rocky Mountain Microfinance Institute (RMFFI).

All of these organizations can use help from Rotary. RMFFI, for instance, needs both funds to loan and volunteers to help with business training of would be entrepreneurs.
