New Business

Nominating Committee Report:

PDG Mike Phillips reported that the Nominating committee selected Dawn Heath-Fiedler from the Rotary Club of Elkhorn as the 2026-2027 District 6270 District Governor. The committee also moved that PDG Craig Burnett, Rotary Club of Oshkosh Southwest as the district's member on the Zone Nominating Committee for RI Director, with PDG Mike Phillips, Rotary Club of West Bend Sunrise, to be the district's alternate member. Report was carried by vote for approval.

2024-2025 Proposed Budget:

DGE Pete Bosch spoke about the Finance Committee recommended and approved 2024-2025 District budget, section by section, covering Income and Expenses. He highlighted points – increase in member dues to \$10.00, for total of \$45.00 (lowest in zone). District to supplement the RYE costs. Continued explaining the budget with line decreases and increases. See worksheet in documents.

Amendments to the budget – Peter Bosch moved and Liz Nevitt seconded the motion to add a line to the budget in the amount of \$500.00 for District member to participate in the Zone RI Director Nominating Committee process. Motion carried.

Another amendment—Liz Nevitt moved Peter Bosch seconded the motion to add a line in the budget for the district's delegate to participate in COL training in the amount of \$1130.00. Motion carried. Finance committee recommendation to send budget with amendments to the District Annual Meeting. Vote carried the motion and amendments.
